### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Cadence Petroleum Group Employees' Supplemental Retirement 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### NOTE 1 - DESCRIPTION OF PLAN

The following description of Cadence Petroleum Group Employees' Supplemental Retirement 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **Plan Merger**

Effective March 1, 2024, the Plan was amended and restated to merge in the retirement plan assets sponsored by Yoder Oil Company, Inc. Savings Plan (Yoder Oil Company, Inc.), and to allow Yoder Oil Company, Inc.'s employees to participate in the Plan. Additionally, effective April 1, 2024, the Plan was amended and restated to merge in the retirement plan assets sponsored by Hoosier Penn 401(k) Plan (Hoosier Penn Oil Company, Inc.), and to allow Hoosier Penn Oil Company, Inc.'s employees to participate in the Plan. No other changes were made to the Plan.

#### **General**

The Plan is a defined contribution plan covering all eligible classes of employees of Pugh Lubricants LLC (the "Company") who have 6 months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan administrator.

#### **Contributions**

Each year participants may contribute a portion of their annual pre-tax compensation, as defined in the Plan. Participants may also make qualified Roth contributions to the Plan and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various money market and mutual fund as investment options for participants.

The Company makes fixed safe harbor contributions equal to 100% of the first 3% of employee contributions and 50% of the next 3% of employee contributions (not to exceed 6%), annually. Contributions are subject to certain limitations as determined by the Internal Revenue Code. The Company may make discretionary profit sharing contributions. There were no profit sharing contributions made during the Plan year ended December 31, 2024. Contributions are subject to certain limitations as determined by the Internal Revenue Code.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 - DESCRIPTION OF PLAN (Continued)

##### **Vesting**

Participants are vested immediately in their contributions, including amounts rolled over from other qualified plans, and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts is based on years of continuous service equally over 5 years.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one outstanding loan at a time. The notes receivable are secured by the vested balance in the participant's account and bear interest at rates that are equal to 1% over prime per the participant loan program. Principal and interest is paid ratably through payroll deductions.

##### **Payment of Benefits**

The Plan permits withdrawals upon attainment of the age 59 1/2 or upon disability, retirement, death, or termination of service. Benefits are payable in lump-sum or partial payments.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$43,904 and \$8,177, respectively. These accounts may be used to reduce future Company contributions. During 2024, \$7,229 of forfeitures were used by the Company to reduce Company contributions.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan Management and the Plan's Investment Manager determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 4 for discussion of fair value measurements.

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. A loan becomes immediately due and payable upon a participant's termination of employment or death. Delinquent notes receivable from participants are reclassified as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments. Expenses relating to specific transactions, such as loan set up, loan maintenance and distribution fees, are paid directly by the participant and are included in administrative expenses.

**Subsequent Events**

The Company has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, which is the date the financial statements were issued.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Topic 820 - *Fair Value Measurement* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market & mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective investment funds:* Valued using the net asset value ("NAV"), provided by the administrator of the trust. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of investment accounts managed by T. Rowe Price Trust Company, a related party, and therefore, these transactions qualify as party-in-interest transactions. Certain Plan expenses are absorbed into the valuation of the investment option as an offset to Plan and participant earnings. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions.

#### NOTE 8 - TAX STATUS

The Plan is a prototype plan sponsored by DST Retirement Solutions, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - NONEXEMPT TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Company inadvertently failed to remit \$310,751 of participant contributions and loan payments within the required timeframe prescribed by DOL regulations. The Plan remitted participant contributions including lost earnings for \$174,167 of late contributions and filed Form 5330 to pay the applicable excise taxes in 2024. The lost earnings were made from the Company's assets and not from assets of the Plan. The Plan intends to remit lost earnings related to the remaining \$136,584 late contributions and file Form 5330 to pay the applicable excise taxes in 2025. The lost earnings will be made from the Company's assets and not from assets of the Plan. These are deemed prohibited transactions in accordance with ERISA and IRC.
