To the Participants and Investment Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kress Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kress Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan

The following description of the Kress Corporation (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan is a defined contribution plan that was established pursuant to a trust agreement effective January 1, 1991. The Plan's most recent restatement was effective September 15, 2024.

Eligibility

An employee is eligible to participate in the salary reduction arrangement and matching contributions as of the first day of the month immediately following the completion of 3 continuous months of service. In order to receive a matching contribution, the participant must complete 1,000 hours of service and be employed on the last day of the plan year.

Employer Contributions

The Company may contribute a discretionary matching contribution to eligible participants. For the years ended December 31, 2024 and 2023, the Company elected to make a match equal to 100% of the salary reduction contributions not to exceed four percent (4%) of the participants' compensation. The amount of the employer matching contribution equaled \$278,189 and \$291,873 for the years ended December 31, 2024 and 2023, respectively.

Employee Contributions

An eligible employee may elect to contribute up to 75% of the employee's before-tax earnings, not to exceed \$23,000 and \$22,500 in 2024 and 2023, respectively. Catch-up contributions are also allowed under the Plan for participants who attain age 50 during the plan year. The maximum catch-up contribution is \$7,500 and \$7,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other eligible retirement plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary match contribution, and (b) Plan earnings less expenses. Allocations are based on participant compensation paid during the Plan year for the Company's discretionary match contribution and account balances for Plan earnings. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Contributions from participants are 100% vested at all times. Participants are 100% vested in the Company's matching contribution after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan proceeds are withdrawn only from salary reduction contributions. Loans are secured by the balance in the participant's account. The loan interest rate is set at prime rate plus 1% at the time the loan is made. Principal and interest is paid ratably through payroll deductions.

1. **Description of Plan (Continued)**

Payment of Benefits

Upon termination of service, retirement, disability or death, a participant with a vested account balance not exceeding \$5,000 will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

Upon termination of service, a participant with a vested account balance that exceeds \$5,000 may elect distribution under any one of the following methods:

- (a) Lump-sum
- (b) Partial withdrawals
- (c) Installment payments (annually, quarterly or monthly) over a specified period of time, not exceeding the participant's life expectancy or the joint life expectancy of the participant and his or her designated beneficiary

Forfeited Accounts

For years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,493 and \$11,278, respectively. These accounts will be used first to pay administrative expenses of the Plan and then to reduce the employer match. Forfeitures totaling \$24,492 and \$7,000 were used to pay Plan expenses during the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, the Company did not use any forfeitures to reduce the employer match. At December 31, 2024 and 2023, the balance of the forfeiture account was \$13,038 and \$34,091, respectively.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (Continued)

Expenses

Expenses associated with plan administration are paid either by the Plan or the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan for the period of January 1, 2023 to September 16, 2024, and Principal Trust Company, the trustee of the Plan for the period September 16, 2024 to December 31, 2024. This information has not been audited by the Plan's independent auditors. The certified information at December 31, 2024 and 2023 and for the years then ended includes:

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Guaranteed Interest Contracts

The Plan held a traditional investment contract. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The value of the traditional investment contract at December 31, 2023 was \$118,670. The contract was sold during 2024.

6. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are investments managed by the trustees as defined by the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to the third party administrator of \$65,603 and \$51,939 for the years ended December 31, 2024 and 2023, respectively.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan is operating under a non-standardized pre-approved plan of Principal Life Insurance Company. The pre-approved plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
