NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of Section 403(b) Retirement Plan for Farnham, Inc. (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to eligible employees of Farnham, Inc. (the Organization) who meet certain eligibility requirements. The Plan is administered by the Board of Directors. VOYA Retirement Insurance and Annuity Company (VOYA) and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) are the custodians of the Plan's assets. Rimkus, Marciano & Associates, Inc. (RMA) is the third party administrator of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees of the Organization are eligible to immediately begin salary deferrals upon hire. Employees are eligible for the Organization's discretionary contribution upon completing six months of eligible service.

Contributions

Active participants may make voluntary contributions in the form of salary reductions, subject to certain limitations of the Plan and the Internal Revenue Code (the Code) under Section 403(b). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Code. Participants are also permitted to make after-tax roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employees are eligible to receive the Organization's contributions on the first pay period following the completion of six months of eligible service. The Organization contributes a 4% discretionary contribution for eligible wages in 2024 and 2023. Additionally, the Organization may make an additional discretionary contribution based on financial results of the Organization during the year. There were no additional discretionary contributions in 2024. The Organization made an additional discretionary contribution to the Plan of approximately \$76,000 in 2023.

Participant Accounts

Participants direct the investment of their accounts among the investment options in the Plan. Participant accounts are credited with the participant contributions, the Organization's contributions, actual earnings/losses thereon, and charged with an allocation of administrative plan expenses. Allocations of earnings/losses and administrative expenses are based on account balances according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings/losses thereon. Employees who sever employment before becoming 100% vested in the account balance will forfeit the portion of their account that is not vested. Employer discretionary contributions vest according to the following schedule:

Notes Receivable from Participants

Plan participants may borrow up to the lesser of \$50,000 or 50% of the amount of the participant's vested interest in the Plan. The minimum loan is \$1,000. Notes are repayable over not more than five years, except in the case of a note for the purchase of a primary residence. Participants must make note payments directly to the custodian. Notes receivable from participants are secured by their account balances and bear interest at rates ranging from 9.25% to 9.50%. Total notes receivable from participants outstanding at December 31, 2024 and 2023 were \$100,243 and \$52,821, respectively.

Payment of Benefits

Participants are eligible for retirement benefits upon reaching age 65. Upon termination of service due to death, disability, retirement, or other means of termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or rolled over to an individual retirement Plan. In-service distributions are not permitted.

Participants with account balances under \$1,000 have a mandatory distribution upon severance from employment.

Forfeitures

Forfeitures are used to reduce employer discretionary contributions or pay plan administration costs. The total forfeited non-vested balances at December 31, 2024 and 2023 were \$133,697 and \$74,469, respectively. No forfeitures were used during the years ended December 31, 2024 or 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts which are recorded at cost. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan has investment contracts with VOYA that maintains participant contributions in a general account. These accounts are credited with actual earnings on the underlying investments and are charged with certain administrative expenses of the Plan. Since the agreement or funding agency has the ability to restrict certain transfers and withdrawals, the contract is not considered fully benefit responsive.

Fair Value Measurement

Accounting Standards Codification (ASC) Section 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment. There are no level 1 assets.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The following is a description of the valuation methodology used for assets measured at fair value:

Registered investment companies: Valued at the net asset value of shares held at year end based on quoted prices in active markets.

Fixed annuity contract: Value is calculated based on discounted cash flows using risk-adjusted discount rates.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation techniques during 2024 or 2023.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Contributions Receivable and Allowance for Credit Losses

The Plan records a receivable for employer contributions that are remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant deteriorations are expected in the future economic conditions; therefore, management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. There were no delinquent notes receivable from participants at December 31, 2024 or 2023.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

Expenses incurred in connection with the purchase or sale of securities are charged against the investment funds whose assets are involved in such transactions. Certain administrative costs of the Plan are paid by the Organization. All other expenses relating to participant transactions are deducted from those participant accounts as transactions occur.

5. GUARANTEED INTEREST ACCOUNT

The Plan invested in a guaranteed interest account through Principal Fixed Income Guaranteed Option (PFIGO). PFIGO is a fully benefit-responsive group annuity contract issued by Principal. PFIGO contracts were reported at contract value, which was the aggregation of contributions, plus interest, less withdrawals, if any. The crediting interest rate is based on a formula agreed upon with Principal. Under the terms of the contract, the crediting rate is reset on a semiannual basis.

PFIGO is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. By definition, PFIGO is an insurance contract. As a result, the Plan is able to transact according to the terms defined in the contract at any time.

5. GUARANTEED INTEREST ACCOUNT (Continued)

PFIGO offers Plan participants stability of principal and a declared interest rate. This contract guarantees principal and provides a stated rate of return backed by the General Account of Principal. The general account consists of more than 7,000 investments, which include corporate bonds, Treasuries, commercial real estate mortgages, mortgage-backed securities, and short-term cash equivalents. There are no redemption restrictions or unfunded commitments related to this investment.

6. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed by letter for the Volume Submitter 403(b) Plan adopted by the Plan, dated March 31, 2017, that the Volume Submitter 403(b) Plan is designed in accordance with applicable sections of the internal Revenue Code (IRC). The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

Transactions with VOYA, Principal, RMA, the Organization, and the Plan are party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.
