Independent Auditor's Report

To the Trustee
HME, Inc. 401(K) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of HME, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HME, Inc. 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. PLAN DESCRIPTION

The following description of the HME, Inc. 401(K) Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution plan sponsored by HME, Inc., CycleZone, LLC, Peak to Peak Engineered Railings, LLC, and Topeka Foundry and Iron Works (collectively the Company) for the benefit of its full-time employees. Employees are eligible to join the Plan once they have attained 19 years of age and completed 455 hours of service within 3 consecutive months from the employee's employment commencement date. If the hours are not completed in the allotted time, then the employee is subject to a 1 year of service requirement. The Plan excludes nonresident aliens, leased employees and part-time/temporary/seasonal employees with hours of less than 455 in the relevant eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees for the Plan is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Participants can make pre-tax deferral contributions and/or post-tax Roth elective deferral contributions to the Plan. Matching contributions are calculated based on elective deferral contributions and participant's eligible compensation for the Plan year. The Company elected to make a 100% matching contribution for any deferral amount up to 3% of eligible compensation per payroll. Catch-up contributions are allowed for participants aged 50 or older. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Vesting

Participant contributions plus actual earnings are 100% vested immediately. Vesting in a participant's employer contribution account is based on the years of continuous service. A participant becomes fully vested regardless of the years of service, upon attainment of normal retirement age, early retirement age, upon retirement due to disability, upon death, or upon termination of the Plan. Employer contributions are subject to the following vesting schedule:

Years of Service	Vested %
1	25%
2	50%
3	100%

Payment of benefits

Upon termination of employment, a participant with an account balance of less than \$5,000 will receive a lump-sum amount equal to the value of the participant's account. A participant with an account balance greater than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's account or a direct rollover distribution. Partial withdrawals or installments are only permitted for required minimum distributions.

Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balance in a single lump sum payment.

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to participants, as defined by the Plan Adoption agreement and permitted by the Internal Revenue Code. Hardship withdrawals are limited to the participant's salary reduction account.

Participant investment account options

Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the employer's matching contribution, if any (b) investment earnings (losses) on their individual account balances, and (c) allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the balance in the participant's account and bear interest rates 1% above the prime rate. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded.

Forfeitures

Forfeitures attributable to matching contributions will be used to pay administrative expenses or reduce any non-elective contribution or matching contributions. As of December 31, 2024 and 2023, the forfeiture account balance was \$0 and \$2,305, respectively. For the plan years ended December 31, 2024 and 2023, there were \$18,349 and \$18,742 forfeitures used to reduce employer contributions, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodia. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses

The Plan permits the payment of plan expenses from the Plan's assets. For the plan years ended December 31, 2024 and 2023, plan expenses were paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in administrative expenses.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations and participants would become 100% vested in their employer contributions.

4. TAX STATUS

ERP Retirement Services is the Plan's third-party administrator. The plan adopted the Compensation Benefit Planning, Inc. non-standardized 401(k) profit sharing plan, as a restatement of the prior plan. The prototype plan was approved by the Internal Revenue Service (IRS) on June 30, 2020.

The Plan's administrator and third-party administrator believe the Plan is designed and being operated in compliance with the applicable requirements of the IRC. They believe that the Plan was qualified and the related trust was tax exempt, and no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. INVESTMENT INFORMATION CERTIFIED BY THE TRUSTEE

John Hancock Life Insurance Company is the trustee of the Plan's assets for the years ended December 31, 2024 and 2023.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the years then ended, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company.

6. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value provided by John Hancock Life Insurance Company:

Pooled separate accounts: Valued at market value less operating expenses accrued and not deducted. All pooled separate accounts are valued daily and the Plan’s separate account market value at any given date is equal to the Plan’s units of participation multiplied by the unit Value which is Net Asset Value (“NAV”). There are no restrictions or redemptions, and there are no unfunded commitments.

- (a) This investment category seeks to provide high total return over the long term. This portfolio is for investors who want long term growth of capital and can accept the levels of risk that typically accompany investments in stocks of all sizes and bonds of varying credit quality, who want a portfolio that takes a top-down view, assessing the global economic environment to determine asset allocation and security selection, and who want a portfolio that can change substantially over time as economic conditions and opportunities within the market sectors dictate.
- (b) This investment category seeks to produce income and provide an opportunity for growth of principal consistent with sound common stock investing, seeks to track the performance of the CRSP U.S. Mid Cap Growth Index that measures the investment return of mid-capitalization growth stocks, seek long-term capital appreciation and current income, seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index, and seeks to track the performance of a benchmark index that measures the investment return of small-capitalization value stocks.
- (c) This investment category seeks high levels of current income, maximum real return, and preservation of capital, consistent with prudent investment risk/management. This portfolio is for investors who want a portfolio of securities that offers a steady stream of investment income and some protection against stock market volatility or want to invest primarily in benefit responsive contracts issued by state regulated insurance companies and banks or want the potential for a higher return compared to investment grade bonds and can accept the higher levels of relative volatility.

- (d) This investment category seeks current income with capital appreciation and growth of income or total return with an emphasis on high current income, but also considering capital appreciation. This portfolio is for investors who want a portfolio of securities with the potential to offer a steady stream of income and some protection against stock market volatility but can accept the inherent risks of investing in below-investment-grade fixed-income securities issued by foreign countries including emerging market countries or the inherent risks of investing in foreign securities, who want to diversify the fixed-income portion of their portfolio by adding debt issues from a range of countries and companies worldwide, including emerging markets or who want a high quality investment portfolio aimed to maximize total returns by investing in a portfolio of sovereign and government debt and currencies from developed and emerging markets.
- (e) This investment category seeks capital appreciation to achieve long-term growth. This portfolio is for investors who want long-term growth of capital and can accept the inherent risks of investing in stocks, including small and medium sized company stocks, stocks of international economies, and global stocks.
- (f) This investment category seeks long-term growth of capital, long-term capital appreciation, and current income. This portfolio is for investors who want long-term growth of capital and can accept the relatively high levels of risk and volatility inherent in concentrating investments in one sector of the market and who want exposure to an asset class with low correlation to most major equity and fixed-income market indices and exposure to a wide range of industries within the technology, energy, and broad utilities sectors.
- (g) This investment category seeks to provide a high total return through its target date retirement date, within a greater focus on income as the target date approaches by the fund primarily investing its assets in passively managed funds using an allocation strategy designed for investors expected to retire around the years 2025-2065. This portfolio adjusts over time to ensure a noticeable and steady shift from equities to fixed income in the years leading to retirement. This portfolio lowers exposure to equities, aims to reduce volatility and preserve assets in the years closest to retirement. The most conservative point-8% equity and 92% fixed income-occurs at the retirement date.
- (h) This investment category seeks to achieve different balances of a high level of current income and capital growth by investing varying portions of the portfolio's assets in underlying portfolios that invest primarily in fixed-income securities and varying portions of its assets in portfolios that invest primarily in equity securities. This portfolio is designed for the investors to have a short, medium, or long-term investment horizon and seek different levels of high current income and potential growth of capital accept varying levels of risk, and also for investors who want instant and broad diversification with exposure to a wide range of asset classes and investment styles, including domestic and international stocks.

7. PARTIES IN INTEREST AND RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by John Hancock. John Hancock is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Legal and accounting fees are paid directly by the Company.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SECURE ACT 2.0

On December 23, 2023, Congress passed the Consolidated Appropriations Act of 2024 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. The most significant changes impact existing plan provisions included updates to required minimum distributions, hardship distributions rules, expanded eligibility of part-time employees, and modifications to catchup contribution rules. SECURE Act 2.0 amendments must be adopted by December 31, 2026 for calendar year plans. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

10. SUBSEQUENT EVENTS

Events occurring after December 31, 2024, have been evaluated through October 15, 2025 for possible adjustments of the most recent financial statements and disclosures. October 15, 2025 is the date the financial statements were available to be issued.
