Opinion

We have audited the financial statements of UFCW Comprehensive Benefit Trust, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of UFCW Comprehensive Benefit Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1 - Description of the Plan

The following brief description of the UFCW Comprehensive Benefits Trust (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

General

The Plan, a multiemployer health and welfare plan, was established on December 21, 2017, for the purpose of providing health care benefits to eligible participants covered under collective bargaining agreements between the United Food and Commercial Workers Union Locals and employer associations and individual employers' signatory to the agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board consisting of equal representation from the participating employers and the United Food and Commercial Workers Union.

Benefits

The Plan provides health and welfare benefits including medical, dental, vision, prescription drug, sick leave, podiatry, physical exam, employee assistance program and extended death for participants. All vision, prescription drug, sick leave, employee assistance program, podiatry, physical exam and certain medical and dental claims are self-funded by the Plan. All life and certain medical and dental benefits are insured with premiums paid by the Plan.

The Plan management has entered into a stop-loss insurance arrangement in an effort to limit the Plan's exposure for self-funded medical and prescription drug benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Under the terms of the contract, individual participant claims incurred in excess of \$350,000 in the aggregate on three claimants, are reimbursed to the Plan.

The Plan management has entered into a stop-loss insurance arrangement in an effort to limit the Plan's exposure for self-funded medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

The Plan uses a pharmacy benefits manager (PBM) which periodically makes refunds to the Plan based on the utilization pattern of specific drugs.

The Plan also offers a Health Reimbursement Arrangement (HRA) program. An HRA is an account that is automatically established for eligible participants who are also enrolled in a PPO plan, from which credits are used to offset the participant's portion of health care expenses not paid by the Plan. The Trust Fund Office administers the HRA and allocates credits to each eligible HRA account annually. Unlike a regular bank account, participants cannot make deposits into their HRA or withdraw funds from it. The accounts are credited an amount based on the Plan option that the participant is eligible for. Participants are not vested in the credits made on their behalf, and their available balance may be used only for certain health care expenses not otherwise covered under the Plan. Any unused amount each year may be accumulated in the participant's account for future periods if the participant maintains eligibility. The Plan is not permitted to refund any part of the balance to the participants and remaining amounts are forfeited to the Plan should the participant have a six-month break in service or enroll in an HMO. During the plan year ended December 31, 2024 and 2023, \$47,910 and \$96,425 were forfeited from the HRA accounts, respectively. In addition, the Plan established Health Risk Questionnaire (HRQ) funding for participants that complete a health risk questionnaire. Upon completion of this Questionnaire participants receive an additional credit of \$150.

Contributions and Eligibility

Participating employers are required to pay an hourly contribution to the Plan for each compensable hour of employment worked by covered employees. The principal hourly employer contribution rate in effect for the Plan is \$6.30 for both years ended December 31, 2024 and 2023.

Participants with dependents are required to pay a weekly premium in order to maintain coverage for enrolled dependents at \$20-\$60 for both years ended December 31, 2024 and 2023.

For initial eligibility, a participant must work at least four months of qualifying hours within a twelve-month period to become eligible for benefits. The first two months of qualifying hours must be met consecutively. The participant must then work qualifying hours in a third and fourth month; however, the third and fourth month does not have to be consecutive. Then, after a lag month, the participant's coverage begins on the first day of the following month. In other words, the participant's actual coverage under the Plan begins on the first day of the second month following the month in which he or she meets the initial eligibility requirement.

Under certain conditions, participants are permitted to maintain Plan coverage by making self-payments. Continuation of health care benefits to persons who could otherwise lose those benefits due to certain events, as mandated by the COBRA, has been adopted by the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Employer Contributions, Contributions Receivable, and Allowance for Credit Losses

The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a rate per hour for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. Management of the Plan evaluates participating employers' contributions receivable periodically for potential credit losses based on historical experience as well as current and reasonable and supportable forecasted economic conditions. As of December 31, 2024 and 2023 there was no allowance taken.

The Plan has an employer payroll audit system in place in which the employers are randomly audited to verify that they are contributing in accordance with their signed agreement. Delinquencies may arise due to these payroll audits, but due to the uncertainty of collections, no estimates of the contributions will be accrued.

Payment of Benefits

Claims and premiums are recorded when paid. Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims' processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statements of changes in the net assets available for benefits may differ from the classification of earnings on the Form 5500 due to different reporting requirements on the Form 5500.

Stop Loss

Premiums for stop loss insurance are included in premiums paid in the accompanying statements of changes in net assets available for benefits. Stop loss refunds received for December 31, 2024 and 2023 claims totaling \$508,386 and \$1,689,262, respectively, are netted against claims paid in the accompanying statements of changes in net assets available for benefits. As of December 31, 2024 and 2023 stop loss reimbursements receivable were \$374,539 and \$187,524, respectively.

Rebates

Prescription refunds from the Plan's PBM are recorded when earned. Pharmacy rebates for the years ended December 31, 2024 and 2023 totaling \$319,851 and \$0, respectively, are netted against claims paid in the accompanying statements of changes in net assets available for benefits.

Health Reimbursement Arrangement

At December 31, 2024 and 2023, HRA accounts totaled \$1,565,713 and \$1,433,713, respectively, and are included in the Plan's net assets available for benefits. There were no amounts approved for payments from HRA accounts but not yet paid as of either December 31, 2024 and 2023.

No separate designation of Plan assets has been made for the HRA; therefore, the financial statements do not separately identify these assets from general Plan assets.

Expenses

Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with a related plan. In computing these allocated costs, various factors were considered, including time spent, costs incurred, and volume of transitions relating to the Plan in relation to the other plans.

Current Benefit Obligations

As a result of the eligibility provisions of the Plan, hours worked by participants through December 31, 2024 and 2023, produced eligibility through February 2025 and 2024, respectively. Accordingly, group insurance premiums and claims incurred are accrued on the basis of hours worked through December 31, 2024 and 2023, and eligibility through February 2025 and 2024, respectively. These amounts are recorded as amounts currently payable on the statements of benefit obligations.

The liabilities for future payment of claims incurred but not reported at December 31, 2024 and 2023, have been estimated using actual claims data paid subsequent to year end for all claims incurred through the eligibility period and has been included in the amounts currently payable on the statements of benefit obligations.

As a result of the eligibility provisions of the Plan, participants with the maximum of 360 hours in accumulated sick leave as of December 31 are eligible for a payout in the subsequent year. Accordingly, the amounts accrued are based on participants sick leave balance at December 31, 2024 and 2023, which earns eligibility for pay outs in 2025 and 2024, respectively. These amounts are recorded as amounts currently payable on the statements of benefit obligations.

Concentration of Credit Risk

The Plan maintains its cash in bank deposit accounts which exceed federally insured limits. Accounts are guaranteed by the by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan had approximately \$6,598,000 and \$5,847,000, respectively, in excess of FDIC-insured limits.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no changes in the methodology used at December 31, 2024 and 2023.

Money market mutual fund – valued at the daily closing price as reported by the fund. The money market mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The money market mutual fund is deemed to be actively traded.

Note 4 - Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated October 7, 2019, stating that the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the related trust is tax-exempt. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Related Party and Party-in-Interest Transactions

The Plan has an administrative services agreement with the UFCW – Employers Benefit Plans of Northern California Group Administration, LLC (LLC). The Plan and LLC are related parties since they share similar members within their respective Board of Trustees. The Plan pays the LLC for its share of indirect administrative costs pursuant to the terms of the Administrative Services Agreement and in accordance with an allocation methodology approved by the Trustee. In addition, certain administrative costs can be attributable to only one of the Plans administered by the LLC and those direct costs are reimbursed to the LLC by the applicable Plan. The Plan’s share of administrative expenses for the years ended December 31, 2024 and 2023, was \$939,629 and \$827,943, respectively. As a result of these transactions at December 31, 2024 and 2023, \$142,667 and \$303,395 was due to the LLC, respectively.

The LLC holds the lockbox account that receives contributions and liquidated damages on behalf of the related plans. These contributions are allocated based on each plan’s contribution rate and are transferred monthly.

The local unions, which are a party to the collective bargaining agreement, provide information and administrative assistance to the participants of this Plan. Pursuant to agreements with the LLC, the local unions are reimbursed for cost of services performed which is based on an approved allocation methodology. For the years ended December 31, 2024 and 2023 reimbursements totaled \$40,961 and \$32,134, respectively.

For the years ended December 31, 2024 and 2023, \$1,193,398 and \$1,894,118, was transferred to the UCBT Retiree Health Plan for actual expenses incurred from the UFCW Comprehensive Benefit Trust. Additionally, during the year ended December 31, 2024, a true-up of expenses based on reimbursements received by UCBT Retiree Health Plan was made resulting in a refund from UCBT Retiree Health Plan to the Plan in the amount of \$2,161,711. At December 31, 2024 and 2023, \$27,997 and \$1,818,365 was due to the UCBT Retiree Health Plan, respectively.

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Claims and premiums that have been processed and approved for payment at year-end, but not paid, claims incurred but not reported and sick leave payouts earned at year end but not paid, are not considered liabilities under GAAP and, therefore, are not presented as liabilities in the accompanying financial statements but are recorded on the Form 5500 as a liability.

Note 7 - Priorities Upon Plan Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, in the event the Plan terminates, the Trustees, after accounting for any and all funds and property remaining in the trust estate, and after the payment of or adequate provision for the payment of all liabilities relating to or affecting this Plan, shall use the balance of the funds remaining on hand in the trust estate for the purpose of continuing the Plan for the benefit of all eligible employees, their dependents and associate members at the time of the termination of this Plan or the collective bargaining agreement above referred to, until said funds shall have been exhausted.

Note 8 - Risks and Uncertainties

The benefit obligation for claims incurred but not reported was calculated using claims data through a point in time as a basis for the estimate. Due to uncertainties inherent in the estimations process, it is at least reasonably possible that changes in these estimates in the near-term would-be material to the financial statements.
