Basis for Opinion

Note 1 – Description of the Plan

The following brief description of Fitzmark, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan instrument for complete information.

General

The Plan is a defined contribution plan established August 1, 2008 for the benefit of the employees of Fitzmark, LLC, Logistics Made Simple, Inc., Fetch Logistics, Inc., and Manning's Truck Brokerage; collectively the Companies. Full-time employees of the Companies are eligible to participate upon reaching 21 years of age and completing three months of service. Part-time employees are eligible to enroll in the Plan once they reach three consecutive years of service with at least 500 hours in each year. Union employees and non-resident aliens are excluded from participating. Employees who do not return a waiver are auto-enrolled at a 1% pretax deferral rate on the first day of the month following meeting the eligibility requirements outlined above. The Plan also has an auto-escalation of 1% annually up to a maximum of 6%.

Contributions

Each year, participants may make pretax or after tax contributions up to a maximum amount of their annual compensation as defined by the Internal Revenue Service (IRS) and recorded in the plan document. Participants who have reached age 50 before the end of the Plan year may make additional catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified plans. The Companies make discretionary matching contributions of 50% of participant elective deferrals up to 6% of eligible compensation. The Companies may also choose to make a discretionary profit sharing contribution each year in addition to the matching contributions. No discretionary profit sharing contributions were made during the year ended December 31, 2024. Employees who are terminated prior to year-end are not eligible to share in the allocation of the discretionary match or profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' matching and profit sharing contributions, if any, allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant account balances or earnings, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings or losses thereon. Vesting in the Companies' matching contribution portion of their accounts, plus actual earnings or losses thereon, is calculated based on years of continuous service; a participant is 100% vested after 4 years of service. Vesting in the Companies' profit sharing contribution portion of their accounts, plus actual earnings or losses thereon, is calculated based on a 2 to 6 years schedule of years of continuous service. Participants also become fully vested in the event of death, disability, retirement, or Plan termination.

Forfeited Accounts

Forfeitures may be used to reduce the Companies' matching contributions or to pay Plan expenses. As of December 31, 2024 and 2023 forfeited non-vested accounts totaled \$21,525 and \$10,722, respectively. Forfeitures were not used to reduce employer matching contributions during the year ended December 31, 2024.

Investment Options

Upon enrollment in the Plan, participants are able to invest in a variety of investment choices as more fully described in the plan document. Participants may change their investment options at any time during the year.

Notes Receivable from Participants

A participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested balance or \$50,000. Loans are secured by the participant's account balance and must be repaid over 1 to 30 years depending on the purpose of the loan. A participant may only have one loan outstanding at a time, and interest is charged on these loans at a rate equal to the prime rate plus 1%. The interest rate on all current outstanding loans ranges from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, a participant (or beneficiary) may receive benefits based on the participant's vested account balance. Benefits may only be paid in a lump sum or installments, and participant consent is required for all distributions over \$5,000. Hardship distributions are also permitted by the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), which requires management to make estimates and assumptions affecting certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the collective trust, which is reported at contract value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Note receivable from participants are reported at their unpaid principal balance. Delinquent notes receivable are reclassified based on the terms of the Plan document.

Excess contributions

Excess contributions are recorded after a Plan fails compliance testing. Compliance testing failure occurs when participants contribute more than the Plan limit. These funds are then due back to the participant to allow the Plan to be in compliance.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses paid by the Companies are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated by management October 8, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair measurement level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by each fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission (SEC). The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Note 4 – Collective Trust Fund

The Invesco Stable Asset Fund (the Fund) is a bank collective trust fund for which Investment Trust Company serves as trustee and investment manager. It is available exclusively to qualified retirement plans. The Fund is not FDIC insured nor is it registered with the SEC. The primary investment objective of the Fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The Fund's return is based on returns generated by an actively managed, highly diversified portfolio of investment grade, fixed and floating rate securities. The Fund may invest in such securities directly or indirectly through commingled investment vehicles (the building block strategy). This building block strategy may provide greater diversification than could be achieved by investing in individual bonds. The building block strategy also may reduce the unintended impact on portfolio characteristics created by participant cash flow. The Fund is fully benefit responsive, and as such, are reported at contract value based on the value of the underlying investments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents, including complete or partial plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events, such as divestures or spin-offs of a subsidiary, (4) the failure of the trust to qualify for the exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and also would limit the ability of the Plan to transact at contract value with participants.

Note 5 – Tax Status

The Internal Revenue Service (IRS) determined the prototype plan used by the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC), as indicated in a letter dated October 6, 2020. The Plan was most recently restated as of January 1, 2023. The Companies believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position which more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 – Certified Information

At December 31, 2024 and 2023, the Plan's investments were maintained by Reliance Trust Company (the trustee and custodian). The trustee and custodian supplied the plan administrator with a certification as to the completeness and accuracy of all information relating to investments as of December 31, 2024 and 2023, and income and expenses on such investments for the year ended December 31, 2024. The certified information includes total net assets available for benefits of \$16,627,793 and \$12,630,461 at December 31, 2024 and 2023, respectively, which diverges from the statements of net assets available for benefits by the values of the employee receivables, employer receivables, and employer QNEC receivables. The certified information also includes the activity reported on the statement of changes in net assets available for benefits for the year ended December 31, 2024, except for the impact of the receivables on contribution income.

Note 8 – Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds certain investment funds managed by the plan trustee and custodian. Such investments and the Plan's payment of fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Some professional fees for the administration and audit of the Plan are paid directly by the Companies.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to numerous risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Qualified Non-Elective Contributions (QNEC)

Prior to the year ended December 31, 2024, the Plan recorded a QNEC receivable pertaining to an ongoing issue regarding automatic enrollment during the period January 1, 2016 through August 1, 2021. The Plan engaged legal counsel to assist in resolving this matter with the IRS. During the year ended December 31, 2024, the Plan received notices from the IRS and advice from legal counsel indicating the matter is substantially resolved, and the QNEC receivable is not due to the Plan. Accordingly, the QNEC receivable was reversed as presented on the statement of changes in net assets available for benefits as QNEC receivable reversal expense.
