## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the HAC, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the HAC Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan established September 7, 2002. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Charles Schwab Bank is the Plan’s trustee, and The Standard Life Insurance Company is the Plan’s recordkeeper.

**Eligibility** – Nonunion employees, union employees of Georgia, and nonleased employees of HAC, Inc. (the “Company”) may enter the Plan on the first day of any calendar quarter after working 90 days and attaining the age of 21.

**Contributions** – Participants may designate a portion or all of their contributions as Roth or 401(k) deferrals, up to any amount, subject to certain Internal Revenue Code (“IRC” or “Code”) limitations. Participants may also begin making catch-up contributions beginning in the year the participant reaches the age of 50.

The Plan has an automatic enrollment feature. Any participant who is eligible to participate in the Plan will automatically be enrolled in the Plan and will make deferral contributions of 2%. Any participant who was automatically enrolled in the Plan, and never changed deferral rates, will automatically have his or her deferral increased by 1% during January of each year, until his or her deferral is 8%. A participant must affirmatively opt out of the automatic enrollment or automatic deferral increase for it not to occur.

The Company may make a discretionary profit-sharing contribution or discretionary matching contribution. These contributions are determined annually by the President of the Company based on the Company’s performance for the year. In order to receive any type of discretionary Company contribution, the employee must be employed on the last day of the Plan year and have worked 1,000 hours during the year. No employer contribution was made for 2024.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution, Company contributions (if any) and Plan earnings or losses, based on the underlying investments in the participant’s accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – Participants of the Plan direct their contributions to various mutual funds or a guaranteed investment contract.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service, or upon death or permanent disability.

**Forfeitures** – Forfeited balances of terminated participants’ nonvested accounts are used to restore any forfeitures required to be restored, and then to offset employer contributions to the Plan or pay permitted Plan expenses. There was \$11,638 and \$5,388, respectively, available in forfeitures at December 31, 2024 and 2023. Forfeitures in the amount of \$500 were used to pay Plan expenses in 2024.

**Payment of Benefits** – Upon termination of employment, the participant, or in the case of death, the participant’s beneficiary, may elect to receive the participant’s account balance in a single lump sum in accordance with the Plan document, or maintain the assets in the Plan until a later date, subject to certain IRC regulations.

**In-Service Withdrawals** – Hardship withdrawals are available to the plan participants for reasons as defined in the Plan Document. Distributions can be taken from participant deferrals, and from rollover account balances only. A participant who has reached the age of 60 may also take an in-service distribution, and the distributions may come from all account sources.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of the participant’s vested account balance. The minimum that may be borrowed is \$1,000, and the maximum term is 5 years. Loans used to purchase a primary residence may have a term longer than 5 years. Loans to participants bear interest equal to the prevailing interest rate charged on similar loans. A participant’s account will be charged \$100 upon initiating a loan on-line, or \$125 for initiating a loan submitting a paper form.

**Administrative Expenses** – The majority of administrative expenses of the Plan for the year ended December 31, 2024 were paid by the Plan, in the amount of \$144,608.

**Transfers Into the Plan** – During the 2024 Plan year, balances of \$149,970 were transferred into this Plan from another qualified plan administered by the Plan Sponsor, the HAC, Inc. ESOP (“ESOP”).

Effective January 1, 2021, the Plan allows for incoming transfers from the ESOP for certain union employees. These transfers do not permit these individuals to be participants in this Plan for any reason other than establishing the “Transfer Account” and receiving distributions from the Transfer Account in accordance with the distribution provisions stated in the Plan’s adoption agreement. The participants who transfer money into this Plan may take a participant loan from the Transfer Account.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all participants become 100% vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan’s investments are stated at fair value, except for the guaranteed investment contract, which is valued at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Risks and Uncertainties** – The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the financial statements.

**Date of Management’s Review** – Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued, and there were no significant events requiring additional recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the published net asset value (“NAV”) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. #### **4. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive investment contract with The Standard Insurance Company (“Standard”). Standard maintains the contributions in a general account, which is credited with earnings or losses on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value and then adjusted to contract value as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, partial or total Plan termination, certain retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Standard may terminate the contract at an amount less than contract value with 30 days advance written notice to the Plan for reasonable cause, which includes the Plan’s failure to abide by state or federal law, failure to perform under the terms of the contract or Plan disqualification.

Standard is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is declared each quarter. The crediting rate of the contract will track current market yields on a trailing basis. Under the existing contract, the average yield based on actual earnings and interest credited to participant accounts yielded 1.95% and 2.78%, for the years ended December 31, 2024 and 2023, respectively.

## **5. INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Bank, trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Investment, at contract value
- Net appreciation in fair value of investments
- Interest and dividend income

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **6. TAX STATUS**

The Company adopted a Prototype Non-standardized Pre-Approved Profit-Sharing Plan/Money Purchase/CODA which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

A Plan investment is the Standard Stable Asset Guaranteed Fund, which is managed by Standard. Standard is the recordkeeper for the Plan, and therefore, these transactions qualified as party-in-interest. Certain administrative fees are paid to Standard, which are party-in-interest. Notes receivable from participants are party-in-interest.
