We have performed audits of the financial statements of BBJ Linen 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1. Description of the Plan

The following description of BBJ Linen 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of BBJ Rentals, Inc. (the Company) who are not covered by a collective bargaining agreement, who have completed 90 days of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the BBJ Linen 401(k) Plan Committee (the Committee) that serves at the discretion of the Company's Board of Directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents and directing the Plan's trustee.

Participant contributions: Each year, participants generally may contribute a minimum of 1% up to 90% of their pretax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Employer contributions: The Plan sponsor provides discretionary Company matching contributions based on the amount of compensation that a participant contributes to the Plan. For the years ended December 31, 2024 and 2023, the Company matched 25% up to 4% of eligible compensation that a participant contributed to the Plan. Employer contributions totaled \$92,145 for the year ended December 31, 2024. Effective January 1, 2025, the Plan was amended to adjust the Company matching contribution to a safe harbor matching contribution. The safe harbor matching contribution is 100% of the first 3% of a participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participants compensation (the maximum match is 4% of the participant's compensation).

The Company may also make annual discretionary profit-sharing contributions. These contributions, if made, are allocated according to the ratio of each participant's eligible compensation to the total eligible compensation paid to all participants for the plan year. Participants who were terminated during the plan year must have worked a minimum of 500 hours during the plan year in order to receive an allocation of any such discretionary Company profit-sharing contributions unless terminated due to death, disability, after normal retirement age or after early retirement age, as defined in the Plan document. No discretionary profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

Rollovers: The Plan accepts rollovers from a qualified retirement plan of a prior employer with approval from the Company.

Participants' accounts: Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings, account balances and other factors, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs, both separately and distinctly, into which investment the participant contribution and Company contribution is to be invested.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. Participants vest in Company contributions 50% after two years of service and 100% after three years of service.

Note 1. Description of the Plan (Continued)

Notes receivable from participants: Participants may borrow from their accounts the lower of \$50,000 or 50% of their vested account balance. The minimum amount for any single loan is \$1,000. Loan terms do not exceed five years, except if the funds are for certain home-related loans. The loans are collateralized by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are repaid through payroll withholding. Interest on participant loans is at a rate of prime plus 1%. The interest rates on outstanding loans ranged from 5.00% to 9.50% and 4.25% to 9.50% as of December 31, 2024 and 2023, respectively.

Payment of benefits: On termination of service, a participant is eligible to receive a distribution equal to the vested balance of the participant's account. A participant may, under certain conditions, withdraw all or a portion of their account balance without terminating their employment. If a participant's vested account balance is less than \$1,000, then the participant's vested account balance will be paid in a single lump-sum cash distribution as soon as administratively feasible after termination of employment. The Plan also includes an automatic rollover provision for terminated participants with vested balances of less than \$5,000. Such participants may elect to take a lump-sum distribution as soon as practicable following their termination of employment or the Plan sponsor will automatically roll over the distribution to an individual retirement account on the participant's behalf. Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan document.

Forfeited accounts: Forfeited nonvested account balances are used to pay administrative expenses with remaining amounts used to offset future employer contributions. Forfeited, nonvested accounts were immaterial at December 31, 2024 and 2023. Forfeited amounts of \$9,198 were used to reduce employer contributions during 2024.

Excess contributions payable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding decrease in contributions. The Plan distributed the excess contributions to the applicable participants in the subsequent plan year.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements and accompanying notes. Actual amounts could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are paid by the participants. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administration deems the loan to be a distribution, the participant's loan balance is reduced and a benefit payment is recorded upon distribution.

Contributions: Participant contributions are recognized when earned. The Company matching contributions are recognized concurrently with employee contributions. Company discretionary profit-sharing contributions are recognized annually, if applicable.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: A significant portion of the Plan's administrative expenses are paid by the Company; however, fees are split between the Plan and participants.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 4. Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under this standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trust funds: Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested and the net assets will be distributed to the participants and beneficiaries in proportion to their account balances.

Note 6. Parties-in-Interest

Certain Plan investments are managed by Reliance Trust Company. ADP is the trustee of the Plan and, therefore, these transactions qualify as parties-in-interest transactions. Fees paid by the Plan for recordkeeping and other services amounted to \$4,449 for the year ended December 31, 2024.

Note 7. Prohibited Transactions

During 2024, the Plan sponsor inadvertently failed to deposit \$27,125 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan sponsor intends to deposit lost earnings to correct this failure in 2025. The Plan sponsor will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan sponsor's assets and not from assets of the Plan. In 2024, the Plan sponsor corrected the 2023 delinquent participant contributions, which has been reflected in schedule H, line 4(a)—schedule of delinquent participant contributions.

Note 8. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that there were no uncertain tax positions that require recognition or disclosure in the financial statements.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
