## Independent Auditors' Report

### The Board of Trustees of Harlem Village Academy Charter School 403(b) Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Harlem Village Academy Charter School 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

The following description of the Harlem Village Academy Charter School 403(b) Plan (the "Plan") is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan, which was effective on November 1, 2007, is a defined contribution plan covering substantially all eligible employees of the Harlem Village Academy West Charter School ("West"), Village Academies Network, Inc. (d/b/a Harlem Village Academies), and Harlem Village Academy East Charter School ("East") (collectively the "School" or "Employer"). Effective July 1, 2024, West and East merged to become Harlem Village Academies Charter Schools. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Eligibility***

Employees are eligible to participate in the Plan on the first day of the month on or after they have completed at least 30 days of service. Employees who normally work less than 20 hours per week are not eligible to participate in the Plan. There is no minimum age requirement to participate in the Plan.

#### ***Contributions***

Each year, participants may elect to have a percentage or specified dollar amount deducted from their eligible compensation as defined by the Plan. Participants may make "pre-tax" deferrals or Roth contributions. The Plan has an automatic 4% elective deferral feature. A participant may elect to increase, decrease or suspend deductions according to procedures established by the School. There is an annual dollar limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Plan provides for a discretionary Employer matching contribution to the Plan based on the participant's eligible compensation. During 2024, the School made discretionary matching contributions equal to 100% of a participant's contributions up to 4% of their eligible compensation. The School may also make additional discretionary non-matching contributions to the Plan. During 2024, no additional discretionary non-matching contribution was made to the Plan.

Participants may also contribute amounts representing distributions (rollovers or transfers) from other qualified defined benefit or defined contribution plans; however, these contributions are ineligible for Employer matching contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

**1. Description of Plan (continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the School's contribution and (b) Plan earnings (losses) thereon. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are participant directed.

***Vesting***

Participants are immediately 100% vested in their contributions plus allocated earnings thereon. A participant vests in Employer matching contributions and Employer non-matching contributions in accordance with the following vesting schedule:

***Forfeitures***

At December 31, 2024 and 2023, balances of forfeited non-vested accounts totaled \$548 and \$0. Forfeitures may be used to reduce Plan expenses or future Employer contributions or they may be allocated to participants. During 2024, \$71,231 of forfeitures were used to reduce Plan expenses, \$226,421 of forfeitures was used to reduce Employer contributions, and no forfeitures were allocated to participants.

***Payment of Benefits***

Benefits are payable upon retirement, age 59 ½, death, or other termination of employment. Upon termination of service, a participant's balance will be paid in a lump-sum amount equal to the participant's account balance. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such hardship distributions, which are considered withdrawals, are subject to restrictions as to use of the proceeds and cause suspension of contributions for at least six months. Upon termination if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is valued at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payments of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan may be paid by the School and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

The Principal Fixed Income Guaranteed Option (the “PFIGO”) is a benefit-responsive general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The PFIGO is backed by the general assets of Principal Life Insurance Company. A rate of interest is contractually guaranteed by Principal Life Insurance Company. The rate is reset semiannually.

Benefit payments to participants for plan benefit events, including retirement, termination of employment, disability, Plan termination, death, loans, and withdrawals, as allowed by the Plan, are made without any surrender charge.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. The plan administrator believes that any events which would limit the Plan’s ability to transact at contract value with participants are not probable of occurring. An employer-level liquidation or employer initiated transfer of the Plan’s interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever an employer chooses. Notification of a Plan’s intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, notice becomes irrevocable. The PFIGO also has a surrender charge of 5% that may be charged if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan’s interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan’s interest in the contract.

### 5. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all participants will become fully vested in their accounts.

### 6. Tax Status

On March 31, 2017, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. Although the Plan has since been amended, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 7. Exempt Party-in-Interest Transactions

Certain investments of the Plan are managed by the Principal Life Insurance Company or Principal Trust Company, both of whom are members of Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Each month, Principal Life Insurance Company will determine the revenue it expects to receive with respect to the month and with respect to each investment option held in the Plan (“Monthly Expected Revenue”) pursuant to a written agreement with the Employer. Under the agreement, Principal Life Insurance Company credits the Monthly Expected Revenue to participant accounts, pro rata based on the fair market value of each investment option in each participant’s account as of the date of the credit or the credit may be used to reduce plan expenses. These transactions are considered allowable party-in-interest transactions under ERISA. Revenue in the amount of \$4,802 was used to reduce plan expenses during the year ended December 31, 2024.

Certain administrative functions are performed by employees of the School. No such employees receive compensation from the Plan.

### 8. Prohibited Transactions

During 2024, the Employer failed to remit to the Plan certain participants’ contributions totaling \$110 within the period described by the Department of Labor’s regulations. The Employer is in the process of making the necessary corrections to satisfy both the Department of Labor and IRS guidance for this matter for the delinquent contributions.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
