## Report of Independent Auditor

### Opinion

We have performed audits of the accompanying financial statements of the Association for Visionary Schools Health Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”). The financial statements comprise the statements of net assets available for Plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for Plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for Plan benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for Plan benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Note 1—Description of the Plan

The following description of the Association for Visionary Schools Health Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution health and welfare benefit plan that provides health benefits covering substantially all full-time employees of the participating schools of the Association of Visionary Schools (“Plan Sponsor”).

The Plan’s assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The governing board of the Plan Sponsor is responsible for oversight of the Plan.

*Administration* – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Benefits* – The Plan provides health benefits (medical, dental, and vision) to full-time employees of the Plan Sponsor and to their beneficiaries and covered dependents.

*Insured Benefits* – Current health claims of the participants and their dependents and beneficiaries are covered under a group insurance contract with Aetna, Inc.

*Self-Insured Benefits* – The Plan has a health reimbursement arrangement (“HRA”) that is funded with Plan Sponsor contributions. The HRA allows participants to be reimbursed tax-free for qualified medical expenses up to a maximum dollar amount for a coverage period. Amounts remaining at year-end can generally be carried over to the next year. The Plan Sponsor is not permitted to refund any part of the balance to the participants, the account cannot be used for anything other than reimbursements for qualified medical expenses, and remaining amounts are not portable upon termination once a participant terminates employment.

The claims for the HRA benefits are processed by the Plan’s third party claims processor. The claims processor pays claims directly to or for participants and is then reimbursed by the Plan’s VEBA trust. Despite the Plan’s utilization of a third party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

*Experienced Rated Contracts* – Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

*Contributions* – On an annual basis, the Plan Sponsor establishes participant contribution rates for the various benefit elections. The contribution rates are based on the Plan Sponsor’s consultations with the insurance carrier and third party claims processor to determine an estimate of the annual cost of the Plan. During 2024, participants contributed 10%, 20%, 30%, or 40% of total estimated contributions to the Plan through payroll deductions. The participating schools contributed the remainder. The Plan Sponsor may periodically require additional contributions from the participating schools.

The Plan received 2025 contributions prior to December 31, 2024 and 2024 contributions prior to December 31, 2023 and they have been recorded as contributions received in advance in the accompanying statements of net assets available for Plan benefits.

### **Note 2—Summary of significant accounting policies**

*Basis of Presentation* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Cash* – The Plan maintains its bank balance at a financial institution located in southern Ohio. Bank balances are insured by the Federal Deposit Insurance Corporation up to \$250,000. The Plan has not experienced any losses on this account.

*Payment of Benefits* – HRA claim payments are recorded when paid by the third party claims processor. Amounts due to the claims processor that have yet to be reimbursed by the Plan are recorded as payable to claims administrator in the accompanying statements of net assets available for Plan benefits. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for Plan benefits.

Premiums paid are recorded as insurance premiums paid in the accompanying statement of changes in net assets available for Plan benefits.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

### **Note 3—Related party and party-in-interest transactions**

Certain administrative services are provided by the Plan Sponsor at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Plan Sponsor. The Plan has entered into various service agreements with parties-in-interest. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

### **Note 4—Plan amendment and termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to amend the Plan to modify the benefits provided to the participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### **Note 5—Income tax status**

The Plan is required to operate in conformity with the Internal Revenue Code (“IRC”) to maintain its tax-exempt status. The trust established under the Plan to hold the Plan’s net assets had applied for a favorable tax exemption letter from the Internal Revenue Service (“IRS”). By a letter dated March 31, 2020, the trust was informed by the IRS that it qualifies pursuant to Section 501(c)(9) of the IRC to be exempt from income taxes.

U.S. GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
