DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of Timmons Group, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all eligible employees of Timmons Group, Inc. (the “Company”). Employees become eligible to participate and are eligible for entry immediately upon employment commencement date. The Plan excludes eligibility for interns and leased and reclassified employees.

Plan Administration – The Company is the Plan sponsor and Plan administrator. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan. The Company may reimburse the Plan for any administrative expenses incurred.

Contributions – The Plan provides for participant contributions of pre-tax and Roth contributions of a specific percentage or dollar amount of annual compensation, as defined in the Plan. Participants of qualifying age may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations allowed under Section 402(g) of the Internal Revenue Code (“IRC”).

The Company may make matching contributions and nonelective contributions equal to a discretionary percentage defined by the Company’s Board of Directors, to those participants employed on the last day of the Plan year. For the year ended December 31, 2024, the Company elected to contribute 50% of the first 10% of the participant’s compensation contributed to the Plan. There were no nonelective contributions in 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and Company matching contributions. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Each participant’s account is also allocated a portion of the Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participant accounts are segregated for purposes of determining the earnings or losses on each participant’s choice of investments.

Investments Options – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants as of December 31, 2024. Participants may change their investment elections at any time.

Payment of Benefits – Distribution of the vested portion of a participant’s account will occur upon the participant’s termination of service, retirement, death, disability, attainment of age 59½, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment, installment payments in an amount equal to the vested value of his or her account, or ad-hoc distributions. At December 31, 2024 and 2023, there were no benefit payments that had been requested but not yet paid.

Vesting – A participant normally becomes eligible for benefits after reaching age 65 or meeting the vesting requirements. A participant who becomes permanently disabled, dies, or reaches the normal retirement date while in the employment of the Company will have a 100% vested interest in his or her account. As defined in the Plan document, the normal retirement age is 55. Participants are immediately vested in their contributions, plus actual earnings thereon.

Forfeitures – Forfeitures of nonvested contributions may be used to pay Plan expenses or used to offset the Company's contribution obligation. The Plan's balance in the forfeitures account were \$89,861 and \$59,256 as of December 31, 2024 and 2023, respectively. Forfeiture balances of \$59,580 and \$38 were used to offset the Company's contribution and pay Plan expenses, respectively, for the year ended December 31, 2024.

Notes Receivable from Participants – A participant may borrow from the Plan an amount which, when added to the outstanding balance of any other loans from the Plan to the participant, does not exceed the lesser of: (i) 50% of his or her vested portion or (ii) \$50,000 reduced by the excess, if any, of the highest outstanding loan balance in the previous 12 months over the outstanding loan balance on the date of the loan. The period for repayment shall be for a period not to exceed five years unless the loan is to be used in conjunction with the purchase of the principal residence of the participant, for which the repayment period is up to 15 years. New loans are charged an interest rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. At December 31, 2024, the interest rates ranged from 4.25% to 9.50% on outstanding loans.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value, except for the fully benefit-responsive investment, which is reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company.

Note 2—Summary of significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefit payments are recorded when paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes are reclassified as distributions based upon terms of the Plan document. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

Contributions Receivable – The amount of employer contributions due and payable, but not yet deposited with the Plan as of year-end is reflected as employer contributions receivable in the Plan's financial statements.

Administrative Expenses – The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 3—Information certified by the qualified institutions (unaudited)

Assets of the Plan are in the custody of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (the "qualified institutions"). The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institutions of the Plan have certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, investments at contract value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in the fair value of investments, including realized and unrealized gains and losses, dividends and interest, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

Note 4—Fair value measurements

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between levels during the year ended December 31, 2024.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 or 2023:

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common Collective Trusts – These investments are valued based on NAV of units of the common collective trust. NAV, as provided by the qualified institution, is used as a practical expedient to estimating fair value. NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The funds' principal objective is to protect principal while providing a higher rate of return than shorter maturity investments, such as money market funds or certifications of deposits.

Guaranteed Investment Contracts – This investment is a guaranteed fixed income annuity backed by the qualified institution's claims paying ability whereby the annuity guarantees a principal and minimum interest rate, plus opportunity for additional amounts in excess of the guaranteed rate. The annuity contract is not traded, and significant other observable inputs are not variable. These contracts are reported at fair value and are classified within Level 3 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Guaranteed investment contract with insurance company

The Plan offers the Principal Fixed Income Guaranteed Option (“PFIGO”), which is a benefit-responsive group annuity contract issued by Principal Life Insurance Company. This investment is presented at contract value.

The PFIGO is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets. As a result, the average yield earned by the Plan is the yield earned (i.e: interest credited) on the group annuity contracts. The interest rate history for the contract is as follows:

The PFIGO investment option crediting rate resets semiannually at December 1st and June 1st.

By definition, a group annuity contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. Interest is credited to the Guaranteed Interest Fund on a daily basis from the date the deposits are accepted until paid, transferred, or applied in full. Fees may be paid in one of the following three ways:

- By being netted from the effective annual interest rate;
- By being paid separately by the Plan sponsor; or
- By being deducted from the Guaranteed interest fund.

Benefit payments are deducted from the value of the Guaranteed Interest Fund to the extent that the Composite value is sufficient to make such payments. Payments and transfers are made in full within three business days after the date payment or transfer has been requested. In the event that market conditions are such that it is determined that they will not allow for the orderly transfer or sale of financial instruments, up to an additional 30 days may be required to make such payments or transfers.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

Note 6—Tax status

The Company adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Note 6—Tax status (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and the net assets would be allocated to the participants of the Plan in amounts equal to the individual account balances.

Note 8—Party-in-interest transactions

Certain investments of the Plan are managed by the qualified institutions of the Plan's assets. The qualified institutions provide investment management services to the Plan. The Plan also pays fees to an investment advisor. Transactions involving these investments are considered to be party-in-interest transactions for which statutory exemption exists under DOL's Rules and Regulations. Fees incurred by the Plan for investment management and advisory services are paid directly by the Plan and, therefore, do qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan to these parties-in-interest totaled \$259,582 for the year ended December 31, 2024.

Notes receivable from participants also qualify as parties-in-interest.

Note 9—Subsequent events

The Plan administrator has evaluated subsequent events for potential recognition and disclosure in the December 31, 2024, financial statements through September 15, 2025, the date the financial statements were available to be issued.
