NOTE 1 - PLAN DESCRIPTION

The following description of John H. Northrop & Associates, Inc. 401(k) Safe Harbor Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution 401(k) plan available to substantially all qualified employees of John H. Northrop, Inc. (Sponsor). To be eligible to participate in the Plan and for the purposes of the employer safe harbor, non-elective contribution, the employee must be at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan agreement allows participants to contribute to the Plan and to receive employer safe harbor matching contributions on the first day of the first pay period ending after the employee meets the eligibility requirements. Participants must still complete one year of service before being eligible for discretionary nonelective employer contributions.

Contributions

Subject to certain limitations under Internal Revenue Code (IRC) Section 401(k), participants may contribute up to one hundred percent of their annual compensation, with the contributions and earnings thereon being nontaxable until withdrawn from the Plan. Participants may also contribute their after-tax annual compensation for Roth elective deferral purposes, subject to certain limitations, with the contributions and earnings thereon being nontaxable when withdrawn from the Plan. Upon reaching age fifty, participants are allowed to make catch-up contributions to the Plan. The Sponsor makes a safe harbor, non-elective contribution at a rate of one hundred percent of the first three percent of eligible participant compensation, as defined by the Plan. The Sponsor may also decide to make a non-elective, discretionary contribution. If made, the contribution will be allocated to participant accounts in the ratio that participant's eligible compensation bears to the total eligible compensation paid to all participants. Participants may also contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans are reported as rollover contributions.

Participant Accounts

Each participant's account is credited with the participant's and the Sponsor's contributions and an allocation of net Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their employee deferrals, employer safe-harbor, and any income or loss thereon. Vesting in the non-elective, discretionary contribution is based on years of continuous service. A participant is one hundred percent vested after six years of credited service. Amounts not vested at the time a covered employee ceases to participate in the Plan are forfeited.

Participants under the merged Technology Security Associates 401(k) Profit Sharing Plan retained the vesting schedule applicable under their original adoption agreement. Participants with discretionary matches or non-elective contributions under the previous Plan are one hundred percent after six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation of service, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or installment payments under various options. If a terminated participant's vested interest in his or her account is less than \$1,000 and he or she does not elect to receive a distribution from the Plan, benefits will be paid in a single lump-sum distribution as soon as administratively feasible. If a terminated participant's vested interest in his or her account is greater than \$1,000 but less than \$7,000 and he or she does not elect to receive a distribution from the Plan, benefits will be rolled over into an IRA of the plan administrator's choosing.

Forfeitures

The nonvested portion of a terminated participant's account balance shall be forfeited and used to pay administrative expenses or to reduce any employer contributions otherwise payable for the Plan year in which such forfeitures arise or for any succeeding Plan year. Forfeitures of \$7,675 were used to reduce Sponsor contributions for the year ended December 31, 2024. Unallocated forfeiture balances for Plan years ended December 31, 2024 and 2023 totaled \$8,848 and \$11,275, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. The Sponsor, at its discretion, pays the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent third-party administrator fees, other recordkeeping fees paid directly from the Plan, and any remaining fees not paid by the Sponsor.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of \$50,000 or fifty percent of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest of 5.25% to 9.50%. A loan will provide a fixed rate of interest equal to the prime rate reported by the United States Federal Reserve plus 1.00%. Principal and interest are paid through payroll deductions as indicated in the loan policy.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

As required by accounting principles generally accepted in the United States of America, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. One investment option in which participants may direct the investment of their accounts, the EI Fixed Account - Series Class II (fixed annuity contract), holds fully benefit-responsive investment contracts. The statements of net assets available for benefits present the contract value of the investment contracts. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Concentration of Market Risk

As of December 31, 2024 and 2023, approximately 56% and 21%, respectively, of the Plan's net assets were invested in four and one mutual funds, respectively. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the mutual fund and its investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date.

Fair Value - Continued

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Fixed Annuity Contract

The fixed annuity contracts is a group annuity insurance contract called the Empower Investments Fixed Account Series Class II Fund (the "Fund"). The Fund provide participants with liquidity at contract value for daily transactions including transfers between funds. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee and custodian, Empower Trust Company, LLC and Matrix Trust Company, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments at fair value and contract value, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

NOTE 4 - PLAN TERMINATION

Although it has not expressed intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become 100% vested in their employer contributions.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 6 - FAIR VALUES

The following is a description of the valuation methodologies used for assets measured at fair value.

There were no changes in the methodologies used at December 31, 2024 or 2023.

- *Money market funds*: Valued at amortized cost which approximates fair value.
- *Mutual funds*: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor, in a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities.

As of December 31, 2024 and 2023, the Plan believes it had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.

NOTE 8 - RELATED PARTY TRANSACTIONS

The fixed annuity contract is managed by Empower Trust Company, LLC, a trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions..

NOTE 10 - NON-EXEMPT TRANSACTIONS

During the year ended December 31, 2024 and 2023, employee contributions totaling \$197,657 and \$47,704, respectively, were not remitted within the appropriate time period by the Plan Sponsor. The contributions from 2023 were related to the November 7 payroll date (\$47,704). The contributions from 2024 were related to the following payroll dates: March 22 (\$49,330), May 22 (\$50,384), June 22 (\$49,117), and September 7 (\$48,827). These transactions constitute prohibited transactions as defined by ERISA. The Plan Sponsor is aware of the occurrences and took corrective action on \$49,330 during the year ended December 31, 2024, and \$196,031 after year end.
