Opinion

NOTE A - DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Copies are available from the Fund office.

1. **General** - The Plan is a defined contribution plan covering all employees working under the jurisdiction of the OPCMIA Local 526 Annuity Plan, who are employed by an employer who is obligated, pursuant to a collective bargaining agreement, reciprocal agreement or other written document, to make contributions on their behalf to the Fund. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. **Contributions** - Contributions are made to the plan in accordance with the terms of the collective bargaining agreement, reciprocal agreement or other written document.
3. **Participant Accounts** – The participants' accounts are self-directed. The Plan offers several different investment options for participants. Each participant's account is credited with employer contributions based on hours worked, investment earnings, and an allocation of administrative expenses. Administrative expenses are charged as a flat rate per account.
4. **Vesting** – All participants are immediately vested in all employer contributions plus earnings thereon.
5. **Payment of Benefits** – On termination of service due to death, disability or retirement, a participant may elect to receive a life time survivor annuity, a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly installments over the participant's normal life expectancy.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accounting records of the Fund are maintained on the accrual basis.

Valuation of Investments – The Plan's Mutual Funds are stated at fair market value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefit payments are recognized when paid.

Fixed Assets / Depreciation – All fixed assets are recorded at cost and are depreciated using the straight-line method over the estimated useful lives of the related assets.

NOTE C – INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Fund by a letter dated January 13, 2016, that the Fund and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE D - PRIORITIES UPON TERMINATION

In the event of termination and in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Fund to be used for or diverted to purposes other than the exclusive benefit of the Plan's participants and beneficiaries. In the event the Plan terminates, the net assets of the Fund will be allocated as prescribed by ERISA and its related regulations.

NOTE E - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Cash Equivalents - The carrying value of cash equivalents approximates fair value.

Registered Investment Companies – These investments are valued at the net asset value of shares held by the plan at year end.

Common Collective Trusts - Valued at unit values provided by the respective trustees of those trusts based on the estimated fair value of the investments held by the trust as determined by the trustees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Expenses common to this fund and related funds administered out of the same office are paid by OP&CMIA Combined Funds of Western PA, Inc. and are then allocated to the related funds.

NOTE G – ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE I – SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the day the financial statements were approved and authorized for issue.
