**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Eversheds Sutherland (US) LLP Cash Balance Plan B (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined benefit retirement plan, formed effective January 1, 2019, covering eligible equity partners of Eversheds Sutherland (US) LLP (the "Firm" or "Plan Sponsor"). Generally, equity partners of the Firm become eligible to participate in the Plan following completion of two years of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Participant Accounts: Under the Plan provisions, amounts are credited by the Firm to the participants' hypothetical accounts. A participant's cash balance account shall be credited with cash balance credits and earnings credits as described below.

**Cash Balance Credits**: For each Plan Year for which a participant earns a year of service, a cash balance credit shall be credited as of December 31<sup>st</sup> of the Plan Year to the cash balance account of such participant. For participants that first became a participant during the Plan Year beginning January 1, 2019, the cash balance credit shall be that amount as defined for such participant in the Plan document. The cash balance credits are equal to 50% for participants entering on or after January 1, 2020 through December 31, 2022, or 100%, for participants entering on or after January 1, 2023, of the cash balance credit amount determined based on the participant's partner ownership percentage for such Plan Year multiplied by the full or fractional year of benefit service earned during the Plan Year. In no event shall such cash balance credit be less than \$2,500.

**Earnings Credits**: Earnings credits are credited at the end of each day by applying the rate of return earned by the Plan for such day to the participant's cash balance account as of the beginning of the day. No earnings shall be credited with respect to a participant's cash balance credit for a Plan Year until January 15<sup>th</sup> next following the Plan Year for which the cash balance credit was earned. In no event shall the cumulative rate of return provided to the cash balance account be greater than 6% annualized over the period of Plan participation.

Pension Benefits: Benefits are determined based on the participant's hypothetical account balance. Plan participants are eligible to receive their Plan benefit following retirement or termination of service. Participants are allowed to take in-service distributions upon reaching age 59 ½. Under the terms of the Plan, participants have the option of receiving their Plan benefit as a single lump sum payment or a monthly annuity payable for their lifetime. Participants may also elect to defer payment until a later date. In addition, if the benefits due to a participant are \$5,000 or less, the amounts will be paid out in a lump sum. If a participant dies prior to receiving or commencing his or her benefit under the Plan, the participant's spouse or designated beneficiary, if not married at the time of death, will be entitled to the participant's benefit under the Plan.

Vesting: All Plan participants are 100% vested in their cash balance account at all times.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Funding Policy: Firm contributions to the Plan are made in amounts which will meet or exceed the minimum funding requirements under ERISA, as determined by the Plan's actuary. For the 2024 and 2023 plan years, the Firm made contributions of \$4,082,773 and \$3,464,557, respectively. The Firm's contributions to the Plan for the years ended December 31, 2024 and 2023, satisfied the minimum funding requirements of ERISA. Participant contributions are not permitted under the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures, and actual results may differ from those estimates. It is at least reasonably possible that a significant change may occur in the near term for the estimates of the actuarial present value of accumulated Plan benefits.

Risks and Uncertainties: Investments are exposed to various risks such as interest rate, market, liquidity, credit risks, and global events. Due to the level of risk associated with certain plan investments, it is at least reasonably possible that changes in the values of certain plan investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Payment of Benefits: Benefits are recorded when paid.

Administrative and Investment Management Expenses: Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All expenses of the Plan are paid by the Plan, unless paid by the Firm. Expenses paid by the Firm are excluded from these financial statements.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments included in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the trustee.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and exchange-traded funds: The fair values of mutual fund and exchange-traded fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trust fund: The fair value of participation units in the collective trust are based upon the net asset value (NAV) per unit, which is a practical expedient for fair value, of such fund and as reported by the fund manager. The fund provides for daily redemptions by the Plan at reported NAV per share.

**NOTE 5 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the plan are accumulated based on employees' compensation during each year of credited service. Benefits payable under all circumstances — retirement, death, disability, and termination of employment — are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawals or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of December 31, 2023 were as follows:

Distribution payouts: 100% lump sums  
Interest crediting rate: 3.5%  
Weighted average retirement age: 64

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Firm has the right under the Plan to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event the Plan terminates, the net assets of the Plan will be allocated among the participants and beneficiaries of the Plan in the order provided by ERISA.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation ("PBGC") if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service has determined and informed the Partnership by letter dated June 9, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was tax-qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE 7 - TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the plan, any party rendering service to the plan, the employer, and certain others. Certain administrative functions are performed by employees of the Firm. No such employee receives compensation from the Plan. The Plan holds mutual funds and a collective trust investment that is managed by AllianceBernstein, L.P., the Plan's investment advisor, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to other service providers also qualify as exempt party-in-interest transactions. Certain administrative expenses of the Plan are paid directly by the Firm.

**NOTE 9 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued. No subsequent events have occurred since December 31, 2024 that required recognition or disclosure in the Plan's financial statements.

**NOTE 10 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS (UNAUDITED)**

The December 31, 2024 actuarial valuation was completed prior to the release of the financial statements. A summary of the actuarial valuation information provided by the Plan's actuary, which has not been audited by independent accountants, is provided below for informational purposes.
