## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Jacsten Holdings, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Jacsten Holdings, LLC 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. ## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - Jacsten Holdings, LLC 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 26, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Jacsten Holdings, LLC is the plan sponsor, employer and plan administrator. Participating employers include CDM Tool & Mfg. Co., LLC ("CDM"), Stanek Tool, L.L.C. ("Stanek"), and Vonco Products LLC ("Vonco").

Charles Schwab Trust Bank is the trustee of the plan that holds plan investment assets and executes investment transactions. Milliman, Inc. is the recordkeeper and third party administrator responsible for maintaining plan and participant records and tax counsel that performs various compliance tests. The plan sponsor has established an employee benefits committee to act as plan administrator on behalf of the plan sponsor. The committee consists of three officers of the plan sponsor. Francis Investment Counsel is the plan's investment advisor.

**Investments** - The employee benefits committee, with consultation from the plan's investment advisor, determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold, and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

**Mutual funds** - Valued at the daily closing price as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

*Common/collective trusts* - The common/collective trusts held by the plan are direct filing entities and are valued at their NAVs. The NAVs are used as practical expedients to estimate fair values and are generally based on the fair values of the underlying investments held by the common/collective trusts less their liabilities. The practical expedient would not be used if it is determined to be probable that the common/collective trusts would sell the investments for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

### 2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

**General** - The plan was established on March 8, 2019 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible to make elective deferral contributions and receive employer matching contributions once they have completed 90 days of service and have reached 18 years of age. Employees are allowed to enter the plan on the first day of the month coinciding with or following meeting the eligibility requirements. Highly compensated employees are not eligible to receive employer contributions.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also allows for Roth elective deferral contributions. Upon meeting the eligibility requirements, employees are automatically enrolled in the plan and have 3% of their compensation withheld as elective deferral contributions. These participant deferral percentages automatically increased by 1% each year until they reached a maximum of 6%. Effective March 1, 2024, the maximum was increased to 10%. Such employees have the option to increase, decrease, or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. Employer matching programs are as follows:

CDM made discretionary matching contributions equal to 100% of the first 3% of compensation that a participant contributed to the plan. Matching contributions are made quarterly and are only approved if certain financial criteria are met. Discretionary matching contributions were made for all quarters in 2024 and for the 1<sup>st</sup> quarter, 2<sup>nd</sup> quarter and 3<sup>rd</sup> quarter during 2023.

Stanek made discretionary matching contributions equal to 100% of the first 3% of compensation that a participant contributed to the plan and 50% of the next 2% of compensation that a participant contributed to the plan in 2024 and 2023. The matching contributions are made on a semi-annual basis.

Vonco made discretionary matching contributions equal to 100% of the first 3% of compensation that a participant contributed to the plan and 50% of the next 2% of compensation that a participant contributed to the plan in 2024 and 2023. The matching contributions are made on an annual basis.

- d. Employer nonelective contributions may also be made at the employer's discretion. No such contributions were made in 2024 or 2023.

**Participant accounts** - Earnings, including fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's deferral and rollover contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options on a daily basis and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants generally begin vesting in employer contributions and related earnings upon completing two years of service at which time they are 100% vested. Special vesting provisions for employer contributions are applicable to participants with transferred account balances on March 8, 2019 as further defined in the plan document. Upon death, disability or attainment of normal retirement age (defined as age 65) while employed, participants become 100% vested.

**Payment of benefits** - Benefit payments are recorded when paid. Benefit payments may commence upon death, disability, retirement or termination of employment. Participants generally receive distributions in the form of a single lump sum payment or installments. Hardship withdrawals are allowed under certain circumstances and in-service distributions are permitted upon reaching age 59 ½.

**Forfeitures** - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Forfeitures used to pay plan expenses were \$74,000 in 2024 and \$10,000 in 2023. Forfeitures used to reduce employer contributions were \$25,000 in 2024. There were no forfeitures used to reduce employer contributions in 2023. Unapplied forfeitures were insignificant as of December 31, 2024. Unapplied forfeitures were \$106,000 of December 31, 2023.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer and not included in these financial statements. Certain other administrative expenses are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for distribution and loan fees and non-participant directed charges for service, administrative and advisory fees. Non-participant directed fees not paid from forfeitures are allocated to the participants on an account value basis.

**Notes receivable from participants** - Participants may obtain loans from their accounts with approval of the plan administrator. Each participant may only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the loans cannot exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Loans must be paid back over a period not to exceed five years, unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through November 2029 with interest rates ranging from 3.25% to 8.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### 3. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan sponsor, trustee and recordkeeper (as defined at Note 1) qualify as party-in-interest transactions. Nonparticipant directed fees paid to the recordkeeper, recorded as a component of administrative expenses in the accompanying financial statements, were \$56,000 in 2024 and \$46,000 in 2023. Direct fees paid to the trustee were \$9,000 in 2024. Direct fees paid to the trustee were insignificant in 2023. In addition, the trustee receives revenue from mutual fund service providers for providing services to the funds. This revenue is used to offset certain amounts that may otherwise be owed by the plan to the trustee for services provided by the trustee to the plan.

Notes receivable from participant transactions also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions and related earnings.

### 5. INCOME TAX STATUS

The plan is operating under a Milliman, Inc. non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The opinion letter from the Internal Revenue Service states that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

Management has obtained certifications from the trustee, as defined in Note 1, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.
