### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Walker Automotive, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Note 1. Plan Description**

The following description of Walker Automotive, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a profit-sharing plan covering substantially all of the employees of the Company. Employees are eligible to participate in the Plan once they have attained the age of 21 and have completed one year of service. The Plan provides for normal retirement, disability retirement and death benefits, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Voya Retirement Insurance and Annuity Company (Voya) serves as the Plan's recordkeeper and custodian.

### ***Contributions***

The plan is funded through participant and Company contributions. Participants may elect to contribute a percentage of their pretax annual compensation, as defined in the Plan document, up to the maximum allowable under the Internal Revenue Code (the IRC). The Company has an automatic enrollment feature which requires that all newly eligible employees will automatically have a 4% deferral deducted from their compensation, unless they elect not to participate. Each year, the Company will make matching contributions in an amount equal to 25% of the participant's elective deferrals, limited to 4% of the participant's compensation. The Company may also make discretionary profit-sharing contributions to the Plan each year, in amounts that are determined annually. All contributions are invested according to the fund allocation percentage specified by the participant.

### ***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds, common/collective trust funds, and a fixed-interest account.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of (1) the Company's contribution, (2) Plan earnings or losses, and (3) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are fully vested in their voluntary contributions, plus actual earnings, or losses thereon. Vesting in the employer's matching and discretionary contribution portion of their account plus actual earnings or losses thereon is based on years of continuous service. A participant is fully vested after 6 years of continuous service.

### ***Notes Receivable from Participants***

Participants may apply for loans from their vested balances in the Plan. The amount the Plan may loan is limited by rules under the Internal Revenue Code (IRC). Loans are treated as participant directed investments. The minimum loan allowed is \$1,000, and a participant may only have two loans outstanding at one time. All outstanding loan balances will become due and payable in their entirety upon severance of employment unless directly rolled over to another employer's plan. Loans generally have terms of one to five years. Loans will be granted an interest rate of the prime interest rate plus 1%. On December 31, 2024, outstanding loans bore interest rates from 4.25% - 9.50%.

***Payment of Benefits***

If employees terminate before rendering six years of service, they forfeit the right to receive some or all of the benefits they have accumulated based upon their percentage of vesting at the date of termination. Employees may elect to receive the current value of their accumulated benefits as a lump-sum distribution upon retirement or early termination, or they may elect to receive cash payments in annual or more frequent installments, over the life of the employee or beneficiary.

***Forfeitures***

On December 31, 2024 and 2023, forfeited nonvested accounts totaled \$40,881 and \$11,742, respectively. These accounts will be used to pay Plan expenses or to reduce employer contributions. During 2024, no forfeitures were used to pay Plan expenses or reduce employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Plan sponsors, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution payments are charged directly to the participant's account and are included in administrative expenses. In addition, accounting, recordkeeping, and investment advisory fees paid by the Plan are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**Note 3. Unaudited Information Certified by Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices included within level 1 that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Common/Collective Trust Funds**

The Plan invests in common/collective trust funds, for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) per unit, as provided by Voya, as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 30 days' to 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Fully Benefit-Responsive Fixed Interest Account**

The Plan has a guaranteed investment contract (the fixed interest account) with VOYA that totaled \$503,095 and \$487,144 as of December 31, 2024 and 2023, respectively. VOYA maintains contributions in a general account. The account meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The account's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is a traditional investment contract under which the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on credit rates established by contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) premature termination of the investment contract, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without consent of the issuer.

**Note 6. Exempt Party-in-Interest Transactions**

Certain Plan investments are managed by Voya, which serves as the custodian as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan to Voya for administrative and advisory services totaled \$71,508 for the year ended December 31, 2024.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized pre-approved profit sharing plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the non-standardized pre-approved prototype plan document was designed in accordance with applicable sections of the IRC. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
