Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fairwood Brands 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the Fairwood Brands 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution 401(k) plan which was established January 1, 2023 for the exclusive benefit of eligible employees of Fairwood Brands, LLC (the “Company”), as defined in the Plan document.

The plan was set up as a successor plan to multiple plans previously established. The plans that were transferred into the Plan included Bruss Landscaping, Inc. 401(K) Profit Sharing Plan, LML Estate Management Corporation 401(K) Profit Sharing Plan, Enchanted Garden Landscape Inc. Profit Sharing Plan, Fine Landscapes, LTD 401(K) Plan, Executive Landscaping, Inc. Retirement Trust and Bear Creek Landscaping LLC 401(k) Profit Sharing Plan & Trust.

Executive Landscaping, Inc. Retirement Trust transferred their assets into the plan in one transaction, occurring on September 9, 2024.

Bear Creek Landscaping LLC 401(k) Profit Sharing Plan & Trust transferred their assets into the plan in one transaction, occurring on May 1, 2024.

Contributions—Each year, participants may contribute up to a maximum of 100% of their annual compensation, as defined in the Plan. However, these contributions shall not exceed the maximum amount permitted by the Internal Revenue Code. All employees who have completed 60 days of service and have attained age 18 are eligible to participate in the Plan.

Effective February 1, 2023, the Company’s match for those participants eligible for the Plan is 100% of the first 3% of employee deferrals and 50% of the next 4% of employee deferrals, for a maximum of 5%.

For the year ended December 31, 2024, the Company contributed matching funds of \$339,367. The Company may, at its sole discretion for each plan year, make discretionary contributions to the Plan. No discretionary contributions were made to the Plan for 2024.

Upon enrollment, a participant may direct employee and employer contributions into any of the Plan’s investment options.

Participant Accounts—Each participant’s account is credited with the participant’s contributions and allocations of (a) Plan earnings or losses and (b) any Company matching or discretionary contributions. Earnings or losses of the Plan are allocated to individual participant accounts based on the participant’s account balance in the applicable fund.

Notes Receivable from Participants—Loans to participants are not permitted under the Plan as stated by the plan document.

During 2024, loans were transferred into the plan for \$24,309, where the Plan Sponsor did not amend its plan document to allow loans. Management plans to amend the Plan in 2025 to allow notes receivables for loans transferred in from other plans. The loans transferred into the Plan are secured by the participants' vested balance in the Plan's assets. These loans are generally due in weekly or bi-weekly payments of principal plus interest at the rate established at the issuance of the loan (ranging from 9.50% to 10.50%). The interest rate is fixed and based on the prime rate of interest as of the loan date plus 1.00%.

Vesting—Amounts contributed by participants and related earnings thereon become immediately vested. The Company's matching contributions and related earnings or losses become 100% vested upon entry into the Plan.

Withdrawals—Any participant can withdraw all or any portion of participant contributions as a result of financial hardship or attainment of age 59-1/2. Financial hardship shall include qualified medical expenses, tuition for post-secondary education, expenses incurred for the purchase of a primary residence or the need to prevent the eviction or foreclosure on a participant's principal residence.

Benefits Paid to Participants or Beneficiaries— On termination of employment, if the benefits are less than \$1,000, the participant will automatically receive the value of the vested account balance in one lump sum payment. For benefits that are between \$1,000 and \$5,000, the participant will have the option for either a cash payment or rollover into an IRA. For benefits that are greater than \$5,000, a participant is entitled to receive their vested account balance or may leave their vested account balance in the plan. Death benefits will be paid to the participant's designated beneficiary, which generally requires payment by the end of the calendar year following the date of death.

Plan Termination—Although it has not expressed any intention to do so, the Company has the right, at any time, to terminate the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The financial statements of the Plan are prepared on the accrual basis of accounting.

Administrative Expenses—Administrative expenses of \$44,572 consist of various administrative fees and distributions fees charged to the participant accounts. Distribution fees are charged to those specific participants that have requested distributions. Administrative fees are allocated to participants based on fund choices and balances. Additionally, the Company provides certain accounting and administrative services at no cost to the Plan.

Benefits Paid to Participants or Beneficiaries—Benefits paid to participants or beneficiaries are recorded in the statements of changes in net assets available for benefits when paid. At December 31, 2024 and 2023 there were no unpaid amounts due to participants who had elected to withdraw from the Plan.

Use of Estimates—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income are recorded on the cash basis. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Forfeitures—Based on the current vesting provisions in the Plan, the participants will not forfeit any of their account balance. Participants that do not deposit their distribution checks will have their stale dated checks cancelled and the funds deposited into the forfeiture account. Participants with funds deposited in the forfeiture account may receive their funds from the Company by request.

Forfeitures, relating to certain unvested funds transferred in from other plans, totaled \$32,309 in 2024. During 2024, \$35,574 from the forfeiture account were utilized to reduce 2024 employer contributions and \$2,100 was utilized to pay plan expenses. At December 31, 2024 forfeitures in the amount of \$177, were available for reduction of future employer contributions.

Subsequent Events—The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued and has determined that there were no transactions or other events that required disclosure through the evaluation date.

3. INFORMATION CERTIFIED BY TRUSTEE

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Common Collective Trusts: A stable value fund that is composed primarily of benefit-responsive contracts that is valued at the NAV of units of the common collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the

investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan does not have any contractual obligations to further invest in this fund.

5. PARTIES-IN-INTEREST

One Plan investment is a collective trust fund managed by Transamerica, the custodian of the Plan. These transactions qualify as party-in-interest transactions. The custodian maintains and manages the common collective trust in the Plan for which they receive management fees. These management fees are part of the annual operating expenses of each fund that range and result in a reduction of earnings from investments. All of these transactions are exempt from the prohibited rules of the Employee Retirement Income Security Act of 1974.

6. TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with various investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and in the statements of changes in net assets available for benefits.

8. PROHIBITED TRANSACTION

During 2024, the Company failed to remit the contribution for multiple pay periods in a timely manner, as defined by the Department of Labor regulations. The prohibited transactions were corrected outside the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) during 2025.
