Independent Auditor's Report

To the Plan Administrator and Plan Participants
Scott Industrial Systems, Inc. Profit Sharing 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Scott Industrial Systems, Inc. Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Scott Industrial Systems, Inc. Profit Sharing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Note #1 – Significant Accounting Policies

Basis of Accounting:

The accounting records of the Plan are maintained on the accrual basis.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized/unrealized gain and losses include the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates:

Management used estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions and deductions of net assets. Actual results could vary from those estimates that were used.

Payment of Benefits:

Benefits are recorded when paid.

Note #2 – Description of the Plan

The Plan was established effective January 1, 1987. The Plan is a defined contribution plan covering substantially all employees of Scott Industrial Systems, Inc. (the Company). The Company pays certain administrative expenses of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility Requirements – Each employee of Scott Industrial Systems, Inc. shall become a participant on the entry date (January 1 or July 1) coincident with or next following age 21 and the completion of one year of service (defined as 1,000 hours).

Contributions – The Plan provides for voluntary participant contributions up to 100% of annual compensation, as defined in the Plan. Participants age 50 or older may make additional "catch-up" deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employer matching contributions and qualified matching contributions (QMAC) to the Plan are discretionary and determined on a pay period basis. QMAC contributions are made only to non-highly compensated employees. The plan has a safe harbor plan basic matching formula of 100% of the first 3% of deferral and 50% of the next 2% of deferral. No employer QMAC matching contributions were made for 2024.

Note #2 – Description of the Plan (Continued)

The Plan also allows for an employer discretionary non-elective contribution and qualified non-elective contribution (QNEC), which would be determined on an annual basis and allocated to participants based on compensation. QNEC contributions are only allocated to non-highly compensated employees. To be eligible to receive any of these employer contributions, the participant must be employed at year end or have separated from service with at least 500 hours of service. There was no employer non-elective contribution or QNEC contribution in 2024. Contributions are subject to certain regulatory limitations.

Participant Accounts – Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Plan earnings are allocated using daily valuation accounting to each participant's account in the proportion that each participant's account balances, as defined, bears to the total account balances of all participants. Participants direct their investment contributions into investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefit Payments – Participants have a fully vested and non-forfeitable interest in the value of their account derived from participant contributions, employer matching, QMAC, and QNEC contributions. Upon termination of employment, a participant may receive the amount of his or her vested account balance. Payments are made in the form of a lump-sum payment in cash or a rollover to an IRA or another qualified plan. If a terminated participant's account balance is less than \$5,000 they have the option to make a direct roll over or they will receive a lump sum cash payment. Hardship distributions are permitted from the participant's vested account balances, excluding QNEC and QMAC accounts. In-service distributions are permitted upon reaching age 59½ from the participant's vested account balances. Required distributions begin upon reaching age 72, even if you are still employed.

Note #3 – Certification

All of the Plan's investments and investment transactions were recorded by Ascensus Trust Company, the asset custodian. The accompanying financial statements have been prepared from the information supplied and certified by the custodian, including investment assets, transactions, and income.

Note #4 – Income Tax Status

The Plan is an adoption of a prototype plan, which obtained its latest favorable opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the plan prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan and prototype have since been amended, however, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Note #5 – Plan Termination

Although it has not expressed any intent to do so, the employer has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated funds of the trust shall be allocated and all participants will become fully vested and non-forfeitable.

Note #7 – Common Collective Trusts

Common collective trust funds are comprised of units in such collective trust funds that are not publicly traded. The underlying assets in these funds (common stock, preferred stock, collective investment funds, U.S. Government and Agency Obligations, debt instruments, insurance investment contracts, global wrap synthetic investment contracts, securities lending funds, repurchase agreements, futures contracts, and foreign currency contracts) are valued where applicable on exchanges and price quotes for the assets held by these funds are readily available. When current market prices or quotations are not available, valuations are determined using valuation models adopted by the Trustee or other inputs principally from or corroborated by observable market data. Common collective trust funds are valued at their net asset value (NAV) on the last day of the calendar year of the period; as a result, these investments are not classified within the fair value hierarchy.

Investments in common/collective trust funds are valued at the net value of participation units held by the Plan at year-end. The value of these units is determined by the trustee based on the current market values of the underlying assets of the common/collective trust fund as based on information reported by the investment advisor using the audited financial statements of the common/collective trust fund at year end. The Plan held collective trust funds at December 31, 2024 and 2023 as described below.

The objective of the Metlife Stable Value Fund – Series 25053 Class 65, common/collective trust fund is to provide safety and preservation of principal and accumulated interest for participant-initiated transactions. The interest credited to balances in this fund will reflect both current market conditions and performance of the underlying investments in this fund. This fund is not FDIC-insured or registered with the Securities and Exchange Commission.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes the valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

Note #8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note #9 – Subsequent Events

Plan Management has evaluated subsequent events through the date of the report of these financial statements, which is the date on which the financial statements were available for issue.
