Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the IBG LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan sponsored by IBG LLC (the “Company”) to provide all eligible employees of the Company, its affiliates and related participating employers, who are aged 21, with an opportunity to accumulate retirement savings comprised of Company contributions and voluntary salary deferral contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was effective as of January 1, 1994.

The Company’s Board of Directors has appointed the Company’s Chief Financial Officer to act as Plan administrator. The Plan’s assets are managed by Fidelity Management Trust Company, (the “Trustee” or “Fidelity”) appointed by the Company.

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants (pretax and after-tax), (ii) matching contributions made by the Company, (iii) discretionary contributions made by the Company; and (iv) participant rollovers from another plan.

Each year, participants may contribute up to 15% of pre-tax annual compensation as defined in the Plan. Pre-tax contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan also allows for Roth 401(k) contributions, which started on July 1, 2010. Participants may contribute up to 15% of after-tax earnings as defined in the Plan. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. In February 2024, the Plan was amended to decrease the limit on catch-up contributions from 100% to 90% of eligible compensation. These additional contributions are eligible for a Company matching contribution.

The Company may provide discretionary matching contributions, which are based on eligible compensation contributed to the Plan each pay period. During 2024, the Company provided discretionary matching contributions of 50 cents for every dollar contributed by the employee up to a maximum of 10% of an employee’s payroll period compensation. For 2024, the Company matched employee contributions in the amount of \$7,623,524 for both the 401(k) and Roth 401(k) contributions. The Company may also make discretionary profit-sharing contributions. No such additional discretionary contributions were made for the year ended December 31, 2024.

For 2024, participants contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) of \$3,014,230, for both the 401(k) and Roth 401(k) contributions.

Contributions are subject to certain Internal Revenue Code (“IRC”) limitations. The maximum contribution allowable per participant under the IRC for participants under age 50 was \$23,000 and for participants over age 50 was \$30,500 for 2024.

Investments—Participants direct the investment of their contributions and/or account balances and the Company’s contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each

participant's account is credited with the participant's contribution, the Company's matching contribution, allocations of Company's discretionary contributions, and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan gains and losses; and administrative expenses that are not paid by the plan sponsor. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon. The portion of the participant's account contributed by the Company vests in 20% increments beginning after completing two years of service. A participant is 100% vested after six years of credited service.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan represents forfeitures. The Plan document permits the use of forfeitures to either reduce future employer contributions or plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$326,037 and \$303,136, respectively. In 2024, \$503,880 of forfeitures were used to reduce company contributions.

Payment of Benefits—Participants may elect to commence distribution of their nonforfeitable accrued benefit as of any distribution date after the Plan year in which the participant reaches normal retirement age. A participant who has separated from service may commence distribution on any distribution date following their separation from service. Distributions may be made in the form of a lump-sum payment or substantially equal installments, pursuant to the Adoption Agreement, which details all the plans provisions, and related addendum.

Participants may receive the full value of their vested interests upon termination of employment. Subject to certain limitations and conditions as set forth in the Plan document, Plan participants may withdraw funds from the Plan prior to termination.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Notes Receivable from Participants—Participants may borrow from the Plan an amount not to exceed the lesser of 50% of his or her vested accrued benefit or \$50,000. Loan terms range from 1 to 5 years; however, terms may not exceed 30 years for the purchase of a primary residence. Participants may not have more than one loan outstanding at any time. Collateral used as security for a loan shall be 50% of the participant's vested balance. Interest on such loans is charged at the prevailing bank prime interest rate, plus 1%. As of December 31, 2024, participant loans have maturities through 2051 at interest rates ranging from 4.25% to 9.50%. As of December 31, 2023, participant loans have maturities through 2051 at interest rates ranging from 4.25% to 9.50%.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants’ account balances and the amounts reported in the financial statements.

Payment of Benefits—Benefit payments to participants or beneficiaries are recorded upon distribution. There were no participants or beneficiaries, who elected to withdraw from the Plan, but have not yet been paid at December 31, 2024 or 2023.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year. The change in the difference between market value and cost of investments is reflected as net appreciation/ (depreciation) in the fair value of investments in the periods in which such changes occur. Gains or losses from the sale of investments are determined on the average cost basis.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Contributions – Employee contributions and employer matching contributions are recorded when earned by the Plan.

Administrative Expenses—The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan’s administrative expenses. Future Plan expenses can be paid from any excess remaining revenue sharing amounts. Administrative expenses of the Plan are paid by the Plan Sponsor as provided in the Plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments in the registered investment companies are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. For the year ended December 31, 2024, administrative expenses amounted to \$115,277 and participant revenue credits are \$244,226.

3. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2024.

Self-Directed Brokerage Account – Consists of investments in variety of mutual funds and are valued at their published net asset values and closing prices and are therefore categorized as Level 1 of the fair value hierarchy. These investments are deemed to be actively traded.

Stable Value Fund— The Stable Value Fund is a common collective trust fund sponsored by the Trustee. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund’s constant of \$1 per unit. Distributions to the Fund’s unit holders are declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable NAV of \$1 per unit, although, there is no guarantee that the Fund will be able to maintain this value.

The Fund is valued at the Net Asset Value (“NAV”) of the units of the common collective trust. The Fund invests in fully-benefit responsive investment contracts that are held at contract value. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan does not have any unfunded commitments with the fund, redemption frequency is immediate, and there are no redemption restrictions or notice periods of the fund.

Registered Investment Companies—Shares of registered investment companies, including money market funds, are valued at the closing price as reported by the registered investment company. Shares of registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and categorized as Level 1.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

6. FEDERAL INCOME TAX STATUS

The Company adopted a volume-submitter plan sponsored by Fidelity Management & Research Company. Fidelity Management & Research Company received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, which states the volume submitter plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

7. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation, recordkeeping, and financial reporting of the Plan.

Certain Plan investments are registered investment companies and a common collective trust fund managed by Fidelity, the Trustee as defined by the Plan, and these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned by each fund.

Fidelity performs certain administrative services to the Plan pursuant to the Service Agreement between the Plan and Fidelity. Per the Plan, Fidelity shall fund and allocate to eligible participants a participant revenue credit.

The Plan issues loans to participants, which are secured by the vested balance in the participants' accounts.

8. SUBSEQUENT EVENTS

The Plan Sponsor has evaluated events that occurred subsequent to December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued. The Plan Sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
