As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis effective December 1, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of Plan

The following description of Akai, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants may refer to the Plan’s documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Akai Security, Inc. (the “Employer”) who are at least eighteen years of age. The Plan also covers employees working under the terms of prevailing wage contracts that provide for employer prevailing wage and pension contributions. As of December 31, 2024, the Employer does not have employees working under prevailing wage contracts and the Plan does not have any active participants and therefore no contributions during the years ended December 31, 2024 and 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 1, 2024, Plan management passed a resolution to discontinue contributions and terminate the Plan. As the financial statements contemplate certain liquidation presentation requirements, the realization of assets and settlement of liabilities aligns to the Plan termination date rather than on a going-concern basis. Prior year amounts have not been restated on a liquidation basis and are still presented on a going-concern basis. The termination process was completed and all plan assets were distributed out of the Plan in February 2025.

Contributions

The Plan allows contributions of any portion of a participant’s pre-tax compensation, subject to contribution limitations specified by law. Participants may designate their contributions as pre-tax salary deferrals, after-tax Roth 401(k) contributions, or a combination of the two. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

The Employer may make discretionary matching contributions determined as a percentage of participant salary deferrals. The amounts of these contributions, if any, are determined at the discretion of the Employer’s board of directors. No discretionary matching contributions were made during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with employee contributions, allocations of Employer’s discretionary contributions (if any), the Employer’s prevailing wage and pension contributions (if any), allocations of Plan earnings or losses, and are charged with an allocation of any administrative expenses paid by the Plan.

Participant Accounts (continued)

Participants direct their funds into various investment options offered by the Plan. Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Notes receivable from participants are not permitted under the Plan.

Payments of Benefits

Upon retirement, permanent total disability, death, or termination of employment, participants or their beneficiaries may elect to receive their vested portion of Plan assets under several payout options specified in the Plan. Participants who have attained fifty-five years of age are permitted to withdraw all or part of their vested accounts as in-service distributions. Subject to certain conditions, a participant may make hardship withdrawals from his or her balance in the Plan while employed.

Administrative Expenses

The Plan pays custodial, recordkeeping, and certain professional and administrative fees. The Employer pays for certain other professional and administrative fees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits. There were no material valuation changes in investment securities held by the Plan upon liquidation of Plan assets in February 2025.

Payment of Benefits

Benefits are recorded when paid.

3. Custodian Certifications

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, cash, net appreciation in the fair value of investments, and interest and dividends, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the custodians of the Plan).

4. Fair Value Measurements

The methods used to measure fair values may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fair Value Measurements (continued)

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. All of the Plan's mutual fund investments were valued using Level 1 inputs, based on quoted market prices.

The Plan invests in a collective trust where the underlying investments primarily consist of value-approach exchange traded funds and mutual funds. The collective trust is valued at the net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV of each account is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the trust, the trust provider reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner. Upon termination of the Plan, as discussed in Note 1, the Plan initiated a full redemption of the trust. The trust provider temporarily delayed withdrawal from the trust to ensure security liquidations were carried out in an orderly business manner. Liquidation occurred in February 2025 at which point the full redemption of the trust was complete.

5. Unallocated Assets

Plan assets of \$0 and approximately \$31,000 had not yet been allocated to participants as of December 31, 2024 and 2023 and 2023, respectively.

6. Income Tax Status

The Plan operates under a non-standardized profit sharing plan document that obtained its latest determination letter on June 30, 2020, in which the IRS stated that the non-standardized profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Income Tax Status (continued)

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress.

7. Party-In-Interest Transactions

Fees paid directly by the Plan for custodial, recordkeeping, investment advisory, and other services amounted to approximately \$39,000 and \$62,000 for the years ended December 31, 2024 and 2023, respectively. These transactions, which qualify as party-in-interest transactions, are exempt from the prohibited transaction rules as defined by ERISA.

8. Subsequent Events

Management has evaluated events and transactions after December 31, 2024 through October 15, 2025, the date the financial statements were issued, for subsequent events. Other than completion of the Plan termination process and liquidation of the remaining Plan assets discussed in Notes 1 and 4, no subsequent events were identified.
