Note 1. Description of the Plan

The following description of Columbus Regional Health System Services 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined contribution plan sponsored by Southeastern Indiana Medical Holdings, Inc. (Company) for the benefit of its non-contract employees who have at least one month of service and are age 18 or older. Southeastern Indiana Health Management, Inc. is a related employer who also participates in the Plan. Transfers from an affiliated employer are immediately eligible to participate. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Lincoln Financial Group Trust Company, Inc. (Lincoln) is the trustee of the Plan. Lincoln Retirement Services Company, LLC is the record-keeper of the Plan.

Contributions

Each year, participants may contribute up to the maximum amount of their pre-tax or Roth annual compensation as defined by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year may make an additional catch-up contribution. Participants may also contribute amounts representing rollovers from other qualified plans. The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. Participants may not make pre-tax and Roth contributions during the same plan year.

Additionally, the Company may choose to make a discretionary matching contribution and discretionary profit-sharing contribution each year. For the years ended December 31, 2024 and 2023, the Company elected to make a matching contribution of 100% of the participant's deferral on the first 4% of eligible compensation for those participants hired before December 16, 2012 or to those with greater than ten years of service. For those with less than ten years of service and those which are considered a highly compensated employee, the Company matching contribution was 100% of the participant's deferral on the first 2% of eligible compensation for the years ended December 31, 2024 and 2023.

The Company elected to make a discretionary profit-sharing contribution of 2% of eligible compensation for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and any safe harbor Company contributions, plus actual earnings thereon. Company discretionary matching and profit-sharing contributions, as well as earnings thereon, are subject to a three-year cliff vesting schedule where participants become 100% vested after three years of credited service. Participants also become fully vested in the event of death, disability, normal retirement (age 59.5), or plan termination

Payment of Benefits

Upon termination of employment, retirement, death or disability, a participant (or beneficiary) may receive benefits based on the participants vested account balance. Benefits may only be paid in a lump-sum or installments, not more frequently than quarterly, over a period not to exceed ten years. The Plan has an involuntary cash-out option for vested accounts under \$1,000. In-service withdrawals are available under certain circumstances allowed by the Plan.

Notes Receivable From Participants

A participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of the 50% of the participant's vested balance or \$50,000. Loans are secured by the participants account balance and must be repaid over one to ten years depending on the purpose of the loan. Interest is charged on these loans at a rate equal to prime rate plus 1%. Participants are responsible for making loan payments directly to Lincoln.

Forfeited Amounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$82,752 and \$56,170, respectively. Forfeitures may be used to reduce the Company's matching contributions or pay administrative expenses. During 2024 and 2023, forfeitures of \$23,181 and \$11,500, respectively, were used to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis method of accounting. This method of accounting differs from accounting principles generally accepted in the United States of America because under this method, income is recognized when received (except contributions which are recognized on the accrual basis), and expenses are recognized when paid.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Lincoln Stable Value Account, which is a fully benefit-responsive investment contract, is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Fees paid to various mutual fund companies are netted against investment returns prior to being posted to participant accounts.

Notes Receivables From Participants

Loans to participants are reported at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Subsequent Events

Subsequent events have evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and participant loans included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Plan Tax Status

The IRS has determined and informed the Company by a letter dated May 16, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

Note 6. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities held include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities held by the Plan.

Note 7. Investment Contract With Insurance Company

In 2020, the Plan entered into a fully benefit-responsive insurance contract with Lincoln. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying contracts and is charged for participants withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specific interest rate that is guaranteed to the Plan. The minimum guaranteed interest rate is 1.70%.

Because the group annuity contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash

provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation.

The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 8. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in a Stable Value Account of the Plan trustee. The Plan paid \$37,468 and \$34,625 of recordkeeping and administrative fees to Lincoln during the years ended December 31, 2024 and 2023, respectively. Other professional fees paid during the years ended December 31, 2024 and 2023 totaled \$23,100 and \$11,500, respectively. The Company provides certain administrative services at no cost to the Plan.

The Plan has an expense reimbursement account with a balance of \$21,762 and \$21,252 as of December 31, 2024 and 2023, respectively.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
