Note 1: Description of Plan

The following description of the FNB 401(k) Employee Stock Ownership Plan (the "Plan") is provided for general information purposes. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is designed as a stock ownership plan with IRC Section 401(k) and 401(m) features for participating employees of First National Buffalo Bankshares Controlled Group (the "Company"). The Plan operates as an employee stock ownership plan and is designed to comply with Section 4975(e)(7) and the regulations there under of the Internal Revenue Code of 1986 and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (the "ERISA"). The Plan is administered by a committee approved by the Company. Internal management are the Plan's Trustees.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Eligibility

An employee of the Company becomes eligible to participate in salary deferrals and safe harbor non-elective contributions after completion of 90 days service and no minimum age is required. An employee who has satisfied the eligibility requirements will become a participant the first day of the calendar month following the satisfaction of such requirements. An employee of the Company becomes eligible to participate in nonelective discretionary contribution after completing one year of service and will be credited with a year of eligibility service after completing at least 1,000 hours. An employee who has satisfied the eligibility requirements will become a participant the first day of the first month and seventh month of the plan year following the satisfaction of such requirements. In order to receive the nonelective discretionary contribution, the participant must also be employed on the last day of the plan year.

Contributions

Each year, participants may contribute up to 100% of their pre-tax annual compensation as defined in the Plan, not to exceed an amount determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows for Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The Plan allows for a safe harbor non-elective contribution that cannot be less than 3% of the participant's plan compensation. During 2024, the Company elected to contribute 3% of the participant's plan compensation as a safe harbor non-elective contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Employer also may make a discretionary nonelective contribution. Participants are eligible for the contribution if they complete a year of service defined as 1,000 hours, are part of an eligible class of employees, and are employed on the last day of the plan year. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. There were no discretionary non-elective contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, as well as allocations of (a) the Company's discretionary nonelective contribution, (b) forfeitures (if any), and (c) plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully vested in their employee, rollover, and safe harbor non-elective contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts is based on years of service. A participant is 100% vested in their Company discretionary nonelective contributions after five years of credited service (20% per year after the second year of service). Forfeitures may be reallocated to eligible participants, reduce Company contributions, or pay expenses. There were no unallocated forfeitures at December 31, 2024 and 2023. Full vesting also occurs upon normal retirement (as defined by the Plan), disability, and death.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan interest is determined at the time the loan is taken out based on the US Prime Rate plus 1%. The notes are secured by the balance in the participant's account. A loan is payable over a period not to exceed five years, unless used to purchase a participant's principal residence, in which case the note may not exceed fifteen years. Principal and interest are paid ratably through payroll deductions. A participant can only have one loan at any given time.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon termination of service due to reasons other than death, a participant may elect either a lump-sum amount, substantially equal installments, or partial distributions equal to the value of the participant's vested interest in his or her account other than from the investment in FNB common stock. Upon termination of service due to death, a beneficiary may elect to receive a lump sum payment or installment payments over a period not greater than the life expectancy of the beneficiary. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan allows for in-service distributions upon attaining age 59 ½. The Plan includes the IRS hardship distribution regulations that were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disaster as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Cash and Concentration of Credit Risk

Cash consists of highly liquid investments with an original maturity of three months or less. The Plan maintains its cash in bank deposit accounts which exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. As of December 31, 2024 and 2023, the Plan had \$0 and \$367,066 in excess of FDIC-insured limits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: Summary of Significant Accounting Policies (Continued)

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Participant contributions and the related Company non-elective safe harbor contributions are recorded in the year in which the employee contributions are withheld from compensation or contributed.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, and certain expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are allocated to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Company Stock Program

Valuation

The Company Stock is valued at least once per year by an independent third-party appraiser.

Note 3: Company Stock Program (Continued)

Terminated Participants and Active Participants over age 59 ½

Terminated participants (or their beneficiaries if the participant is deceased) and active participants over age 59 ½ can choose to have either their share balance paid out in cash or rollover their shares to an accepting IRA account as a transfer in-kind. If a cash payment is elected, shares are sold at the current valuation price at the time the distribution request is processed. The Company is responsible for the cash purchases from a participant's account.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. A year of participation is measured based on plan years in which the participant had at least 1,000 hours of service. Diversification is offered to each eligible participant over a five-year period. In each of the first five years, a participant may diversify up to 25 percent of the shares allocated to his or her account, less any shares previously diversified. At the end of the fifth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The option to diversify is only applicable to employees with at least \$500 in employer stock.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to a participant for which there is no market. The put price is representative of the fair market value of the stock. A participant may receive a distribution from the Trust at any time during two option periods. The first put option period runs for a period of 60 days commencing on the date of the distribution to the participant. The second put option period runs for a period of 60 days commencing in the next Plan year after the new determination of fair market value of the Company's common stock or the 60 days after the first 60-day period. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Note 4: Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund: Valued daily at the NAV of the units of the bank collective trust. NAV is readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily and there are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 or 2023.

Investment in FNB common stock: The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. These appraisals were based upon a combination of acceptable income and market valuation methods. The appraisals took into account historical and forecasted financial information in estimating the fair value.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by the Custodian and the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The investment in common stock of the Employer, and all transactions involving the Employer common stock, are considered related-party transactions. Fees incurred and paid by the Plan for certain administrative and brokerage services were \$2,150 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 8: Income Tax Status

The Company has adopted a nonstandard pre-approved plan document with an opinion letter dated June 30, 2020, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and the related trust was tax-exempt at the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities including an investment in FNB common stock. Investment securities are exposed to various risks, such as interest rate, market, and credit risks as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk with the Plan's investment securities, and to the level of risk associated with the investment in FNB common stock, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, except for the investment in FNB common stock, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, except for the net appreciation in the investment in FNB common stock, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the Trustee of the Plan. Investment in common stock of \$5,535,750 and \$4,900,500, as of December 31, 2024 and 2023, respectively, and appreciation of \$635,250 for the year ended December 31, 2024, were not certified by the trustee.

Note 11: Plan Amendments

Effective February 9, 2024, the Plan was amended to allow participant loans.

Effective October 1, 2024, the Plan was amended to add interns and summer help as excluded employees for eligibility purposes.

Note 12: Right of First Refusal

Company stock that has been distributed to a participant and not immediately repurchased by the Company or Trust, may be subject to a right of first refusal as determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the Trust at fair market value as determined by an independent appraiser appointed by the Board.
