INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator
Jim Butler Auto Group 401k Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Jim Butler Auto Group 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jim Butler Auto Group 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Jim Butler Auto Group 401k Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jim Butler Auto Group 401k Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Jim Butler Auto Group 401k Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Jim Butler Auto Group 401k Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions for the year December 31, 2024 and assets (held at end of year) as of December 31, 2024, (the "supplemental schedules") are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Jim Butler Automotive Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1991, and restated January 1, 2021 as a defined contribution plan for the benefit of employees of Jim Butler Chevrolet Inc. (the "Plan Sponsor") and participating employers, (collectively, the "Company" or "Employer") who meet the Plan's eligibility requirements. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act, related to participant loans and distributions. The Company has until December 31, 2026, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until December 31, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date of the financial statements were available to be issued.

Plan administration

The Plan Sponsor is the administrator of the Plan's and, as such, carries out the duties imposed by ERISA. The Plan Sponsor has contracted with Advisor Trust, Inc. (the "Custodian") to act as the Plan's Custodian and Professional Capital Services, LLC, an affiliate of the Custodian, to perform the Plan's record-keeping services.

Eligibility

Most employees of the Company are eligible to participate in the Plan. However, employees are not considered an eligible employee if the employee is covered by a collective bargaining agreement or is a non-resident alien. Eligible employees may become participants in the Plan on the first day of the month after the employee has attained the age twenty-one and has completed one year of service.

1. DESCRIPTION OF THE PLAN (continued)

Contributions

Participants may elect to contribute a portion of their eligible compensation and have that amount contributed to the Plan. The Plan offers participants the option of contributing either pre-tax dollars or after-tax as Roth deferrals. The elective deferred amount may not be more than the lesser of: (a) the maximum dollar limit allowed under the requirements of the Internal Revenue Code ("IRC") or (b) such lesser amount as determined by discrimination tests for the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has an auto-enroll feature that enrolls participants in the Plan at a 4% deferral rate once they complete the eligibility requirements. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans.

The Company may make discretionary Employer matching contributions and discretionary Employer non-elective contributions, to eligible employees as defined in the Plan. For the year ended December 31, 2024, the Company made \$303,935 in Employer matching contributions. There was no discretionary Employer nonelective contribution made for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contribution, Employer contributions, and an allocation of investment earnings and losses, and is charged with certain utilization-based fees, as applicable. Participants are entitled to the benefit that can be provided from the participant's vested account. Plan participants can direct the investment of their Employer and employee contributions into various investment options offered under the Plan. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their elective and, if applicable, rollover contributions plus applicable earnings thereon. Discretionary matching contributions and profit-sharing contributions will vest based on years of vesting service in accordance with the following schedule:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable from participants ("participant loans" or "loan") terms include a maximum of 5 years, unless the loan is for the purchase of a primary residence. The maximum number of loans allowed at any time is one. The notes are secured by the balance in the participant's account and bear an interest at a rate at 1% over the prime rate at the date of issuance. Principal and interest are paid ratably through payroll deductions. Outstanding participant loans at December 31, 2024, bear interest at annual rates of between 4.25% to 9.50% with maturities through December 2029.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, disability, or death. In-service withdrawals from a participant's account are permitted to participant's who are 59 1/2 or older, financial hardship, rollover contributions, and qualified reservist, as defined in the Plan document. Upon termination, if a participant's vested account balance is less than or equal to \$7,000, their balance shall be automatically rolled over into an individual retirement account designated by the Plan administrator, unless otherwise elected. Upon termination, the participant may elect to receive a distribution of their account balance as a lump-sum payment or, if the account balance is greater than \$7,000, postpone payment to a later date and remain in the Plan.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net realized and unrealized appreciation in fair value of investments.

Forfeited accounts

At December 31, 2024, forfeited nonvested accounts totaled \$49,944 and \$38,370 respectively. These accounts may be used to reduce employer contributions as well as pay any administrative expenses. In 2024, forfeited nonvested accounts reduced employer contributions by \$36,532.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis method of accounting, in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") and in accordance with the provisions of ERISA.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts of assets and liabilities therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments in mutual funds are reported at fair value. The Plan's investment in a collective trust fund is reported at net asset value ("NAV") as a practical expedient to fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, while NAV is based on the fair value of a fund's underlying assets less its liabilities and expenses. See Note 4 for discussion of fair value measurements. The Jim Butler 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefit payments are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and a distributable event occurs, and the participant loan is determined to be deemed distributed, the notes receivable balance is reduced and a benefit payment is recorded.

Administrative expenses

Administrative expenses are recorded when incurred.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions or repayments have been separated from a participant's pay by the Company, which is the pay date. Employer contributions are recorded in the year earned to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the contributions are received by the Custodian.

Subsequent events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued. The Plan has been approved to be amended to add an auto-escalation contribution feature as of January 1, 2026, which will increase contributions for all participants one percent until they reach eight percent.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Custodian, determined to be a qualified institution by the plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year). The Custodian certified that the following investment information included in the financial statements is complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024.
- Investments and notes receivables from participants as reflected on the schedule of assets (held at end of year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the valuation hierarchy.

4. FAIR VALUE MEASUREMENTS (continued)

Collective investment trust ("CIT") is valued at NAV as calculated by the issuing financial institution, as a practical expedient to fair value. The NAV is based on the fair value of the underlying investments held by the CIT, minus its liabilities and expenses, divided by the number of shares outstanding. The Plan's investment in the CIT has a daily redemption frequency and no unfunded commitments (see Note 5).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Trustee by a letter dated June 30, 2020, that the volume submitter agreement the Plan has adopted and the related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan and ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

ERISA defines a party-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in interest.

Party-in-interest transactions include those with any fiduciary of the Plan, any party rendering services to the Plan, an employer whose employees are covered by the Plan, employees of the Plan, and certain others. As such, transactions conducted by the Custodian and its affiliates, including fee offset agreements, qualify as party-in-interest transactions. The Plan Sponsor pays certain fees and expenses on behalf of the Plan. The Plan is not required to reimburse the Plan Sponsor for expenses paid on behalf of the Plan. These transactions qualify as exempt party-in interest transactions.

Certain fund-level fees incurred by the funds in which the Plan invests for such services as record-keeping are paid through fund-level revenue-sharing agreements. These fees reduce the fund earnings, thereby impacting the investment return applied to participants' accounts.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company had late contributions and loan repayments totaling \$4,832 for the Plan year ending December 31, 2024. The Company utilized the Department of Labor Voluntary Fiduciary Corrections Program calculator to determine lost earnings to self-correct these delinquent contributions and loan repayments in the 2025 Plan year.

The Company had late contributions and loan repayments totaling \$97,472 for the Plan year ending December 31, 2023. The Company will utilize the Department of Labor Voluntary Fiduciary Corrections Program calculator to determine lost earnings to self-correct these delinquent contributions and loan repayments. Lost earnings will be contributed in the 2025 Plan year.

12. NET TRANSFERS

The Company also sponsors the Jim Butler Auto Group Union 401(k) Plan, a 401(k) plan for employees of certain divisions of the Company electing to participate. If employees change the terms of their employment during the year, their account balances are transferred into the corresponding plan.
