We have performed an audits of the financial statements of Peabody Properties, Inc. 401(k) Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1. Description of Plan

The following description of the Peabody Properties, Inc. 401(k) Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Peabody Properties, Inc. (the Company). The Plan was established on January 1, 1993, and was amended and restated on June 1, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An employee of the Company serves as the Plan Administrator. The Plan was most recently amended on September 14, 2021, with an effective date of September 27, 2021, to exclude certain payroll codes from eligible compensation on the effective date of the amendment. As of December 31, 2024 and 2023, Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan (Trustee).

**Eligibility:** All employees of the Company that are at least 21 years of age, with the exception of those employees covered by a collective bargaining agreement, leased employees and nonresident aliens who do not receive earned income in the United States of America from the Company, are eligible to participate in the Plan. Participants are either enrolled on the first day of the month following the month of hire upon the participant's election to participate in the Plan or are automatically enrolled in the plan at 6% of eligible compensation, as defined, upon completion of 30 days of service.

**Contributions:** Each year, active participants may make tax-deferred contributions from their compensation, as defined, subject to the Internal Revenue Service (IRS) limitation. Participants age 50 or older may make catch-up contributions. Active participants may elect to designate all or any portion of their future elective deferral contributions as Roth elective deferral contributions. An active participant may, with permission of the Plan Administrator, rollover to the Plan amounts from other qualified plans or individual retirement accounts, if the contributions satisfy the tax law requirement for a qualified rollover.

The Company may elect to make discretionary employer matching contributions equal to a percentage of employee elected contributions, as determined by the Company. For the year ended 2024, discretionary employer matching contributions equaled 50% of the first 6% of an employee's eligible compensation, for a maximum employer match of 3% of eligible compensation. For the year ended December 31, 2024, discretionary employer matching contributions totaled \$1,086,656.

**Participant accounts:** Each participant's account is credited with the participant's contribution, allocations of the Company's matching contribution, plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their employee contributions and rollovers, plus actual earnings thereon. Vesting in the discretionary employer matching contributions is based on years of continuous service. A participant vests 20% per year and is 100% vested after five years of credited service.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Retirement Committee. Participants may change their investment options daily. The Plan offers a variety of mutual funds and a guaranteed interest account in which participants can invest.

#### Note 1. Description of Plan (Continued)

**Forfeitures:** Forfeitures represent the nonvested portion of terminated participants' account balances and are used for monthly expenses and employer contributions. Forfeitures are first used to pay administrative expenses and then to reduce employer discretionary matching contributions. For the year ended December 31, 2024, \$195,058, of nonvested account balances were forfeited and \$129,939 were used to pay administrative expenses and reduce discretionary employer matching contributions. As of December 31, 2024 and 2023, the amount of forfeitures available to pay monthly expenses and employer contributions was \$78,360 and \$13,241, respectively.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance, reduced by the highest outstanding loan balance in the previous 12 months on the date the loan is made. Participants may have a maximum of two outstanding loans at any given time. The loans are secured by the balance in the participant's account and bear interest at fixed rate of the prime rate plus 2%. The term of each loan may not exceed five years unless the loan is used for acquiring or rehabilitating a principal residence. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:** The value of a participant's account will be distributed upon termination of employment due to retirement, death, disability or other. If the participant's vested benefit does not exceed \$5,000, payment in cash will be made in a lump-sum amount as soon as reasonably possible following termination of employment. If the participant's vested balance exceeds \$5,000, then the participant must consent to distribution before it is made. Participants may also receive in-service withdrawals upon reaching the age of 59½ and hardship distributions for any portion of their vested balance if they meet any of the financial needs criteria as defined by the Plan.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (U.S. GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to U.S. GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (ASC).

The financial statements of the Plan are prepared on the accrual basis in accordance with U.S. GAAP.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and the disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Retirement Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustee. See below for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. The net appreciation in the fair value of the investments reported in the statement of changes in net assets available for benefits includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of benefits:** Benefits are recorded when paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan for these services.

**Risks and uncertainties:** The Plan provides for investments in various mutual funds and a guaranteed interest account. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect amounts reported in the financial statements.

**Income taxes:** U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would be sustained upon examination of a tax authority. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the United States federal, state or local tax authority for years before 2021.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

The Trustee also certified to the completeness and accuracy of \$3,515,008 of net appreciation in fair value of investments, \$1,388,350 of interest and dividend income related to the aforementioned investments and \$74,436 of interest related to the participant loans for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

FASB ASC 820 Fair Value Measurements and Disclosure Requirements, issued by the FASB, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### Note 4. Fair Value Measurements (Continued)

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual funds:** These investments are valued at quoted market prices. These securities are categorized in Level 1 as they are actively traded, and no valuation adjustments have been applied.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Guaranteed Interest Account

The Plan has a fully benefit-responsive traditional guaranteed investment contract with the Trustee. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **Note 5. Guaranteed Interest Account (Continued)**

Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023, was \$3,044,691 and \$3,634,019, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, which may not be less than 1.00% as of December 31, 2024. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) temporary absence, (b) changes in position or other occurrence qualifying as a temporary break in service under the plan, (c) transfer or the change of position resulting in employment by an entity controlling, controlled by, or under common control with the employer, (d) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business, (e) removal from the plan of one or more groups or classifications of participants, (f) partial or complete plan termination or (g) plan disqualification. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### **Note 7. Party-in-Interest Transactions**

Certain Plan investments are managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan for the investment management services in 2024 were \$167,463. The Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts, which also constitute party-in-interest transactions.

#### **Note 8. Tax Status**

Effective June 30, 2020, the Plan adopted a nonstandardized form of a profit sharing plan sponsored by FMR LLC. The nonstandardized plan has received a favorable opinion letter from the IRS as to the nonstandardized plan's qualified status. The pre-approval plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

#### **Note 9. Subsequent Events**

The Company evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 15, 2025, for these financial statements.
