**INDEPENDENT AUDITOR'S REPORT**

To the Trustees of

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Spruce Technology, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Spruce Technology Inc, 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan’s provisions.

**GENERAL:**

The Plan is a qualified defined contribution plan covering all eligible employees of Spruce Technology, Inc. (the “Company”) except for:

- Certain nonresident aliens who have no earned income from sources within the United States.
- Employees who are residents of Puerto Rico.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by Vice President, General Administration & HR and Vice President, Finance, of the Company, appointed by the Company’s Board of Directors. The Plan Administrators are also the Plan’s Trustees. The Plan Administrators are responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**ELIGIBILITY:**

Employees of the Company who have attained age twenty one are eligible to participate in the Plan after completing three months of service.

**CONTRIBUTIONS:**

Participants may elect to defer up to 90% of their eligible compensation into the Plan on a pre-tax or Roth basis, not to exceed the maximum amount allowable by the Internal Revenue Code of \$23,000 for 2024. Participants aged fifty (50) or older as of the last day of the plan year may elect to make “catch-up” contributions of up to \$7,500 for 2024. This limitation is an aggregate limit that applies to all deferrals made to this Plan, and to any other salary deferral plan. In addition, participants may also rollover amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make profit-sharing contributions each year.

**PARTICIPANT ACCOUNTS:**

Each participant’s account is credited with the participant’s contributions, rollover contributions, and investment earnings (losses). The contributions are allocated among various investment options selected by the participants. Allocations are based on participant earnings, account balances or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The participant determines the percentage or amount of compensation to be deferred (subject to the limitations stated above).

**INVESTMENT OPTIONS:**

The Plan’s investments are held by Reliance Trust Company. Participants direct the investment of their contributions into various investment options offered by the Plan.

**VESTING:**

Participants are immediately vested in 100% of their salary deferral contributions, rollover contributions plus actual earnings thereon.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**NOTES RECEIVABLE FROM PARTICIPANTS:**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance on loans in the past 12 months or 50% of their vested account balance. A participant may not have more than two (2) loans outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent over the Prime Rate published in the Wall Street Journal on the first business day of the month before the loan is originated. The interest rate is fixed for the life of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions. The maximum term for loans is five years. As of December 31, 2024, the Plan had outstanding notes receivable from participants with principal balances totaling \$139,335.

**PAYMENT OF BENEFITS:**

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. A participant may request an in-service distribution once they have reached age 59 ½. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such hardship distributions, which are considered withdrawals, are subject to restrictions as to use of the proceeds.

If the participants' vested account balance does not exceed \$7,000, it will be distributed in a single lump-sum payment. If the vested account balance exceeds \$7,000, participants' may elect to receive a single lump-sum payment, installments over a period of not more than the assumed life expectancy or partial withdrawals of at least \$500.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when paid. If a participant ceases to make loan repayments and the plan administrator considers the participant loan to be in default, the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefit payments to participants are recorded when paid.

**PLAN EXPENSES**

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses relating to investment management are paid directly from the respective investment vehicle and are recorded as a reduction to net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust fund: Valued at the NAV of units held by the plan. The NAV, as provided by the plan trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund (a diversified portfolio of short-term money market instruments, fully benefit-responsive synthetic guaranteed investment contracts and other similar contracts with various insurance companies, banks, and financial institutions) less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes the valuation methodologies are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

**NOTE 5 – COMMON COLLECTIVE TRUST**

The Invesco Stable Asset Fund (the "Fund") is a common/collective trust. The Fund is managed by Invesco Trust Company. The investment objective of the Fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The crediting rate formula is used to determine the Fund's yield to amortize the gain/loss experience over the duration of the contract. The crediting rate provides a fixed return for a period until the next rate reset. Crediting rates may be reduced in the event of large withdrawal from the Fund, and the fund's yield may not reflect prevailing market interest rates. The Fund has no unfunded commitments at December 31, 2024.

**NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain employees of the Company may also be participants in the plan and perform administrative services to the Plan at no cost to the Plan.

Notes receivable from participants also qualifies as party-in-interest transactions but are exempt from the prohibited transaction rules of ERISA. The Employer provides certain accounting and administrative services to the Plan for which no fees are charged.

**NOTE 8 – TAX STATUS**

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax exempt. In accordance with Revenue Procedures 2016-6 and 2015-36, the Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions. However, there are currently no examinations for any tax periods in progress.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 10 - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in

the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

The Plan holds certain investments that each represent 10% or more of the total investments held by the Plan. As of December 31, 2024, the Plan had investments concentrated in three funds totaling \$2,573,592.

**NOTE 11 - SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan has changed its trustee from Reliance Trust Company to ADP Trust Retirement Services, LLC.

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. There were no other subsequent events that required recognition or disclosure in the financial statements.
