### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hometown Grocery 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1 – Plan Description

---

The following brief description of Hometown Grocery 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Hometown Grocery, LLC d/b/a Grant’s Supermarket (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Eligibility*

All employees as defined are eligible to participate in the Plan once they attain age 21 and have completed one year of service with semi-annual entry dates of the first day of the Plan year and the first day of the seventh month.

#### *Contributions*

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) safe harbor matching contributions (100% of participant contributions for the first 3% contributed and 50% for the next 2% contributed by participants), and (iii) discretionary profit-sharing contributions. There were no profit-sharing contributions for the years ended December 31, 2024 and 2023. Each participant may authorize the Company to contribute on a pretax basis up to 100% of their annual salary subject to limits prescribed by the *Internal Revenue Code (IRC)*. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with (a) the participant’s contribution, (b) the Company’s contributions, and (c) an allocation of Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Distribution of Benefits*

Upon attainment of normal retirement at age 65, termination of employment, disability, or in the case of death, a participant or their beneficiary, will receive the vested portion of the amount credited to the participant’s account. The participant with benefits greater than \$7,000 may choose periodic payments over a time period, as defined, chosen by the participant or in a lump sum. They may also choose to leave the benefits in the Plan to the extent that age requirements allow. In-service distributions are available to participants at least age 59½. Benefits between \$1,000 and \$7,000 will be paid by lump sum or rolled into an individual retirement account. Benefits under \$1,000 are payable in a single lump sum.

### *Vesting Requirements*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are 100% vested in their safe harbor account. In regard to any profit-sharing contributions made by the Company, a participant who has completed three years of service or who attains age 65 while employed by the Company shall have a non-forfeitable right to the entire balance in their account. Upon the termination of employment, a participant shall have a vested interest in their accrued benefit based on the table below. The benefit will be payable at normal retirement date.

### *Forfeitures*

Forfeitures related to employer profit-sharing contributions are used to reduce Plan expenses. There were no forfeited non-vested accounts for the years ended December 31, 2024 and 2023. During 2024, no forfeitures were used to reduce Plan expenses.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a maximum amount equal to the lesser of (i) \$50,000 reduced by the highest outstanding loan balance from the previous twelve months or (ii) 50% of their vested account balance. Terms range from 1 to 5 years, unless the loan was taken for the purchase of a primary residence for which longer terms are available. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. For the year ended December 31, 2024, the interest rates for notes outstanding with the Plan were between 7.75% and 8.5%.

### *Administrative Expenses*

Certain administrative expenses are paid by the Plan, and remaining expenses are paid by the Plan Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### *Benefit Payments*

Benefits are recorded when paid.

### *Subsequent Events*

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

---

## **Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

### *Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end. These investments are public investment vehicles valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

### *Level 2 Fair Value Measurements*

The fair values of the collective trust funds are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets and may also include insignificant adjustments to market observable inputs. The collective trust funds invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal. No distributions of income and gain or loss are made to participants.

### Note 5 – Tax Status

---

The Plan was adopted under a prototype non-standardized profit-sharing plan with Ascensus, LLC. Ascensus, LLC received a letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that its prototype plan is designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the IRS approval letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
