Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of the Qualitas Dental Partners, LLC Retirement Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all employees of Qualitas Dental Partners, LLC (the Employer or the Company), who are 18 years of age or older and have completed three months of service. Part-time, temporary and seasonal employees will become eligible after completion of 1 year of service (1,000 hours as defined by Plan provisions). Entry dates into the Plan are the first day of the Plan year quarter following satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established by the Employer on January 1, 2023.

The Employer is also the Plan Administrator. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (Reliance) is the appointed trustee of the Plan and holds and manages Plan investments, as well as provides recordkeeping services, at the direction of the Plan Administrator.

Effective January 1, 2025, the Employer entered into an agreement with Automatic Data Processing (ADP) Retirement Trust Services, LLC replacing Reliance Trust Company as the Plan's trustee. The Plan was amended and restated effective January 1, 2025. The provisions of the Plan remained consistent with this restatement.

Contributions

Eligible employees may elect to contribute up to 90% of their eligible compensation to the Plan, so long as those contributions do not exceed annual limitations set by the Internal Revenue Code (IRC). Participants may designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants who have reached the age of 50 before the end of the Plan year may contribute additional amounts in the form of catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Plan included an automatic enrollment provision, whereby eligible employees were automatically enrolled to defer 6% of eligible pre-tax earnings, as applicable, in the Plan unless they affirmatively elect not to participate. Effective January 1, 2024, the Plan was amended to no longer include an automatic enrollment feature.

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE) Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

The Company may decide to make a discretionary matching contribution, although the Company is not required to do so. The percentage of elective deferrals to be matched will be determined by the Company and allocated to all eligible participants at the end of the Plan year. For the year ended December 31, 2024, the discretionary matching contribution was \$173,671.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s matching contribution, and their allocation of Plan earnings and losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary elective contributions and rollover contributions, plus the allocation of Plan earnings and losses, at the time of allocation. Participants become fully vested in the Employer’s discretionary matching contributions and the allocation of Plan earnings and losses as follows: 20% after 1 year, 40% after 2 years, 60% after 3 years, 80% after 4 years, and 100% after 5 years. Each participant shall be 100% vested in their account balances upon death or disability, or attainment of normal retirement age.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Note terms range from one to five years, or up to 30 years for the purchase of a primary residence. The notes are secured by the balance in the participant’s account and bear interest equal to the prime rate plus 1.00%. Principal and interest are paid ratably through payroll deductions. Participants can only have one loan outstanding at any given time.

Payment of Benefits

Upon retirement, death, disability or termination of service, a participant (or participant’s beneficiary in the event of death) can elect to receive 100% of their vested account balance, payable in a single lump-sum distribution or a rollover to a qualifying retirement account, or defer receiving payments until age 72. Participants who have reached the age of 59½ may elect to withdraw a minimum of \$500 from their account while still employed by the Employer.

If a participant's vested balance is equal to or less than \$5,000, the participant will receive an immediate cash-out of their vested account balance in a single lump-sum distribution, and the non-vested portion shall be treated as a forfeiture. Participant consent is required if the vested balance exceeds \$5,000 and the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant.

Effective January 1, 2024, the Plan adopted the provision of the SECURE Act 2.0 to increase the limit for involuntary automatic lump-sum distribution for account balances from \$5,000 to \$7,000.

Hardship Withdrawals

Hardship distributions are permitted from all accounts subject to limitations imposed by the IRC.

Effective January 1, 2024, the Plan adopted the provision of the SECURE Act 2.0 to permit self-certification of financial hardship withdrawals.

Forfeitures

Participants in the Plan who leave the employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeited non-vested accounts may be used to reduce future Employer contributions or pay administrative expenses. As of December 31, 2024, forfeited non-vested accounts totaled \$4,752. As of December 31, 2023, there were no forfeited non-vested accounts. During 2024, \$433 in forfeitures were used to reduce Employer contributions.

Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants, and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

Contributions

Participant contributions are recorded weekly and bi-weekly, as applicable, when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary matching contributions, if any, are recorded at the end of the Plan year.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Excess Contributions Refundable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year end.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held three mutual funds that accounted for approximately 55% and 61% of total Plan investments at December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through October 9, 2025, which is the date these financial statements were available to be issued

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: The Plan invests in the Reliance Trust Company Collective Investment Trust for the Metlife Group Annuity Contract Series 25053 Class 0. It is valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trust reserves the right to temporarily delay withdrawals in order to ensure that liquidations of securities will be carried out in an orderly business manner. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

As of December 31, 2024 and 2023, the Plan held investments in one collective investment trust for which NAV was employed to estimate fair value with daily redemption frequency and no redemption notice period.

4. Income Tax Status

The Plan has adopted an ADP non-standardized pre-approved plan. The pre-approved plan obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Summary of Financial Data Certified by the Trustee

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

6. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

7. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Reliance, the trustee of the Plan. ADP Retirement Services is the recordkeeper of the Plan, and MMA Securities, LLC is the independent investment advisor. Therefore, these transactions qualify as party-in-interest transactions. The Plan made aggregate payments of \$10,469 to the recordkeeper and independent investment advisor for the year ended December 31, 2024. In addition, participant notes receivable also qualify as party-in-interest transactions.

8. Non-exempt Transactions

During 2024, the Employer failed to remit participant contributions of \$120,224 and loan repayments of \$2,004 to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Employer.

During 2024, the Employer remitted untimely participant contributions and loan repayments totaling \$120,066 due to the Plan for the year ended December 31, 2024. During 2025, the Employer remitted untimely participant contributions of \$2,162 due to the Plan for the year ended December 31, 2024. The Employer is currently working with its third-party administrator to calculate and remit any lost earnings associated with these late remittances during 2025.

During 2023, the Employer failed to remit participant contributions of \$89,316 to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102.

During 2023, the Employer remitted untimely participant contributions of \$86,795 due to the Plan for the year ended December 31, 2023. During 2024, the Employer remitted untimely participant contributions of \$2,521 due to the Plan for the year ended December 31, 2023. During 2024, the Employer remitted lost earnings applicable to the correction of the 2023 untimely participant contributions.
