Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of the Preferred Technologies 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Preferred Technologies 401(K) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was formed and adopted by the Company, effective January 1, 2010, as a defined contribution 401(k) plan that provides retirement savings benefits to certain full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan has been amended and restated from time to time, most recently on January 1, 2022, to incorporate all previous amendments and to comply with all ERISA and Internal Revenue Code ("IRC") rules and regulations.

Administration

The Plan is administered by the Company and accordingly, certain administration functions are performed by officers or employers of the Company. No officers or employees receive compensation from the Plan. The trustee for the Plan's assets is Reliance Trust Company (the "Trustee"). The recordkeeper for the Plan is T. Rowe Price (the "Recordkeeper").

Eligibility

All non-excluded employees of the Company, such as any employees covered under a collective bargaining agreement, are eligible to participate in the Plan once they have performed one hour of service. Employees will be eligible to enter the Plan immediately upon eligibility.

Participant Contributions

Each year, participants may make contributions to the Plan not to exceed the limitation (\$23,000 in 2024) set forth in Section 402(g) of the IRC. Participants may designate all or a portion of their contribution as a ROTH deferral, which is a post-tax deferral. Additionally, participants may make catch-up contributions (pre-tax contributions and/or ROTH contributions that exceed the annual elective deferral limit) during any calendar year ending on or after the participant's 50th birthday. Participants' total catch-up contributions are limited to a maximum of \$7,500 in 2024. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Company makes a safe harbor matching employer contribution to eligible participants, as defined in the Plan document. The Company matches 100% of the first 4% of the participant's eligible compensation. The Company may also make discretionary matching contributions, which are allocated to participants based on each participant's eligible compensation deferred into the Plan each plan year. Additionally, the Company may make discretionary non-elective contributions to eligible participants, which are determined by the Company. During the year ended December 31, 2024, the Company made \$470,648 in safe harbor matching contributions, and no discretionary matching or discretionary non-elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' accounts in the fund. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Loan terms may not exceed five years, or 10 years if used for the purchase of a principal residence. Principal and interest are paid through payroll deductions. As of December 31, 2024 and 2023, loans bore interest at rates ranging from 4.00% to 9.35%. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

1. Description of Plan, continued

Vesting

Participants are immediately vested in their elective contributions, qualified non-elective contributions, and safe harbor matching contributions, and earnings thereon. Participants vest in their matching contributions and non-elective contributions at a rate of 20% per year after two years of service and are 100% vested after six years of service. Participants become immediately 100% vested upon attaining the normal retirement age of 65, disability or death.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or his or her designated beneficiary in the event of death) will receive the value of their account through a single lump-sum distribution. Partial or installment distributions are permitted only to satisfy the required minimum distribution rules.

Distributions on account of death may be made over a period as provided in the Plan document, if elected by the beneficiary.

Participants who have attained age 59 ½ may receive an in-service distribution from certain accounts. Subject to guidelines set forth in the IRC, a participant may request a hardship withdrawal.

Administrative Expenses

The Plan routinely incurs expenses related to general administration and recordkeeping of the Plan. Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the Plan's financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as further described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as loan fees and are expensed when they are incurred.

Benefit Payments

Benefit payments are recorded when paid.

3. Fair Value Measurements

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses two different approaches, the market approach and the cost approach, depending on the nature of the asset or liability. The market approach uses prices and other relevant data based on market transactions involving identical or comparable assets or liabilities. The cost approach is the amount that would be currently required to replace an asset or liability and indicates the cost to the Plan to acquire a substitute asset.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Market Approach)

Money market fund: Valued at amortized cost, which approximates fair value and is classified within level 2 of the valuation hierarchy. (Cost approach)

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

Under Section 401(a) of the IRC, the Plan is qualified as tax-exempt. The Plan is based on a pre-approved plan offered by the Trustee. The Trustee received a letter, dated June 30, 2020, from the Internal Revenue Service ("IRS") regarding its review of the pre-approved plan. In the letter, the IRS stated the pre-approved plan was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the DOL and IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

7. Party-in-Interest Transactions

The Plan pays expense to the Custodian or Trustee. These transactions qualify as party-in-interest transactions, as defined by ERISA; however, these transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

8. Operational Errors

During the year ended December 31, 2024, it was identified that certain contribution errors have occurred related to improperly applying participant deferral percentages that may result in corrective contributions receivable. As of the date of the financial statements were available to be issued, the amounts of corrective contributions were not known. The Company is in the process of correcting these amounts and will make corrections as soon as administratively feasible. Although the corrections are not expected to be material to the Plan's financial statements, any corrections are not reflected in the accompanying financial statements and will be reflected in future periods.

9. Subsequent Events

Plan management has evaluated all subsequent events through October 15, 2025, which is the date the financial statements were available to be issued, and has concluded that there were no significant events to be reported.
