**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Jones Bros. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan established for the exclusive benefit of all employees of Jones Bros. Contractors, LLC (the “Company “). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA “), as amended.

Eligibility: The Plan covers substantially all employees who are age 21 or older and are not covered by a collective bargaining unit. Effective March 1, 2023, the Plan was amended to cover substantially all employees who are age 18 or older and are not covered by a collective bargaining unit. For purposes of employee salary deferral contributions, employees must have completed six consecutive months of service as defined by the Plan. For purposes of employer contributions, employees must have completed one year of service. Upon attaining such requirements, an employee may begin participating on the first day of the following quarter.

Effective January 1, 2024, the Summit Constructors, Inc. 401(k) Retirement Plan was merged into the Jones Bros. 401k Plan. The transfer of net assets into the Plan was completed during 2024 in the amount of approximately \$1.2 million.

Contributions: Each year, participants may contribute up to 100% of their compensation up to a maximum contribution as allowed by the Internal Revenue Service. These contributions can be made both before and after tax (Roth). Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Participants who are age 50 or older by the end of the Plan year may make catch-up contributions, subject to certain Internal Revenue Code limitations. The Company contributes a Safe Harbor match of 100% of the first 3% of the participant’s compensation plus 50% of the amount of the participant’s matched employee contributions that exceed 3% of the participant’s contributions but that do not exceed 5% of the participant’s compensation. Additional profit-sharing contributions are discretionary and determined annually by the Company. Rollover contributions from other qualified plans and individual retirement accounts are also allowed by the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of the Company’s contributions and Plan earnings. Each participant’s account is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in the amount of participant contributions and earnings thereon. Vesting in Company contributions and related earnings is based on years of service as follows, counted from the participant’s date of hire:

Notes Receivable from Participants: Participants may borrow up to 50% of their vested account balance not to exceed \$50,000 and not less than \$1,000. The loans are generally repaid over a period of two to five years through payroll deductions. The notes receivable bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator.

Payment of Benefits: Upon retirement, death, disability or termination of employment, participants' vested account balance is available for distribution in one of the methods defined by the Plan.

Active employees may make withdrawals of all or a portion of their account balances subject to certain withdrawal and contribution suspension rules as defined by the Plan. Withdrawals from the accounts are not allowed for participants who are less than 59½ years of age, except under hardship withdrawal and rollover contribution provisions.

Hardship Withdrawals: Participants may withdraw all or a part of their account balance attributable to elective deferrals and certain employer contributions to the extent vested, limited to the amount needed to meet the financial need, as defined by the Plan.

Forfeitures: Forfeitures of nonvested matching contributions are used to reduce the employer's matching contribution and pay administrative expenses.

Administrative and Investment Management Expenses: The Plan's record keeping and administrative fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit-responsive investment contracts are reported at fair value as described further in Note 4. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Trust Company and Transamerica Life Insurance Company for the period July 1, 2024 through December 31, 2024 and as of December 31, 2024, and Reliance Trust Company for the period January 1, 2024 through June 30, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)**

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

**NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

Traditional Guaranteed Investment Contract: The Plan holds a fully benefit-responsive investment contract with Transamerica Life Insurance Company ( “Transamerica “, “Issuer “) that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan’s fully benefit-responsive investment contract, by general type, is presented below:

Transamerica maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated monthly based upon contract provisions, and it may not be less than 1%. Transamerica’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

**NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)**

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding the set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 6 - TAX STATUS OF PLAN**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Officers and employees of the Company perform certain administrative functions for the Plan for which they receive no compensation from the Plan. The Plan holds a fully benefit-responsive guaranteed investment contract with Transamerica. These transactions and the Plan's payment of administrative fees, record keeping fees, and investment management fees to Reliance Trust Company and Transamerica qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. EFinancial Alliance, LLC received payment for investment advisory services from plan assets and is considered a party-in-interest. FuturePlan by Ascensus received payment for record keeping from plan assets and is considered a party-in-interest.
