December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following description of the Sunshine, Sachs & Associates Profit Sharing Plan (the Plan) provides only general information. Further detailed information regarding the plan can be found in the published plan document provided by the Plan.

1. General

The Plan is a defined contribution plan covering substantially all employees of SS KS, LLD d/b/a Sunshine, Sachs & Associates, Sunshine, Sachs Marketing, LLC, and Sunshine, Sachs West (collectively, the Sponsor). The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The management of the Sponsor is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the plan administrator. On December 17, 2024, the Plan assets have been transferred from Empower Trust Company to ADP Retirement Services.

2. Eligibility

Employees are eligible to participate when they attain age 21 and complete one month of service and may enter the plan beginning on the first day of the calendar month following meeting the eligibility requirements. These employees are also eligible for employer discretionary match, discretionary profit sharing and safe harbor contributions, when the Sponsor elects to provide them. In order to be eligible to receive Sponsor discretionary profit sharing contributions, employees must have attained age 21 and completed one year of service consisting of a minimum of 1,000 hours with entry dates of January 1 and July 1 following meeting all eligibility requirements.

3. Contributions

Employees may elect to contribute up to 100% of compensation, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Additionally, participants age 50 and older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the plan document. Participants direct the investment of all contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan is allowing roth elective deferrals.

The Sponsor may elect to make discretionary profit sharing contributions, discretionary matching contributions, or discretionary safe harbor contributions. The Sponsor makes 3% discretionary safe harbor contributions for all employees who are eligible to participate and were employed at the end of the Plan year. Discretionary safe harbor contributions for the year ended December 31, 2024 totaled \$682,031. The Sponsor did not elect to make profit sharing contributions or discretionary matching contributions for the year ended December 31, 2024. Sponsor contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

NOTE A – DESCRIPTION OF THE PLAN – Continued

4. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Vesting

Participants are immediately vested in their voluntary contributions and earnings thereon as well as Sponsor safe harbor contributions. Vesting in the Sponsor's discretionary profit sharing plan contributions and discretionary matching contributions is based on years of continuous service, as follows:

6. Notes Receivable from Participants

Participant loans are not permitted.

7. Payment of Benefits

On termination of service resulting from death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period selected by the participant. Participants become fully vested if actively employed upon death, disability or retirement. The Plan also allows in-service withdrawals for those participants age 59 ½ or older.

8. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$53,601 and \$22,928, respectively. These accounts will be used to reduce future Sponsor contributions. During the year ended December 31, 2024, \$-0- of forfeitures was used to reduce Sponsor contributions.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE B – SUMMARY OF ACCOUNTING POLICIES – Continued

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Contributions

Contributions from plan participants and the safe harbor contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

5. Payment of Benefits

Benefits are recorded when paid.

6. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

7. Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN AND TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, the Plan's custodian as of December 31, 2023 and for the period January 1, 2024 through December 17, 2024 and by Reliance Trust Company, the Plan's trustee as of December 31, 2024 and for the period December 18, 2024 through December 31, 2024.

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were mutual funds managed by Empower Life and Annuity Insurance Company of NY (Empower) up until the investments were transferred to ADP Inc. (ADP) as of December 18, 2024. Empower and ADP provide the recordkeeping services for the Plan and, therefore, transactions between the Plan and Empower qualify as party-in-interest transactions. UBS Financial Services (UBS) provides investment advisory services to the Plan and, therefore, transactions between the Plan and UBS qualify as party-in-interest transactions. Administrative fees paid to UBS totaled \$49,162 and to Empower totaled \$47,619 for the year ended December 31, 2024. The Plan Sponsor paid directly any other fees related to the Plan's operations.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contributions.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H – INCOME TAX STATUS

The Plan as adopted is a non-standardized pre-approved profit sharing plan sponsored by Arnold Warshachik (Arnold). The IRS issued an opinion letter to Arnold dated June 30, 2020 stating that its non-standardized pre-approved profit sharing plan document was designed in accordance with IRC requirements as of that date. Although the Sponsor has not applied for an opinion letter for the Plan and although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
