Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Green Dot Corporation 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Green Dot Corporation 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Responsibilities of Management for the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 – Plan Description and Related Information

The following description of the Green Dot Corporation 401(k) Retirement Savings Plan (the Plan) provides general information about the Plan's provisions. Green Dot Corporation (the Company) is the plan sponsor. Participants should refer to the Plan Document and summary plan description for a more complete description of the Plan's provisions, copies of which only may be obtained from the plan sponsor.

General – The Plan is a defined-contribution plan sponsored by the Company covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC). The 401(k) Committee of the Company is responsible for the general administration of the Plan.

Trustee and recordkeeper – Fidelity Management Trust Company (Fidelity) serves as the trustee and Fidelity Workplace Services LLC serves as the recordkeeper as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Eligibility – Employees of the Company are eligible to participate in the Plan and are eligible to receive Company-matching contributions upon reaching age 21.

Contributions

Participant contributions – Each pay period, the Plan allows an eligible employee (a participant) to make pre-tax contributions of eligible compensation to the Plan through payroll deductions, subject to certain limitations as defined in the Plan. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows for after-tax contributions (Roth). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated fund until elected otherwise by the participant.

Employer-matching contributions – The Company may make discretionary matching employer contributions on behalf of each eligible participant. For the plan year ended December 31, 2024, the Company matched 50% of participant's contributions up to 5% of eligible compensation.

Contributions are subject to regulatory limitations.

Participant accounts – Participant accounts are credited with the participant's pre-tax, after-tax, and rollover contributions, employer contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting – Participants are vested immediately in their contributions and employer contributions plus actual earnings thereon.

Investments – Participants direct the investment of their contributions and employer contributions in multiples of 1% to any of the investment options offered by the Plan. Participants may change their deferral percentage or investment elections at any time.

Notes receivable from participants – Participant loans are available under the Plan. The maximum amount of any loan, when added to the balance outstanding on all other loans to the participant, may not exceed the lesser of (1) \$50,000, less the participant's highest outstanding loan balance in the preceding 12 months, or (2) 50% of the participant's total account balance in the Plan. Participant loans are generally payable over one to five years, unless such loans are used for the purchase of a primary residence under the Plan. The minimum loan is \$1,000. The loan interest rate is the prime lending rate established by the Federal Reserve on the business day preceding the issuance of the loan plus 1%. The interest rates for notes receivable from participants at December 31, 2024, ranged from 4.25% to 9.50% with various maturities through March 2044.

Forfeitures – Forfeitures are retained in the Plan and can be used to pay plan administrative expenses or reduce future Plan contributions. For the year ended December 31, 2024, forfeitures of approximately \$4,000 were used to reduce employer matching contributions. No forfeitures were used to pay plan expenses during the year ended December 31, 2024.

Benefit payments – Upon disability, death, retirement, or termination, participants or their beneficiaries are eligible to receive a distribution of the full value of their accounts. Participants may elect to receive their account balance as a lump-sum amount or as installment payments. Distributions from all funds are made in cash. If the participant's balance is less than \$1,000, the participant may receive an immediate lump-sum distribution.

Administrative expenses – Trustee, recordkeeping, and certain investment management fees are netted against investment returns for each participant. Loan establishment and maintenance fees are paid directly by the Plan through participant accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual basis of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Risks and uncertainties – The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the financial statements.

Investment valuation – Investments are reported at fair value. The Plan’s trustee, Fidelity, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. Refer to Note 3 for additional information.

Income recognition – Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are allocated based upon participant account holdings on the record date and are recorded on the dividend payment date. Net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and money market funds – These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund – The Plan invests in the Wells Fargo Stable Value Fund Class C, which is a collective trust fund (CT). Units held in the CT are valued using the NAV practical expedient of the CT as reported by the CT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. There are no redemption restrictions nor unfunded commitments as of December 31, 2024.

Note 4 – Exempt Party-in-Interest Transactions

The Plan holds certain investments managed by Fidelity and its affiliates. Fidelity is the custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Note 5 – Tax Status

The Plan Document is a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax exempt. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC. As a result, no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

Note 6 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Notes to Financial Statements

Note 1 – Plan Description and Related Information

The following description of the Green Dot Corporation 401(k) Retirement Savings Plan (the Plan) provides general information about the Plan's provisions. Green Dot Corporation (the Company) is the plan sponsor. Participants should refer to the Plan Document and summary plan description for a more complete description of the Plan's provisions, copies of which only may be obtained from the plan sponsor.

General – The Plan is a defined-contribution plan sponsored by the Company covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC). The 401(k) Committee of the Company is responsible for the general administration of the Plan.

Trustee and recordkeeper – Fidelity Management Trust Company (Fidelity) serves as the trustee and Fidelity Workplace Services LLC serves as the recordkeeper as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Eligibility – Employees of the Company are eligible to participate in the Plan and are eligible to receive Company-matching contributions upon reaching age 21.

Contributions

Participant contributions – Each pay period, the Plan allows an eligible employee (a participant) to make pre-tax contributions of eligible compensation to the Plan through payroll deductions, subject to certain limitations as defined in the Plan. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows for after-tax contributions (Roth). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated fund until elected otherwise by the participant.

Employer-matching contributions – The Company may make discretionary matching employer contributions on behalf of each eligible participant. For the plan year ended December 31, 2024, the Company matched 50% of participant's contributions up to 5% of eligible compensation.

Contributions are subject to regulatory limitations.

Participant accounts – Participant accounts are credited with the participant's pre-tax, after-tax, and rollover contributions, employer contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting – Participants are vested immediately in their contributions and employer contributions plus actual earnings thereon.

Investments – Participants direct the investment of their contributions and employer contributions in multiples of 1% to any of the investment options offered by the Plan. Participants may change their deferral percentage or investment elections at any time.

Notes receivable from participants – Participant loans are available under the Plan. The maximum amount of any loan, when added to the balance outstanding on all other loans to the participant, may not exceed the lesser of (1) \$50,000, less the participant's highest outstanding loan balance in the preceding 12 months, or (2) 50% of the participant's total account balance in the Plan. Participant loans are generally payable over one to five years, unless such loans are used for the purchase of a primary residence under the Plan. The minimum loan is \$1,000. The loan interest rate is the prime lending rate established by the Federal Reserve on the business day preceding the issuance of the loan plus 1%. The interest rates for notes receivable from participants at December 31, 2024, ranged from 4.25% to 9.50% with various maturities through March 2044.

Forfeitures – Forfeitures are retained in the Plan and can be used to pay plan administrative expenses or reduce future Plan contributions. For the year ended December 31, 2024, forfeitures of approximately \$4,000 were used to reduce employer matching contributions. No forfeitures were used to pay plan expenses during the year ended December 31, 2024.

Benefit payments – Upon disability, death, retirement, or termination, participants or their beneficiaries are eligible to receive a distribution of the full value of their accounts. Participants may elect to receive their account balance as a lump-sum amount or as installment payments. Distributions from all funds are made in cash. If the participant's balance is less than \$1,000, the participant may receive an immediate lump-sum distribution.

Administrative expenses – Trustee, recordkeeping, and certain investment management fees are netted against investment returns for each participant. Loan establishment and maintenance fees are paid directly by the Plan through participant accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual basis of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Risks and uncertainties – The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the financial statements.

Investment valuation – Investments are reported at fair value. The Plan’s trustee, Fidelity, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. Refer to Note 3 for additional information.

Income recognition – Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are allocated based upon participant account holdings on the record date and are recorded on the dividend payment date. Net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and money market funds – These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund – The Plan invests in the Wells Fargo Stable Value Fund Class C, which is a collective trust fund (CT). Units held in the CT are valued using the NAV practical expedient of the CT as reported by the CT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. There are no redemption restrictions nor unfunded commitments as of December 31, 2024.

Note 4 – Exempt Party-in-Interest Transactions

The Plan holds certain investments managed by Fidelity and its affiliates. Fidelity is the custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Note 5 – Tax Status

The Plan Document is a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax exempt. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC. As a result, no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

Note 6 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
