Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Distribution Alternatives Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan:

The following description of the Distribution Alternatives Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The original Plan was established on January 1, 1988. The Plan is a defined contribution plan covering all full-time employees of Distribution Alternatives, Inc., who are age 21 or older and have completed three consecutive months with at least 384 hours of service. If an employee does not complete the stated hours of service during the time period, the employee is subject to the one year of service with 1,000 hours requirement. The Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and includes salary deferral contributions permitted under Section 401(k) of the Internal Revenue Code (IRC).

The Plan was amended effective January 1, 2024 to cover part-time and seasonal employees and change the service requirement to 3 months of elapsed time.

In 2020, the United States passed the Coronavirus Aid, Relief, and Economic Security Act, (the CARES Act) which provided retirement plans the option to allow COVID-19 related distributions, increase loan amounts and waive 2020 required minimum distribution. In 2020, the Plan chose to adopt these CARES Act provisions without amendment. The Plan has until December 31, 2025 to reflect this in a plan amendment.

Contributions:

The Plan permits employees to voluntarily defer 1% to 50% of their pay as a pre-tax or Roth after-tax employee contribution up to the maximum prescribed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The employer, at its discretion, may make contributions to the Plan on behalf of all eligible employees. The employer's contributions are based on 30% of the amount contributed by the employees up to 6% of their eligible compensation for the years ended December 31, 2024 and 2023.

Additionally, the employer, at its discretion, may make profit sharing contributions to the Plan on behalf of all eligible employees who have worked 1,000 hours and are employed on the last day of the Plan year. No profit sharing contributions were made in 2024 and 2023.

Once an employee is eligible, 3% of the employees' compensation is automatically withheld and contributed to the Plan unless they decline to participate.

Participant accounts:

Each participant's account is credited with the participant's contribution and an allocation of both the employer's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued):

Vesting:

Employee and employer contributions plus actual earnings thereon are always 100% vested to the participant.

Normal retirement:

Normal retirement is at age 65, at which time the participant will be entitled to receive 100% of the amount in their account.

Death and disability benefits:

A participant's beneficiary is entitled to 100% of the amount in the participant's account in the event of the participant's death. In case of disability, the participant would receive the benefit.

Notes receivable from participants:

Loans to participants are permitted at the discretion of the Plan Administrator. Participants may borrow from a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The maximum number of Plan loans that participants may have outstanding is one. Loans are secured by the balance in the participant's account. The interest rate for participant loans is prime plus 1% and at December 31, 2024 and 2023 the interest rate was 8.50% and 9.50% respectively, with terms not to exceed 5 years unless the purpose is to acquire a principal residence in which case the term cannot exceed 30 years. Actual rates for outstanding loans range from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through weekly payroll deductions.

2. Summary of significant accounting policies:

Investment valuation and income recognition:

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are automatically reinvested into the mutual fund from which they were distributed and recorded on the ex-dividend date.

The change in net unrealized appreciation of investments held from the beginning of the Plan year to the end of the Plan year is included with realized gains/losses as net investment income reported in the accompanying statement of changes in net assets available for benefits.

Administrative fees:

Fees for the Plan's administration may be charged to the Plan unless paid for by the employer. In 2024 and 2023, plan administrative fees were paid by the employer, except for \$12,006 and \$13,273, respectively of loan and distribution fees paid by the Plan.

2. Summary of significant accounting policies (continued):

Administrative fees (continued):

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan has entered into a revenue sharing agreement with their investment advisor. The amount of revenue earned by the Plan was netted with administrative expenses and was \$3,415 and \$4,923 for the years ended December 31, 2024 and 2023, respectively.

Use of estimates and basis of accounting:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Reclassifications:

Certain reclassifications have been made to the 2023 financial statements for them to be in conformity with the 2024 presentation.

Notes receivable from participants:

Participant loans are classified as notes receivable from participants, which are segregated from plan investments.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If participants fail to make payments when they are due under the terms of the loan, the loan is considered to be in default. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of benefits:

Benefits are recorded when paid.

Concentrations:

At December 31, 2024 and 2023, approximately 53% and 57%, respectively, of investments were held in two funds.

Subsequent events:

Plan management has evaluated for subsequent events through October 15, 2025 the date the financial statements were available for issuance.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of further fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully benefit-responsive investment, at contract value:

The Plan holds a synthetic investment contract. The contract meets the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. Synthetic investment contracts are designed to accrue interest based on crediting rates established by the contract issuer.

The synthetic investment contract held by the Plan includes a wrapper contract that provides a guarantee that the credit rate will not fall below 0 percent. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in the contract that adjust the renewal crediting rate to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed monthly for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligations under the contract, (2) a material misrepresentation or (3) a material amendment to the agreement without the consent of the issuer.

6. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax status:

Effective May 1, 2022, the Plan document was restated for regulatory changes. The Plan document provider obtained its opinion letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Effective January 1, 2024, the Plan document was amended to include part-time and seasonal employees and change the service requirement to 3 months of elapsed time.

Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan used by the Company is designed and is currently operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Plan management evaluated the Plan's tax positions and concluded the Plan had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Parties-in-interest:

As described in Notes 2 and 3, the Plan utilizes service providers. Such parties are parties-in-interest under ERISA.

9. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
