### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Grade A Market, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Notes to Financial Statements

#### Note 1. Plan Description

The following description of the Grade A Market, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plans' provisions.

**General:** The Plan is a defined contribution plan established to provide retirement benefits for substantially all employees of Grade A Market, Inc. (the Sponsor). Bristol Supermarket LLC joined the Plan on January 1, 2023, making it a multiple employer plan until August 1, 2023, when the Third-Party Administrator changed from John Hancock to ADP and Bristol Supermarket LLC formed their own plan. The Plan Administrator is responsible for the operations of the Plan in accordance with prevailing regulations. John Hancock Life Insurance Company (U.S.A.) served as the Trustee to the Plan for the period of January 1, 2023, through July 31, 2023. Reliance Trust (the Trustee) served as trustee to the Plan for the period of August 1, 2023 through December 31, 2023 and for the year ended December 31, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and appropriate provisions of the Internal Revenue Code (IRC) and other applicable regulations.

**Eligibility:** Employees who completed six months of service (500 hours within the six-month period) and have attained 21 years of age are eligible to participate in the Plan. Enrollment dates are April 1 or October 1, coinciding with or next following the date such employee meets the eligibility requirement.

**Contributions:** Participants may contribute from 1% to 15% of their pretax annual compensation, subject to the Internal Revenue Service (IRS) limitation of \$22,500. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan Sponsor makes matching contributions equal to 100% of the participant's elective deferrals up to 1% of eligible compensation (matching contributions), plus 50% of the participant's elective deferrals greater than 1% of eligible compensation, but not more than 6% of eligible compensation (Safe Harbor Matching Contributions). Annually, the Plan Sponsor may also contribute a profit-sharing contribution (the Sponsor's Profit-Sharing Contributions), at the option of the Sponsor's board of directors. Contributions are subject to IRS limitations.

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Sponsor's matching contribution and an allocation of the Sponsor's discretionary contribution, if any. Plan earnings are allocated based on participant account balances and the ratio each participant's compensation bears to the total compensation of all participants, as defined in the Plan.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Principal and interest are paid ratably through monthly payroll deductions.

**Participants' investment options:** Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via direct phone or internet access to the Trustee.

**Payments of benefits:** In-service withdrawals are permitted in the case of demonstrated financial hardship or after obtaining the age of 59½. Upon termination of service, a participant may elect to receive a lump-sum payment based on the fair value of his or her account as of the valuation date immediately preceding the date of the payment, or an annuity.

**Administrative expenses:** The Plan's administrative expenses are paid by the Sponsor as provided by the Plan document, with the exception of certain minor loan processing fees, which are charged to participants with outstanding loan balances.

**Forfeitures:** Forfeitures may be used to pay administrative expenses under the Plan, or be used to reduce employer contributions. Forfeited non-vested accounts totaled \$59,234 and \$44,015 at December 31, 2024 and 2023, respectively. Total forfeitures amounted to \$68,963, during the year ended December 31, 2024. Forfeitures used to reduce employer contributions and to pay plan expenses totaled \$53,745, during the year ended December 31, 2024.

**Termination of the plan:** The Plan Sponsor may terminate, amend, modify or suspend the Plan in whole or in part, at any time. No such change is currently being contemplated; however, in such event, the participants will become 100% vested in their accounts.

#### Note 1. Plan Description (Continued)

**Income taxes:** Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision for income taxes has been included in the financial statements.

#### Note 2. Accounting Policies

The Plan's significant accounting policies are as follows:

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Notes 3 and 4 for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Payment of benefits:** Benefits to participants are recorded when paid.

**Risk and uncertainties:** The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the plan document.

**Contributions:** Employee contributions and the matching contributions from the Sponsor are recorded in the period during which the Plan Sponsor makes payroll deductions from participants' earnings. Plan Sponsor discretionary contributions are recorded as approved by the Sponsor.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this guidance are described below:

**Level 1:** Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies:** Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end. Shares of registered investment companies held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
