## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor and Plan Participants

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed audits of the financial statements of Tennessee Wesleyan University Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP);
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplementary Schedule Required by ERISA***

The supplementary schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary schedule, we evaluated whether the supplementary schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplementary schedule, other than the information in the supplementary schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplementary schedule agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Tennessee Wesleyan University Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

Effective January 1, 1945, Tennessee Wesleyan University established the Tennessee Wesleyan University Defined Contribution Plan. The amended and restated provisions of the Plan became effective on July 1, 2013. On July 1, 2016, Tennessee Wesleyan College changed its name to Tennessee Wesleyan University and is referred to as the University throughout the notes in the financial statements. The Plan has not been amended to restate the Plan name which corresponds with the name of the University.

The Plan is a 403(b) plan covering all eligible employees of the University on their date of hire. There are no special age or service requirements to enter the Plan. They are subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). However, the participants cannot participate in employer contributions until they reach age 21 and complete two years of service. In 2024, the Plan was amended in which employees can participate once they reach age 21 and complete one year of service.

#### **Contributions**

Each year, participants may make an elective deferral of up to a dollar amount set by law of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other plans and certain IRAs into the defined contribution plan (rollover contributions). For every participant meeting age and service requirements, the University makes a minimum non-elective contribution of 5%, even for participants electing a zero percent deferral. A non-elective contribution is unrelated to elective deferrals and may be made anytime at the University's discretion.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions, and allocations of (a) the University's contribution, if applicable, and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon as well as the employer's discretionary match.

**Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions in any of the available investment options through The Trust Company of Tennessee Mutual Funds. The Plan's investment options are managed by The Trust Company of Tennessee, the trustees of the Plan.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant (or his or her beneficiaries) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly, quarterly, semiannual or annual installments over a period not to exceed the participant's (or beneficiaries') life expectancy or joint survivor annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In 2024, the Plan was amended to allow hardship withdrawals.

**Forfeited Accounts**

As of December 31, 2024 and 2023, the Plan did not have any forfeited nonvested accounts. Forfeitures are allocated to pay employer contributions and administrative expenses.

**Administrative Expenses**

The Plan permits the payment of the plan expenses to be made from the plan assets. If the University does not pay these expenses, then the expenses paid using the Plan's assets will be allocated among the participant accounts. For 2024, the plan assets paid \$15,212 of administrative expenses related to the operation of the Plan.

**Plan Termination**

Although it has not expressed any intent to do so, the University has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, plan assets must be used for the exclusive benefit of participants.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared using the accrual method of accounting based on accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Basis of Accounting and Use of Estimates (Continued)**

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Investment contracts held by a defined contribution plan are reported at contract value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The insurance company general account determines its fair value using the net asset value (NAV) of the fund. The NAV is determined by the trustee of the fund using the fair value of the underlying securities within the fund at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 – INFORMATION CERTIFIED BY TRUSTEES (UNAUDITED)**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. **NOTE 4 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.
- Level 2 consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 consists of significant unobservable inputs for the asset or liability and has the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

The TIAA Traditional Annuity and VALIC Fixed Account Plus are reported at contract value. The contract value of these annuities equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any.

The TIAA Traditional Annuity and VALIC Fixed Account Plus are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. While transactions involving the purchases/sales of individual contracts are not observable in a public marketplace, contract value may provide a good approximation of fair value.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by TIAA-CREF, VALIC, and The Trust Company of Tennessee, Inc. TIAA-CREF, VALIC, and The Trust Company of Tennessee, Inc. are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Some of the fees paid to parties-in-interest are netted against investment returns.

**NOTE 6 – TAX STATUS**

The Plan is established as a tax-exempt plan under section 403(b) of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

During 2013, the Internal Revenue Service (IRS) issued Revenue Procedure 2013-22, which established a determination letter program for prototype plan documents and for volume submitters of plan documents for 403(b) plans. The Plan utilized a plan document from its trustee, which will qualify under this revenue procedure. The plan administrator has received a determination letter under the provisions of this revenue procedure by TIAA-CREF and VALIC stating that the Plan is properly designed in accordance with IRS rules which was dated August 7, 2017. The plan administrator has also received a determination letter from CCH Incorporated dba FT Williams.com in accordance with IRS rules which was dated March 31, 2017.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of the FASB ASC Topic 740, *Income Taxes*.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

**NOTE 7 – ANNUITY CONTRACT WITH INSURANCE COMPANY**

TIAA-CREF and VALIC maintain the contributions of the TIAA Traditional Annuity and the VALIC Fixed Account Plus, both fixed annuity contracts that are fully and unconditionally guaranteed by TIAA and VALIC. The accounts are credited with earnings on the underlying investments and are charged for participant withdrawals, transfers, and certain administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by TIAA-CREF and VALIC. Contract value represents the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

TIAA Traditional Annuity and VALIC Fixed Account Plus are fixed dollar annuities, investment products offered by TIAA and VALIC, which are insurance companies. Contributions to the annuities purchase a contractual or guaranteed amount of future benefits for the participant. Investments in the TIAA Traditional Annuity and VALIC Fixed Account Plus are secured by the general assets of TIAA and VALIC and backed by TIAA and VALIC's claims-paying ability. Liquidity restrictions apply to the TIAA Traditional and VALIC Fixed Account Plus under annuity contracts used to fund primary retirement plans such that transfers and distributions must be made over a period of ten annual installments. A plan's allocation in the TIAA Traditional Annuity and VALIC Fixed Account Plus are carried at contract value in all plan and participant reporting, which approximates fair value.

Certain events limit the Plan's ability to transact at contract value with TIAA-CREF and VALIC. Such events include the following: (a) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, as amended. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

**NOTE 8 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS**

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$7,333,619. There were no amounts that had been requested to be paid to the participants but were not paid until subsequent to the Plan's year end.

**NOTE 9 – SUBSEQUENT EVENTS**

The plan administrator has evaluated events and transactions subsequent to December 31, 2024 through October 9, 2025 (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The plan administrator has not identified any items requiring recognition or disclosure in the financial statements outside of what is disclosed below.
