### Independent Auditor's Report

To the Administrative Committee of

#### ***Opinion***

We have audited the accompanying financial statements of the KCI Holding USA, Inc. Employee Health Care Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of KCI Holding USA, Inc. **NOTE A - DESCRIPTION OF PLAN**

The following description of the KCI Holding USA, Inc. Employee Health Care Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a group health plan that includes a high deductible group health plan associated with a health savings account (HSA), dental, vision, group term life insurance, long-term disability, short-term disability, blanket accident and business travel insurance plan and, therefore, is considered a “welfare benefit plan” under ERISA. The Plan covers eligible employees of Konecranes, Inc., R&M Materials Handling, Inc., Konecranes Nuclear & Equipment Services, LLC, Morris Material Handling, Inc., and Demag Cranes & Components Corporation (collectively the Companies or Plan Sponsor). Employees and covered dependents who are classified as full time employees (employees who are regularly scheduled to work at least 30 hours per week) are eligible to participate in the Plan as well as their covered dependents.

Plan assets are held in a voluntary employees’ beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan allows participants to utilize Health Savings Accounts (HSA) in order to receive tax-favored contributions (from either the participant or employer). The contribution made to the HSA is used on a tax-free basis to pay or reimburse qualifying health expenses. It also may be used for future expenses or nonhealth purposes (on a taxable basis), or it can be withdrawn at age 65 as supplemental retirement income. HSAs are not a component of the Plan; accordingly, the associated activity has been excluded from the Plan’s financial statements.

**Benefits** - The plan provides health benefits (medical and prescription drugs) to eligible employees. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). During 2024 and 2023, COBRA receipts from terminated employees were not significant to the Plan.

**Insured Benefits** - The Plan is partially self-funded and partially insured. The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Companies purchase annual insurance contracts for these insured benefits. Premiums are paid to the insurance companies from the general assets of the Companies.

**Stop-Loss Coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Self-Insured Benefits** - Medical, prescription, and dental benefits are self-insured. The claims for these benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

**NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

**Contributions** - The Plan's benefits are funded through employer and participant contributions. Participants make contributions through periodic payroll deferrals for active employees. The Plan also receives contributions from terminated employees under COBRA for post-employment benefits. Contributions for active and COBRA participants are determined annually by the Plan Sponsor. The employer contributions are based upon the amounts necessary to provide benefits expected to become payable as well as to pay any premiums due under the Plan. In addition, contributions may be made in the amounts necessary to fund reasonable reserves with respect to those benefits.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Accounting Standards Codification as produced by the Financial Accounting Standards Board ("FASB") is the sole source of authoritative U.S. GAAP.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits** - Premiums paid by either the Companies or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statement of net assets available for benefits. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

**Stop Loss** - Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling approximately \$4,000 have been netted with claims paid in the accompanying statement of changes in net assets.

**Refunds** - Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling approximately \$4,062,000 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

**NOTE C - CLAIMS INCURRED BUT NOT REPORTED**

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's third-party claims processor in accordance with accepted principles based on the Plan's claims data trends. These amounts are paid by the Plan only if claims are submitted and approved for payment.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Plan follows authoritative guidance that establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Money market funds:* Valued at the NAV of shares held by the Plan at year end, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE F - PARTIES-IN-INTEREST TRANSACTIONS**

Fees paid for third-party administration services rendered by parties-in-interest totaled \$2,861,839 for the year ended December 31, 2024.

**NOTE G - TAX STATUS**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated December 14, 2021, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
