Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Lyden Oil Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees Lyden Oil Company (the "Plan Sponsor") as well as its wholly-owned subsidiary Petroleum Recovery Services, LLC. Additionally, the Plan covers the following affiliated entities: Green Labs LLC and Great Lakes Greenery LLC. Lyden Oil Company, Petroleum Recovery Services, LLC, Green Labs LLC and Great Lakes Greenery LLC are referred to herein as (the "Company"). Seasonal employees with fewer than 1,000 hours of annual service are specifically excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

The Plan provides for employee salary deferral pretax and after-tax Roth contributions up to a maximum of 100 percent of annual compensation (as defined in the Plan agreement), subject to maximum tax-deferred limitations established by the Internal Revenue Code ("IRC"). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Participants' deferral percentages are automatically increased 1% annually up to 10% of pre-tax compensation, unless they affirmatively elect out of this automatic increase.

The Plan provides for employer safe harbor matching contributions to a participant's account equal to 100% of each participant's elective deferrals, not to exceed 6% of the participant's eligible compensation.

If a participant reaches age 50 during the calendar year and is making the maximum Plan or IRS pre-tax contribution, they may make an additional "catch-up" contribution each period, up to the annual IRS dollar limit.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions and discretionary matching contributions, earnings based on the performance of the investment options selected by the participant, and an allocation of the Company's discretionary profit sharing contribution. Allocations are based on eligible participant compensation, as defined in the Plan agreement. Participants who initiate a loan or benefit payment are charged a fee for that transaction. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are fully vested in their account balances at all times.

Payment of Benefits

A participant or the participant's beneficiary is entitled to receive the value of his or her account upon termination, death, or disability. Payment may be received in a lump sum or in installments over a period not to exceed the participant's assumed life expectancy. A participant may withdraw all or any part of his or her account balance after having attained age 59½. The Plan also permits withdrawals of active participants' deferral contributions and rollover contributions only in amounts necessary to satisfy financial hardship, as defined by the plan agreement.

If a terminated participant's account balance is \$5,000 or less, a mandatory distribution will be made in a lump sum without the participant's consent.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Administrative Expenses

The Plan pays expenses incurred in the administration of the Plan, unless paid by the Company. Expenses paid to Voya Retirement Insurance and Annuity Company ("Voya") and Empower Retirement Services (collectively, the "Custodians") are accounted for as a reduction in investment earnings.

Plan Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, revenues are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred.

Valuation of Investments and Income Recognition

The Plan's investments in money market funds and pooled separate accounts are stated at fair value at December 31, 2024 and 2023. The Plan also has entered into a fully benefit-responsive contract which is valued at contract value. See Note 6.

Investment income consists of interest and dividend income. The net appreciation (depreciation) in the fair value of investments consists of realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported based on historical cost.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis method of accounting requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 4 – TAX STATUS

The Plan is a volume-submitter plan which has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service. The opinion letter states that the volume-submitter plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. Subsequently, the Plan has been amended. Plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore operates as tax exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Company uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets;
- Level 2 – Quoted prices for similar assets or liabilities in active markets, or other inputs that are observable for the asset or liability, either directly or indirectly for substantially the full term of the financial instrument; and

- Level 3 – Other unobservable inputs that are significant to the fair value measurement.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets measured at fair value are as follows:

Common collective trust funds and pooled separate accounts: valued using the net asset value ("NAV") of units held by the Plan at year-end, and are not assigned a level in the fair value hierarchy. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the account net of investment management fees. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

Mutual funds: Valued at fair value as determined by quoted market prices on active markets.

Money market funds: Valued at the closing price reported on the active market on which the individual funds are traded and at the accumulated unit value of shares (amortized cost) held by the Plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s investments in common collective trust funds and pooled separate accounts may be redeemed on a daily basis and require a redemption notice of one trade day. There are no unfunded commitments related to these common/collective trusts.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in a fully benefit-responsive guaranteed investment contract issued by the Custodian totaling \$3,564,649 and \$3,494,442 as of December 31, 2024 and 2023, respectively. The Custodian maintains the contributions in their general accounts and is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan (3% for the year ended December 31, 2024). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit responsive guaranteed investment contract. The fully benefit-responsive guaranteed investment contract is presented on the face of the Statement of Assets Available for Benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the Issuer. Such events include but may not be limited to: (1) amendments to the Plan documents (including partial Plan termination or merger with another plan; (2) changes to Plan’s prohibition on competing investment options or deletion of equity wash provisions; or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are probable of not occurring.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

The Custodian serves as the fund manager for a portion of the Plan assets. Additionally, administrative expenses are paid by the Plan to the Custodians. These transactions are considered party-in-interest transactions.
