## Independent Auditor's Report

To the Board of Trustees of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C)**

### **NOTE A - DESCRIPTION OF THE PLAN:**

Wallace Design Collective, PC (hereafter also referred to as “the Company”) sponsors the Wallace Design Collective, PC 401(K) Retirement Plan (hereafter referred to as “the Plan”) for the benefit of its employees. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution, 401(k) plan, covering employees of the Company who are at least twenty-one (21) years of age and have completed at least 30 days of service, as defined. Days of service need not be contiguous, but there can be no more than a one-year break in service. Plan entrance is available on a bi-weekly basis. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and for monitoring investment performance.

#### Contributions

Participants may contribute a percentage of compensation, up to the current pre-tax 401(k) contribution limits or after-tax Roth 401(k) contribution limits permissible under the IRC, as defined in the Plan agreement. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. All participant contributions are invested according to the allocations as determined by each individual Plan participant. Participants are allowed to stop their elective deferrals to the Plan and may change their elective deferral amounts on a bi-weekly basis.

The Company makes a safe harbor non-elective contribution of 3% of eligible compensation, as defined in the Plan document.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of Plan earnings including gains and losses on investments with an allocation of administrative expenses that are paid by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

#### Vesting

Participants are immediately 100% vested in their contributions and employer safe harbor non-elective contributions plus earnings or losses thereon.

#### Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their account balance. Participants may not have more than three (3) loans outstanding at any time. Notes receivable are secured by the balance in the participant’s account, evidenced by a promissory note. Notes receivable accrue interest at a reasonable rate that is based on the federal prime rate at the time the notes are issued. The interest rate for new notes receivable, determined annually, was set at 8.5%. Older, pre-existing notes receivable carry interest rates ranging from 3.25% to 8.5%. Repayment terms for notes receivable are five (5) years or less and thirty (30) years are subject to applicable federal and state income taxes, and penalties, if applicable, if they are not paid in full by the end of the quarter following the quarter in which the participant terminated employment.

### **NOTE A - DESCRIPTION OF THE PLAN – (Continued):**

#### Notes Receivable from Participants – (Continued)

Principal and interest are paid ratably through bi-weekly payroll deductions. Upon termination of employment, outstanding note balances are treated as distributions and Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

On termination of service due to death, disability, hardship or retirement, a participant may elect to receive a lump-sum distribution or periodic installments equal to the vested balance of his or her account, under the terms of the Plan. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. For participants who have reached the normal retirement age of sixty-five (65), in-service distributions are allowed. Participants who have reached age seventy-three (73), must take required minimum distributions (“RMD”) as required by the Internal Revenue Service.

#### Hardship Withdrawals

The Plan allows hardship withdrawals subject to account balance limits and applicable laws.

#### Forfeitures

On December 31, 2024, forfeited non-vested accounts totaled \$440. Forfeitures resulted from employer matching contribution payroll corrections that could not be refunded after they were credited to the Plan. Forfeitures are allocated to offset employer matching and profit-sharing contributions. Forfeitures of \$4,810 were allocated to employer matching deposits during the year ended December 31, 2024.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

#### Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan’s management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from the estimates that were used.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received in the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Board of Trustees determines the Plan’s valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid. At December 31, 2024, there were no employees who had terminated employment with the Company who had requested distributions from the Plan that had not yet been received.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements (see Note G). Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or (depreciation) in fair value of investments.

#### Date of Management's Review and Subsequent Events

Management of the Plan has evaluated subsequent events through October 14, 2025, the date that the financial statements were available for issuance, noting no events that required recognition or disclosure in the accompanying financial statements and footnotes.

### **NOTE C – CERTIFIED INVESTMENTS:**

At December 31, 2024 and 2023, the Plan's investments were held by the insurance company, by Empower Annuity Insurance Company of America ("Empower"). The Plan investments that are included in the accompanying financial statements are based on information certified by the insurance company as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,329,951.

### **NOTE D – FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*The Plan held investments in registered investment companies that were determined to be considered to be "Level 1" investments as of December 31, 2024 and 2023.*

#### Level 2

Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

*The Plan did not hold any “Level 3” investments as of December 31, 2024 and 2023.*

#### Explanation of the Fair Value Hierarchy

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### **NOTE E – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY:**

The Plan has a traditional fully benefit-responsive group annuity contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value in the amounts of \$513,752 and \$378,981 for the years ended December 31, 2024 and 2023, respectively.

Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **NOTE E – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY – (Continued):**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants or the issuer is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

Plan investments are mutual funds of various registered investment companies which are held in custody and/or managed by the Plan's custodian, Empower. Empower was the investment manager as defined by the Plan, therefore transactions involving investments managed by Empower qualify as party-in-interest transactions. Fees paid by the Empower Trust Company, totaling \$83,489, for investment management and contract administration services for the year ended December 31, 2024.

### **NOTE G – EMPLOYER ABSORBED COSTS:**

The Company pays for certain administrative expenses of the Plan, such as professional fees. During the year ended December 31, 2024, the Company paid administrative expenses of the Plan in the amount of \$14,319 for audit fees and \$1,696 for other administrative expenses.

### **NOTE H - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### **NOTE I – INCOME TAX STATUS:**

The Internal Revenue Service has determined and informed the Company by a letter dated August 7, 2001, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan was restated, effective January 1, 2023, to bring the Plan into compliance with legislative and regulatory changes. The Plan administrator and the Plan's tax counsel did not believe that it was necessary to request a new determination letter as the Plan is a "Volume Submitter" plan which is pre-approved by the Internal Revenue Service and therefore the Plan is in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the Internal Revenue Service. Management of the Plan does not believe they have any uncertain tax positions as of December 31, 2024.

### **NOTE J - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying "Statements of Net Assets Available for Benefits."

### **NOTE L – CORRECTIVE CONTRIBUTIONS:**

During the performance of our audit procedures, management identified that the incorrect definition of eligible compensation had been used in calculating employer safe harbor contributions. As a result, eligible participants did not receive the full contribution to which they were entitled under the plan provisions.

Management has determined that corrective contributions totaling \$19,612 are due to be remitted to affected participant accounts.

The noted amount relates solely to the correction of employer safe harbor contributions and does not represent a late remittance of employer deferrals or loan payments.
