Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fluid Components International LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (liquidation basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects,

the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all

material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Matter - Plan Termination

As further discussed in Note 4 to the financial statements, the Company elected to terminate the Plan in 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the ongoing basis to the liquidation basis. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF THE PLAN

Fluid Components International LLC 401(k) Profit Sharing Plan (the "Plan") is a defined contribution plan established on January 1, 1970 to provide tax-deferred savings opportunities to eligible employees, as defined in the Plan, of Fluid Components International LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Eligibility

The Plan covers all eligible employees of the Company, except leased employees, union members and nonresident aliens not receiving U.S. source income.

Employees are eligible to participate in the Plan after completing two months of service. Participants may join the Plan on the first day of the month coinciding with or next following date upon meeting the eligibility requirement.

Plan participants become eligible for Company matching and discretionary contributions and forfeitures after completing one year of service, during which they have worked at least 1,000 hours.

B. Benefits

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee, whichever applies. Normal retirement age is the later of turning age 65 or the 5th anniversary of the first day of the Plan year during which the participant entered the Plan. Early retirement and hardship withdrawals are permitted, as are in-service distributions if the participant is 59½ or older and has completed at least six years of service. In addition, participants may take a distribution of all or a portion of the amounts they have transferred into and rolled over from other plans to this Plan.

Participants may elect to receive a lump-sum amount equal to the value of the vested portion of their account, or the value of their account may be distributed to them using another method approved by the Administrative Committee.

C. Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, safe harbor matching contributions, and earnings thereon. Company discretionary contributions and related earnings made on or after January 1, 2007 vest 100% upon the completion of three years of vesting service, whereas contributions made prior to January 1, 2007 are subject to the vesting schedule that existed prior to that date.

Participants became fully vested upon termination of the Plan (Note 4).

D. Contributions

Participants may contribute to the Plan through tax-deferred salary reductions, which are an elected percentage up to 100% of the participant's compensation, as defined in the Plan, up to the statutory annual maximum as determined by the Internal Revenue Code (the "Code"). Participants may commence their contributions or change the amount of their contributions on the day they become a participant or, with 15 days notice, at anytime thereafter.

The Company's matching contribution is a safe harbor contribution of 100% of employee deferrals that do not exceed 3% of the employee's compensation, plus 50% of employee deferrals that exceed 3% but do not exceed 5% of compensation. In 2024, the Company matching contributions totaled \$500,501.

In addition, the Company, at the discretion of its stockholders, may contribute additional amounts, up to 10% of compensation, out of its net profits and/or accumulated profits. The contribution is allocated to participants based on their proportional compensation. There were no Company discretionary contributions made in 2024.

There are no service requirements to receive Company matching contributions, except for a one-year waiting period for new employees during which the employee must work at least 1,000 hours. For discretionary Company contributions, a participant will not vest until the completion of three years of service during which the employee must work at least 1,000 hours during each year of service.

E. Participant Accounts

Each participant's account is credited with his or her contributions, rollovers and an allocation of the following: (a) Company matching contributions, (b) Company discretionary contributions, if any, (c) plan earnings (investment income and the net appreciation of investments) and (d) forfeitures of terminated participants' nonvested accounts, if any. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the vested benefit that can be provided from his or her account.

F. Notes Receivable from Participants

The Plan permits participants to borrow from their accounts. Loans may not exceed the lesser of 50% of a participant's vested account balance or \$50,000, reduced by the highest outstanding loan balance of the participant from the Plan during the one-year period ending on the day before the date on which the loan was made. Loans bear interest at a fixed rate based on the prime rate at the date of the loan, plus 1%. Loans for active participants are repaid through payroll withholdings, generally over five years, although participants may select a shorter term. The Plan provides for longer maturities if the loan is used to acquire the principal residence of the participant. The number of loans per participant is limited to three. Effective April 1, 2019, a participant may have no more than one loan outstanding at a time, unless one loan is a principal residence loan with a term of greater than five years or the participant had more than one loan outstanding as of April 1, 2019.

G. Forfeitures

When a participant terminates employment for reasons other than retirement, disability, or death, the nonvested portion of his or her Company contributions will be forfeited and allocated to remaining participants based upon their proportional compensation. There were no unused forfeited balances as of December 31, 2024 and 2023.

H. Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. All accounting services and administrative fees of the Plan are paid by the Plan.

I. Investments

The participants select how their share of Plan assets will be invested among those investment vehicles made available.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

Effective November 19, 2024, the Company approved the termination of the Plan. The financial statements of the Plan are presented on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America, as liquidation is considered imminent.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (liquidation basis) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term could materially affect the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

D. Payments of Benefits

Benefits are recorded when paid.

NOTE 3 - INCOME TAX STATUS

The Plan adopted a prototype volume submitter profit sharing plan with cash or deferred arrangement that received tax exempt status from the Internal Revenue Service on June 30, 2020. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Effective November 19, 2024, the Plan was terminated due to an acquisition of the Company. All Plan assets were fully liquidated and distributed by July 2025.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 6 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy, Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at closing market prices. Self-directed brokerage accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. Capital gains are recorded as interest and dividends. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments relates to mutual funds.

NOTE 7 - PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the trustee or an affiliate of the trustee. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

NOTE 8 - STANDARD STABLE ASSET FUND

The Plan maintains a fully benefit-responsive group annuity contract with the Standard Insurance Company (SIC) through the Standard Stable Asset Fund (Guaranteed Account). Contributions to the Guaranteed Account are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. SIC is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Account is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The crediting rate is declared quarterly in advance by SIC and is based on the investments performance and expected market conditions. The average crediting rate as of December 31, 2024 and 2023 were 3.07% and 2.78%, respectively.

The Plan's ability to receive amounts due is dependent on SIC's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value, including premature termination of Plan's investments in the Guaranteed Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 9 - SUBSEQUENT EVENTS

As a result of the Plan's termination (Note 4), all Plan assets were liquidated and distributed as by July 25, 2025.

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. Except as noted above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
