## Independent Auditor's Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Marlborough Hospital Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

### December 31, 2024 and 2023

---

#### Note 1 – Description of Plan

The following brief description of the Marlborough Hospital Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement and any amendments thereto for a more complete description of the Plan's provisions.

#### General

The Plan includes a 403(b) contribution plan and a supplemental discretionary plan, both covering substantially all employees of Marlborough Hospital (the Employer). Employees are eligible to make contributions on the first day of service and are eligible to receive the Employer match and discretionary nonelective contributions immediately following 90 days of service. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, investment managers and custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Each year, eligible participants may contribute up to 100% of annual eligible compensation as defined in the Plan document, but not less than \$200 annually, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Participants that have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions". Participants may also contribute amounts representing rollover distributions from other qualified plans.

Employer matching contributions for union employees represented by Marlborough MNA and Marlborough SEIU is a fixed match of 50% of employee deferrals up to 5%, which occurs at each pay period. Employer matching contributions for all other employees, including SHARE union employees, is a fixed match of 25% of employee deferrals up to 5%. Matching contributions will not apply to the catch-up contributions. The Employer can make a discretionary nonelective contribution to the Plan for each plan year. The Employer's discretionary contribution is 1% of compensation for non-union and SHARE union employees and 2% of compensation for union employees, excluding SHARE union employees. In addition, active participants (union and nonunion) who are age 55 or older with 10 or more years of service on October 1, 2004, receive an additional Employer discretionary contribution of 2% of compensation between the ages of 55 and 59 and 3% of compensation between the ages of 60 and 64. This Plan provision does not apply to any currently eligible or active participants. All contributions are invested in the Plan based upon participant elections.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the allocations of (a) the Employer's contributions, (b) the Plan's earnings, and (c) the Plan's administrative expenses. Allocations are based on participant earnings, deferrals, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are 100% vested in the Employer's contribution portion of their accounts plus earnings after four years of credited service in accordance with the following schedule:

#### **Investments**

Participants direct the investment of the Employee and Employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund and a guaranteed investment contract (GIC).

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. Participant loans are secured by the balance in the participants' accounts and bear interest between the range of 4.25% and 9.50%, which is commensurate with local prevailing rates, as defined by the Plan administrator. Loans must be fully repaid within five years or within a reasonable amount of time for the purchase of a primary residence. Participants may only have one loan outstanding in any 12-month period. Principal and interest repayments are made directly by the participants.

#### **Payment of Benefits**

Benefits under the Plan are distributed to participants upon retirement, hardship, death, disability, or termination of employment in either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments, or a partial distribution. If, upon severance of employment, a participant's vested balance account is equal to \$5,000 or less, the Plan will make a mandatory lump-sum distribution.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$92,753 and \$63,564, respectively. These accounts will be used first to pay any administrative expenses of the Plan and then to reduce Employer matching contributions and Employer discretionary contributions. During 2024, forfeitures of \$2,613 was used to pay administrative expenses of the Plan and \$47,003 was used to reduce Employer contributions.

#### **Note 2 – Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value equals accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any) less any withdrawals and transfers out (if any). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Contributions**

Contributions from Plan participants and matching Employer contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective Employer contributions are recorded in the year in which the contributions are earned.

#### **Other Income**

Other income consists of revenue earned from revenue sharing in connection with plan services in excess of contractual compensation. These amounts must be used for payment of qualified plan expenses or allocation to eligible participants, as defined by the agreement.

Fidelity Management Trust Company (Fidelity) provides administrative services to the Plan pursuant to a Group Custodial Agreement (GCA) between the Employer and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the GCA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, there were excess amounts of \$100,827, which are included in other income on the statement of changes in net assets available for benefits. The Plan or Employer may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

#### **Note 3 – Certified Investments**

The Plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity, the custodian of the Plan.

#### Note 4 – Fair Value Measures

Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement that should be determined based on assumptions that market participant would use in pricing an asset or liability. Assets and liabilities reported at fair value are classified and disclosed in one of the following three categories:

Level 1 – Observable inputs such as quoted prices for identical assets and liabilities in active markets at the measurement date. The fair value hierarchy gives the highest priority to Level 1 inputs;

Level 2 – Valuations using observable inputs other than Level 1 prices such as quoted prices in active markets for similar assets and liabilities; quoted prices for identical or similar assets or liabilities in markets that are not active; broker or dealer quotations; or inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; and

Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The Plan categorizes, for disclosure purposes, assets and liabilities measured at fair value in the financial statements based upon whether the inputs used to determine their fair values are observable or unobservable. Observable inputs are inputs that are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumptions about pricing the asset or liability based on the best information available in the circumstances.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 5 – Investment Contract with Lincoln Financial Group Trust Company

During the year, the Plan maintained a fully benefit-responsive GIC with Lincoln Financial Group Trust Company through Fidelity. Fidelity maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and the minimum guaranteed interest rate is 1.00%. The guaranteed crediting interest rate is announced in advance and is guaranteed for a six-month period.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6 – Related Party Transactions and Party-In-Interest Transactions**

During the year, the Plan invested in shares of mutual funds, a money market fund and a GIC managed by Fidelity. Fidelity Workplace Services, LLC, a related party of Fidelity, was the recordkeeper, as defined by the Plan. Fidelity Technology Group, LLC, also a related party of Fidelity, provided the administrative platform and recordkeeping system. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. The Plan made a direct payment to Fidelity of \$34,458 which was not covered by revenue sharing. These transactions qualify as exempt party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions.

#### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Employer contributions.

#### **Note 8 – Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform to the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan has adopted the Fidelity Volume Submitter Plan Document determined qualified by the IRS in a letter dated August 7, 2017.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 10 – Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.
