Opinion

1. Plan Description

The following description of the Haver Analytics Employee Stock Ownership 401(k) Plan (the "Plan") is provided for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Haver Analytics, Inc. (the "Company" or the "Employer") formed the Plan effective January 1, 2017. The Plan operates as a leveraged Employee Stock Ownership Plan ("ESOP"), and is designed to comply with Section 4975(e)(7) and the regulations of the Internal Revenue Code ("IRC") regulations and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

On November 7, 2017, the Plan purchased 3,024,209 shares of the Company's common stock for \$1,360,894 (the "Stock Purchase"), a portion of which was financed by a loan from the Company to the Plan (see note 6).

The Plan consists of the employer stock account (the "ESOP Account") and the participant directed mutual funds, separate accounts and an insurance company general account (the "401(k) Accounts").

Principal Financial Group ("Principal") is the custodian and record-keeper of the ESOP and 401(k) Accounts.

Eligibility

An employee of the Company becomes an eligible participant in the Plan upon attainment of age 21 and completion of six months of service. Leased employees or employees covered by a collective bargaining agreement are not eligible to participate in the Plan.

Contributions

Each year participants may contribute up to the amount allowed by the IRC of pretax annual compensation, as defined in the Plan agreement. The Plan allows for discretionary matching contributions by the Company. For the year ended December 31, 2024, the Employer approved contributions to the Plan were \$262,383, of which \$240,919 were paid in 2025.

The Employer contributions in 2024 included a discretionary contribution of \$21,555, which will be used in 2025 to separate terminated participants from their investments in the Company's common stock.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution, (b) Plan earnings and (c) charges for certain account maintenance and service fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Voting Rights and Dividends

Principal shall vote all shares of Company common stock held by the Plan with respect to all corporate matters upon which Company shareholders are entitled or permitted to vote. Each participant in the Plan shall direct the Custodian as to voting of shares of the Company's common stock held in his or her account in the Plan. Dividends on the Company's common stock may be paid directly to participants at the discretion of the Plan administrator. There were no dividends declared on the Company's common stock for the year ended December 31, 2024.

Vesting

Participants are immediately and fully vested in their elective deferral account and qualified non-elective contribution account. A participant is also 100% vested in cash dividends that the participant elects to have reinvested in the Plan. For Employer contributions made into the Plan, vesting in the Company's discretionary matching contributions is based on years of continuous service. A participant vests at a rate of 25% per year starting after year one and is 100% vested after four years of credited service.

Forfeitures

Forfeitures are allocated to reduce Employer contributions to the Plan. The balance in the forfeiture account at December 31, 2024 and 2023 was \$14,195 and \$8,576, respectively. Forfeited non-vested accounts amounting to \$8,471 were used to reduce Employer contributions during the year ended December 31, 2024.

Investment Options

Upon enrollment in the Plan, participants may also direct their elective and Company contributions into the various investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may not borrow from their ESOP Account, however, participants may borrow from their 401(k) Accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years with the exception of loans for the purchase of a primary residence. The loans are secured by the balance in the participant's 401(k) account and bear interest at prime plus one percent per annum. Principal and interest are paid ratably through payroll deductions. Interest rates on such loans ranged from 5.75% to 9.5% at December 31, 2024 and from 4.25% to 9.5% at December 31, 2023.

Payment of Benefits

Distributions from a participant's ESOP Account will be made in a single lump sum payment or in equal installments over a period not to exceed five years, if the vested balance does not exceed \$1,130,000. If a participant's vested balance exceeds \$1,130,000, distributions will be paid in equal installments over a period not to exceed five years plus one year for each \$226,000 that the balance exceeds \$1,130,000.

A participant's account balance from their 401(k) Accounts will be distributed in a lump-sum payment upon termination, disability, retirement or death. However, any non-vested portion of the account balance is forfeited, except in the case of disability, death or retirement. In the event of such separation prior to age 59-1/2, the participant may elect to defer the distribution until the participant reaches age 59-1/2 or to an earlier date, provided that the participant's eligible distribution exceeds \$5,000. In all cases, an active participant's account must be distributed no later than April 1, of the year following the participant's reaching 70-1/2 years of age.

Hardship withdrawals are allowed under the Plan, and are generally defined as an immediate and heavy financial need for which funds are not reasonably available from other resources. Hardship situations are limited to purchase of a primary residence, certain tuition expenses, certain funeral expenses, deductible unreimbursed medical expenses and the need to prevent eviction from, or foreclosure of a mortgage on, a principal residence. The withdrawal cannot exceed the amount of the immediate need, including amounts necessary to pay any federal, state or local income taxes or penalties reasonably anticipated to result from the withdrawal. In accordance with Internal Revenue Service ("IRS") Regulations participants must first exhaust all other assets reasonably available to them prior to obtaining a hardship withdrawal. Contributions to the Plan are suspended for six months after receipt of a hardship withdrawal.

Put Option

The Company shall issue a put option to each participant who receives a distribution of Company common stock that is not readily tradable on an established market. The put option shall permit the participant to sell such Company common stock at its then fair value to the Company. The Company can pay for the purchase over a period of five years.

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make certain estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements, Investment Valuation and Income Recognition

The Plan follows U.S. GAAP guidance on fair value measurements which defines fair value and establishes a fair value hierarchy organized into three levels based on the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan’s investments in money market and mutual funds, were valued at fair value using Level 1 inputs and are based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value (“NAV”) and to transact at that price.

The Plan’s investments in separate accounts were valued at fair value using level 2 inputs. Separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts.

The Plan’s Principal Guaranteed Option Account and Principal Fixed Income Guaranteed Option are stated at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan’s investment in common stock of the Company were valued using Level 3 inputs based on a valuation performed by an independent appraiser.

For the foregoing valuation, the estimate of fair value is made at a point in time, based on relevant market data as well as the best information available about the investment. Fair value estimates for which no or limited observable market data is available are based on judgments regarding current economic conditions, liquidity discounts, credit and interest rate risks, loss experience and other factors. These estimates include significant uncertainty and judgments and cannot be determined with precision. As a result, such a calculation of fair value estimate may not be realizable on a current sale or immediate settlement of the investment. In addition, changes in the underlying assumptions used in the fair value measurement techniques including discount rates, liquidity risks and estimates of future cash flows, could significantly affect these fair value estimates.

Because of the inherent uncertainty of valuation of Level 3 input risks, the estimated fair value may differ from the value that would have been used had a ready market for these investments existed, and the differences could be material.

At December 31, 2024 and 2023, the cumulative appreciation of Level 3 investments amounted to \$5,534,302.

During the year ended December 31, 2024, there were no transfers into or out of any level of the fair value hierarchy.

In addition, the Plan invests in various other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Significant Concentrations

The Company maintains cash balances in financial institutions in excess of federally insured limits. The Company has not experienced losses on its deposits.

Deposits held at financial institutions insured by the Federal Deposit Insurance Corporation ("FDIC") are insured up to \$250,000. At times cash balances may exceed the FDIC limit. As of December 31, 2024, the Company's uninsured cash and restricted cash balances on deposit totaled approximately \$1.1 million.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date which the financial statements were available to be issued, which date is October 14, 2025.

3. Fully Benefit-Responsive Investment Contract

The Plan invests in two fully benefit-responsive investment contracts called the Principal Guaranteed Option Account and Principal Fixed Income Guaranteed Option Account (collectively, the "Funds"). The Funds maintain their contributions in insurance company general accounts. The Funds consists of guaranteed investment contracts, which are valued, based on the net asset value of the Fund as reported by the investment advisor. The Funds are recorded at contract value. Contract value is the relevant measurement attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Funds represented approximately 23% and 24% of the Plan's total net assets available for benefits at December 31, 2024 and 2023, respectively. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The principal and previously credited interest is guaranteed by Principal. This guarantee is subject to Principal's financial strength and claims paying ability.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of July 2024), Standard and Poor's (A+ as of April 2024), A.M. Best (A+ as of March 2024), and Fitch (AA- as of June 2024). The plan administrator does not believe that any events would limit the Plan's ability to transact at contract value.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter dated July 20, 2018 to the prototype plan document preparer, which states that the form of prototype plan qualified under the applicable provisions of the IRC.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. Plan years since 2021 are subject to examinations by the applicable taxing jurisdictions. There are currently no examinations in progress.

6. Note Payable

The Stock Purchase was partially financed by a loan from the Company to the Plan in the amount of \$340,224 (the “ESOP Loan”). The ESOP Loan accrues interest at the annual rate of 2.6% and requires annual principal and interest payments of \$21,555 payable on December 31 of each year. Future principal payments due on the ESOP Loan, through its maturity on December 31, 2037, are as follows:

The shares are pledged as collateral for the Plan’s debt to the Company. As the debt is repaid, shares are released from collateral and allocated to active employees based on the proportion of debt service paid in the year. As a result of the December 31, 2024 ESOP Loan payment made, 37,803 shares were committed to be released for allocation (the “Released Shares”). The estimated fair value of the Released Shares at December 31, 2024 was \$86,191 (\$2.28 per share).

In the event a terminated Plan participant desires to sell his or her shares of the Company’s stock, the Company may be required to purchase the shares from the participant at the fair value. At December 31, 2024 and 2023, 2,570,578 and 2,532,776 shares, respectively, of the Company’s common stock, with an aggregate fair value of approximately \$5,861,000 and \$5,775,000, respectively, were held by the Plan participants.

7. Party-In-Interest Transactions

Certain Plan investments are managed by the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

All transactions involving the Plan's investments in the Company's common stock qualify as exempt party-in-interest transactions under ERISA.

Certain employees, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

Participants who are active employees of the Plan may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
