

NOTE 1 DESCRIPTION OF PLAN

The following description of the Alkegen 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan is funded by employee and employer contributions and covers all eligible employees. The assets of the Plan are maintained in investment funds held by Fidelity Management Trust Company (Fidelity). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Board of Directors of Unifrax I LLC (the Company). The Benefits Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. All costs not absorbed by the Plan are paid by the Company as the Plan Sponsor.

Eligibility

Substantially all employees of the Company and other participating employers (except those subject to collective bargaining agreements which are not covered by this Plan) are eligible to make pre-tax and Roth contributions and receive matching and safe harbor nonelective contributions as soon as administratively feasible after their date of hire.

Contributions

Participants may contribute between 1% and 75% of their compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision for certain employees which eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. The current automatic deferral rate for newly eligible participants ranges from 4% to 6% depending on the participant's union and employee group. Contributions for employees who are automatically enrolled in the Plan are invested in a designated fund until changed by the participant. Employees who were automatically enrolled in the Plan will have their deferral rate increase annually, up to 10%, unless the participant elects otherwise.

The Company makes a safe harbor matching contribution on behalf of non-union participants in the amount equal to 100% of an employees' contributions up to 5% of eligible compensation.

Contributions (Continued)

The Company makes discretionary matching contributions on behalf of union employees in accordance with each respective collective bargaining agreement. Discretionary matching contributions range from 0% to 5% of eligible compensation. Participants covered by a collective bargaining agreement between the Company and Local USW 4-4058 whose initial date of hire was prior to February 1, 2021, are not eligible for discretionary matching contributions. Participants covered by a collective bargaining agreement between the Company and Local USW 4-2058 who: (1) has an initial date of hire prior to February 1, 2021; and (2) made an election to freeze the pension multiplier used to determine the participant's accrued benefit under the Unifrax Hourly Defined Benefit Pension Plan, effective October 1, 2021, are entitled to a discretionary matching employer contribution with respect to elective deferrals made during payroll periods beginning on or after October 1, 2021.

The Company makes safe harbor nonelective contributions equal to 3% of eligible compensation on behalf of Sebring OH Hourly Union employees. In addition, the Company may make a discretionary nonelective contribution to eligible participants based on their union contact.

All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income (loss), and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Investment Options

Participants may direct their contributions to a variety of funds held at Fidelity. These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants are vested immediately in their contributions, safe harbor matching and non-safe harbor union matching contributions, and safe harbor nonelective contributions plus actual earnings thereon. Other employer matching contributions became fully vested after three years of service, unless credited with prior service for particular classes of participants. Effective April 1, 2024, these other matching contributions now become 100% vested immediately with the exception of certain classes of participants whose vesting schedule ranges from zero to seven years, as defined in the Plan document.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to 15 years. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The loans currently bear interest ranging from 3.25% to 10.50%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

Benefit Payments

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or reaching normal retirement age, the participant may receive the value of the vested interest in his or her account in various forms of payment, as described in the Plan document. In addition, the Plan also allows for in-service distributions if a participant reaches age 59½ or under certain hardship circumstances. The Plan also provides for automatic cash-out and/or rollover distributions into an individual retirement account for terminated participants whose balance does not exceed certain limits as prescribed by the Plan document and IRC.

Forfeited Accounts

Forfeitures of nonvested employer contributions are used to reduce the Company's future contributions or to pay plan expenses. Forfeited nonvested accounts totaled \$141,936 and \$65,822 at December 31, 2024 and 2023, respectively. Company matching contributions were reduced by \$128,134 from forfeited nonvested accounts during the year ended December 31, 2024. The Company also used forfeitures totaling \$273 to pay Plan expenses for the year ended December 31, 2024.

Revenue Sharing

The Plan holds assets in a plan expense account which receives deposits as a result of a revenue sharing arrangement with Fidelity. During 2024, deposits to the account totaled \$35,459, which are included in other income on the statement of changes in net assets available for benefits. Funds in the account are reallocated back to plan participants or used to pay qualified plan expenses. For the year ended December 31, 2024, \$17,857 of revenue sharing credit were used to pay plan expenses. The balance in the revenue sharing account totaled \$85,413 and \$63,928 as of December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other income represents income received from revenue sharing arrangements with Fidelity.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivables from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits to participants are recorded when paid.

Administrative Expenses

Except for certain professional fees paid by the Plan, the majority of expenses related to maintaining the Plan are paid directly by the Company. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options in money market funds, shares of registered investment companies and common collective trusts. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Information presented in the accompanying statements and supplemental schedule of assets (held at end of year) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, for investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE OF INVESTMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market Funds: A money market fund is a public investment vehicle valued using \$1 for the Net Asset Value (NAV).

Shares of Registered Investment Companies: These investments are valued at the NAV of shares held by the registered investment companies at year-end. The investments are measured at fair value using quoted prices for identical assets, which are readily available Level 1 inputs.

Fixed Return Investment: This fixed income investment is valued at contract value with represents fair value. Fair value represents interest, less withdrawals and less funds used to pay administrative expenses. This fund was a grand-fathered investment related to participants transferred from another affiliate and is frozen to contributions, exchanges-in, rebalance and investment elections and was fully liquidated during 2024.

Common Collective Trusts: These investments are composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Investments in common collective trusts provide for daily liquidity and have no participant level restrictions. As discussed above, if the Plan initiates a full redemption of the funds, the issuer reserves the right to require a 12-month notice.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments money market funds, shares of registered investment companies and units of a common and collective trust managed by affiliates of Fidelity. Fidelity is a trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Other parties-in-interest include recordkeepers and professional service firms who provide services to the Plan. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

NOTE 6 PLAN TAX STATUS

The Plan has adopted a preapproved plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.
