### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rod N Reel, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rod N Reel, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1: Description of Plan**

The following description of Rod N Reel, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Rod N Reel, Inc. and Chesapeake Amusements, Inc. (collectively, the Employer), except union employees and residents of Puerto Rico. The Plan originally became effective April 1, 1998 and was restated and amended on July 14, 2023. The Plan is subject to the provisions of ERISA. Plan management is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility**

Effective July 14, 2023 eligible employees of the Employer who have reached age 18 years and have completed two months of continuous service are eligible to participate in the Plan and receive safe harbor matching contributions. The participant can enter the Plan on the Plan entry date which is the earlier of the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date the employee meets the eligibility requirements.

**Contributions**

Each year, participants may contribute pre-tax or after-tax (Roth) annual compensation up to the maximum allowable by the Internal Revenue Service Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan is a safe harbor plan and the Employer makes safe harbor matching contributions to all eligible participants up to 5% of compensation. The first 3% of elective deferrals are matched 100% by the Employer. Any amount of elective deferral over 3%, up to 5%, is matched 50% by the Employer. For the year ended December 31, 2024, the Employer safe harbor match totaled \$115,480.

The Employer may, in its sole discretion, make matching contributions in addition to those described above based on the first 6% of compensation deferred not to exceed 4% of compensation. All participants share in allocations regardless of service completed during the Plan year or employment status at the end of the year.

The Employer may also, in its sole discretion, make a profit sharing contribution. Such contribution, if made, will be allocated in the manner described in the Plan Agreement in the ratio that each participant's compensation bears to the compensation of all eligible participants. Participants must complete at least 1,000 hours of service during the Plan year and be employed by the Employer on the last day of the Plan year in order to receive a profit sharing contribution.

**Note 1: Description of Plan (Continued)**

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and allocations of: (a) the Employer's safe harbor, discretionary and profit sharing contributions, if any, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Expense allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions (including rollovers), as well as Employer's safe harbor matching contributions plus actual earnings thereon. Vesting in the Employer's discretionary and profit sharing contributions is based on years of continuous service. A participant is 100% vested after four years of credited service. Regardless of the vesting schedule, participants become fully vested upon death.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan at a time is permitted. Loan terms range up to five years unless the proceeds are used for the purchase of a primary residence, in which case the payment term may be extended. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator. Interest rates at December 31, 2024 for Plan notes receivable from participants are between 8.75% and 9.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Payments from the Plan will be allowed upon retirement, death, upon attaining age 59 ½, employment termination or hardship. Normal distributions from the Plan may be paid out in a lump sum or installment payment.

**Forfeitures**

Periodically, the Plan will have forfeited, non-vested funds by terminated employees. Monies from forfeitures are used to reduce the Employer contribution. At December 31, 2024 and 2023, the balance in the forfeited nonvested account was \$-0-.

**Hardship Withdrawals**

Hardship withdrawals are permitted in accordance with the Plan Agreement.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Note 2: Summary of Significant Accounting Policies (Continued)**

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions**

Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for direct investments in fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to the administration of the Plan are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Date of Management's Review**

The Plan has evaluated events and transactions that occurred during the period from the date of the financial statements through October 15, 2025, the date the Plan's financial statements were available to be issued. There were no events or transactions that occurred during the period that materially impacted the amounts or disclosures in the Plan's financial statements.

**Note 3: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer discretionary contributions.

**Note 4: Tax Status**

The Plan is a qualified non-standardized pre-approved profit sharing plan under the Internal Revenue Code (IRC), as per the opinion letter dated November 14, 2022. The Plan has since been amended, however the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The previous three tax years remain subject to examination by the IRS.

**Note 5: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6: Related Party Transactions and Party-in-Interest Transactions**

The Plan's investment in the fixed account is managed by Empower Annuity Insurance Company of America (for the period July 14, 2023 through December 31, 2024). American Trust Company, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America are the custodian, trustee, and the insurance issuer, respectively, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investment, as they are paid through revenue sharing rather than a direct payment. During the year ended December 31, 2024, the Plan made direct payments for certain administrative expenses of \$21,925.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 7: Information Prepared and Certified by the Plan’s Custodian, Trustee and Insurance Issuer**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by American Trust Company (for the period January 1, 2023 through July 13, 2023) and Empower Trust Company, LLC and Empower Annuity Insurance Company of America (for the period July 14, 2023 through December 31, 2024), the custodian, trustee, and insurance issuer, respectively, of the Plan, except for comparing such information certified by the custodians and insurance issuer to information included in the Plan’s financial statements as of December 31, 2024 and 2023, and the supplemental schedule of assets held for investment purposes as of December 31, 2024.

The trustee and insurance issuer also certified to the completeness and accuracy of \$322,258 of net appreciation (depreciation) in fair value of investments, \$4,592 of interest on notes receivable from participants and \$235,719 of interest and dividend income related to the aforementioned investments for the year ended December 31, 2024.

**Note 8: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 9: Guaranteed Investment Contract with Insurance Company**

The Plan has a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer and there is no minimum rate. The crediting interest rate is reviewed on a quarterly basis for resetting.

This contract meets the direct fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan's documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan's sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.
