**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the DHL Global Mail 401(k) Plan (the Plan) provides only general information of plan provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was originally adopted March 1, 2002 by DHL Global Mail, Inc. (the Company). Effective January 1, 2012, the Plan was amended to change the Plan sponsor from DHL Global Mail, Inc., to DPWN Holdings (USA), Inc. as well as to change various plan provisions. The Plan is a defined contribution plan covering substantially all employees of the Company. Employees are eligible to participate in the Plan upon hiring. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants in the Plan may elect to defer up to 80% of their pre-tax and after-tax pay each pay period, with a combined maximum limit of 80% for investment in the Plan. Participants may elect to designate that a portion or all of their pre-tax contributions be treated as Roth after-tax contributions. Unless an active employee elects otherwise within 30 days of hire, they are automatically enrolled and deemed to have elected to make a pre-tax contribution of 3% of eligible compensation. The percentage will automatically increase by 1% annually up to 10% unless an active participant elects otherwise. Participants who reach age 50 during the calendar year and are making the maximum Internal Revenue Service pre-tax contribution may make additional pre-tax "catch-up" contributions in accordance with the provisions of Code Section 414(v). Participants may contribute amounts representing distributions from other qualified plans.

The Company makes safe harbor matching contributions to the account of each eligible employee equal to 100% of participant contributions not to exceed 4% of each participant's eligible compensation deferred. The match is funded to the Plan on a quarterly basis. The Company also makes an annual base contribution of 2% of each participant's eligible compensation on an annual basis. The participants must be eligible for the Plan and be active in employment status or have a termination date of December 31 to receive the annual base contribution.

Additional profit-sharing amounts may be contributed on an annual basis at the option of the Company and allocated as determined by the Company. The participant must be eligible for the Plan, completed service requirements as defined by the Plan document, and be in active status or have a termination date of the last day of the calendar year. For the year ended December 31, 2024, there were no profit-sharing contributions made. All contributions are subject to certain Internal Revenue Code (IRC) limitations.

Investment Options: Upon enrollment in the Plan, a participant may direct their contributions plus actual earnings thereon to be invested in any of the investment options offered by the Plan. Participants may change their investment options daily.

Participant Accounts: Each participant's account is credited with their voluntary contributions and allocations of the Company contributions and Plan earnings (losses) and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances or amount as stated in fee schedules, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. Participants are 100% vested in safe harbor Company match contributions and annual base contributions after 2 years of service. Employer non-discretionary contributions, employer discretionary matching contributions and profit-sharing contributions are 100% vested upon Participants reaching 2 years of service, provided the Participant had at least one hour of service on or after January 1, 2012. A Participant who has accrued one year of service as of January 1, 2012 shall remain 33% vested until such Participant has accrued two years of service, at which time the Participant shall become 100% vested.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability. Normal retirement age is 65.

Notes Receivable from Participants: The Plan provides that participants can borrow from their accounts in the Plan. These notes are secured by the balance in the participant's account. These notes must be at least \$1,000 but are limited to the lesser of \$50,000 or 50% of the participant's vested account balance. Note issuances are treated as a transfer between a participant's investment fund(s) and the notes receivable in a participant's account. Note principal and interest payments are made in accordance with the note's amortization schedule and are made via payroll withholding or direct payments to the Plan trustee. Notes must be paid back within a five-year time period according to IRS Regulations. Interest rates on the notes are determined by the Company's Employee Benefits Committee.

Payment of Benefits: On terminations of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account. Retired or terminated participants age 59 ½ may elect to receive installment payments annually, quarterly, or monthly, in either a fixed dollar amount or as a specified number of payments. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Forfeited Accounts: Forfeitures relating to the non-vested portion of a terminated participant's employer contributions are retained by the Plan and used first to pay administrative expenses and then to reduce future Company contributions. As of December 31, 2024 and 2023, the Plan had \$91,256 and \$546,547, respectively, of forfeited non-vested funds available to reduce future Company contributions to the Plan and to pay administrative expenses. For the plan year ended December 31, 2024, approximately \$1,250,000 of forfeited amounts were used to reduce Company contributions. As of December 31, 2024 and 2023, the employer contributions receivable is reported net of \$0 and \$300,000, respectively, in forfeitures used subsequent to year end. During 2024, \$987 of forfeited amounts were used to offset Plan administrative expenses.

Administrative and Investment Management Expenses: Plan record keeping and trustee fees that remain after allocation to participant accounts are paid for by the Plan. These fees, both those paid for by the participant and the Plan, are reflected in the financial statements as administrative expenses of the Plan. QDRO fees charged by the record keeper are paid by the participant. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accounting principles and procedures followed by the Plan conform to accounting principles generally accepted in the United States of America. The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks pertaining to global events. Due to the level of risk associated with certain investment and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received, and the notes are collateralized by the participants' account balances.

Payment of Benefits: Plan benefits are recorded when paid.

## **NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

## **NOTE 4 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLES FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

## NOTE 5 - FAIR VALUE MEASUREMENT

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective trusts:* The fair values of participation units held in collective trusts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated April 5, 2018 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the determination letter, the plan sponsor believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are mutual funds managed by Fidelity Investments, an affiliate of the trustee of the Plan, and a collective trust managed by Fidelity Management Trust Company, the trustee of the Plan. These investments qualify as party-in-interest investments. Notes receivable from participants also reflect party-in-interest transactions.

Fidelity is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Fidelity qualify as party-in-interest transactions. Certain professional fees related to the administration of the Plan were paid by the Company on behalf of the Plan. During 2024, fees paid by the Plan for trustee, record keeping and investment management services amounted to \$556,758 all of which were party-in-interest transactions.

Investment management fees paid to parties-in-interest are reflected as reductions in the investment returns earned by the Plan on its investments and are also considered party-in-interest transactions.
