Note 1 Description of the Plan

The following description of the Eau Claire Cooperative Health Center 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established for the benefit of the employees of Eau Claire Cooperative Health Center (the “Organization” or “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility – Employees of the Organization are eligible immediately, no hours requirement, and does not exclude part time employees, and are age eighteen or older are eligible to participate in the Plan. In order to be eligible for Employer discretionary contributions, employees must complete three months of service. Employer matching contributions are typically made once a year in the spring after plan year-end.

Contributions – Each year, participants may contribute up to 100 percent, of pretax annual compensation, as defined in the Plan subject to the limitations of the Internal Revenue Code. Participants may increase or decrease, on a prospective basis, from salary reductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). In addition, an employee may designate all or a portion of their contribution as a Roth contribution. Participants direct the investment of their and employer contributions into various investment options offered by the plan and can change investment elections and reallocate account balances via online account access at any time. The Organization’s matching contribution is a discretionary percentage that is declared annually. In 2024, the Organization contributed the lesser of the participant’s pre-tax deferral amount or \$2,000 per participant, for a total of \$343,014.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Organization’s contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Administrative expenses of the Plan may be paid by the Organization at its discretion. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Participant Promissory Notes Receivable – Participants may borrow from their individual accounts. The loans are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – A participant may make a hardship withdrawal as allowed by the Plan Document subject to a \$500 minimum of participants deferred contributions only. Participants are entitled to receive a distribution of all or any portion of their vested account balance upon attainment of age 59½. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial payout of the account balance.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$23,455 respectively. Forfeitures used to reduce employer contributions totaled approximately \$20,775 and \$0 during the periods ended December 31, 2024 and December 31, 2023, respectively.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates – The financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and use assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Fair Value Measurement Footnote for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant

transactions (promissory notes receivable from participants and distributions) are charged directly to the participant’s account.

Subsequent Events – The plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3 Fair Value Measurements – FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include</p> <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant Loans: Promissory Notes from Participants (Participant Loans) are valued at amortized cost, which approximates fair value.

Note 4 Information Certified by the Trustee (Unaudited) – Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held December 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company (the trustee of the Plan). All amounts shown in the financial statements, except for amounts shown for employer and employee contributions receivable and employer and employee contributions, was summarized from information supplied and certified as complete and accurate by the trustee. The information obtained from the trustee was not audited by independent certified public accountants, except for comparing such information to the related information included in the financial statements and supplemental schedule, as permitted as permitted by Title 29 U.S. *Code of Federal Regulations* (CFR) Part 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 5 Related-Party Transactions and Party In Interest Transactions – Certain Plan investments are shares of mutual funds managed by Nationwide Trust Company. Nationwide Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations. Administrative fees amounted to \$12,537 and \$50,044 for the years ended December 31, 2024 and 2023, respectively.

Note 6 Tax Status – The Plan has adopted a Nationwide Volume Submitter Plan. The Plan has received an Internal Revenue Service advisory letter indicating that the plan is qualified under Code section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 Risks and Uncertainties – The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 Plan Termination – Although it has not expressed any intent to do so, the Eau Claire Cooperative Health has the right under the Plan Adoption Agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act. In the event of plan termination, participants would become 100 percent vested in their accounts.


