1. Description of the Plan

The following description of the Thielsch Engineering Inc. 401(k) Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was originally established by Thielsch Engineering Inc., a wholly-owned subsidiary of RISE Group, Inc., on January 1, 1990. The purpose of the Plan is to accumulate retirement income for its employees, which will supplement retirement benefits provided to them by Social Security. The Plan is a contributory single-employer defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

RISE Group, Inc. (the Company or Employer) is the Plan Administrator. As Plan Administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Vanguard Fiduciary Trust Company (Vanguard) was the directed trustee of the Plan and acted at the direction of the Plan Administrator through December 31, 2024. Vanguard was acquired by Ascensus, LLC during the Plan year ended December 31, 2024.

The Plan was amended and restated effective January 1, 2025, to become the Rise Group, Inc. 401(k) Plan and to amend certain minor plan provisions. In conjunction with the amended and restated plan, Ascensus Trust Company became the new trustee of the Plan, effective January 1, 2025.

Eligibility

Employees of the Company, including its wholly-owned subsidiaries, other than temporary employees, nonresident aliens, and employees covered by a collective bargaining agreement, are eligible to participate in the Plan effective as of the first day of the month coincident with or subsequent to their date of hire. Prior to January 1, 2024, employees also had to be a minimum of 21 years of age. Effective January 1, 2024, the Plan was amended to reduce the minimum age required to participate to 18 years of age. An employee may elect to waive participation in the Plan.

Contributions

Participants may elect to contribute to the Plan any percentage of eligible compensation, as defined in the Plan. Participants who are at least age 50 before the end of the Plan year may make catch-up contributions equal to any whole dollar amount. The Plan has an automatic enrollment feature under which eligible employees will be enrolled in the plan at 2% on the first day of the month following date of hire, unless they affirmatively elect otherwise. The Plan also has an automatic escalation policy, in which participants' deferral rates increase annually by 1%, not to exceed 6%, unless they affirmatively elect otherwise. Participants may not contribute more than the maximum allowed by the IRC.

Company contributions are discretionary and determined by management prior to the commencement of each Plan year. For the year ended December 31, 2024, Company matching contributions were 50% of the participants' contributions, up to a maximum of 6% of each participant's eligible compensation. Participants are immediately eligible to receive matching contributions.

Rollovers and transfers of funds from other qualified plans in which employees cease to participate are permitted, subject to approval, and are fully vested.

The Company allows participants in the Thielsch Engineering, Inc. Employee Stock Ownership Plan (ESOP) who have attained 55 years of age and 10 years of service to diversify up to 25% of their outstanding shares in the ESOP for cash to be transferred into the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contribution, (b) Plan earnings (losses) and (c) administrative expenses. Plan earnings (losses) and administrative expenses are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions to the Plan and earnings thereon. Participants are vested in Company matching contributions and the related allocated gains and losses as follows:

<u>Number of years of service</u>	<u>Vested percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

A year of vesting service is equal to at least 1,000 hours of service in a plan year. An employee who incurs a break in service of less than five years and returns to employment retains credit for his pre-break years of service subject to certain rules.

Participant Notes Receivable

The Plan provides that participants may request a loan from the vested portion of the participant's account for any purpose. The amount of the loan which may be received cannot exceed the lesser of 50% of the participant's vested interest or \$50,000.

Loans are secured by the vested balance in a participant's account and bear interest at the prevailing prime rate plus one percent. Principal and interest are paid in level payments on at least a quarterly basis, and must be completed within five years, with the exception of loans whose proceeds are used for the purchase of a participant's primary residence, which must be repaid over a reasonable period of time, as determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. Participants may have two loans outstanding at any time.

In-service Withdrawals

Participants who have attained aged 59 ½ may elect to receive an in-service distribution of all or any portion of their deferral contributions account. Participants are required to take distributions upon the earlier of the attainment of age 72 or retirement.

Hardship Withdrawals

A hardship withdrawal may be authorized by the Company in an amount up to 100% of the participant's elective deferral contributions, including earnings thereon.

Payment of Benefits

On termination of service due to normal retirement, death or disability, participants may receive a lump-sum payment equal to 100% of the amounts credited to their accounts. On termination of service for other reasons, participants may receive the value of the vested interest in their account as a lump-sum distribution. If the vested value of a terminated participant's account does not exceed \$5,000, the vested value of the participant's account may be paid by the Plan without the participant's authorization.

Forfeitures

Forfeitures incurred during the Plan year ended December 31, 2024 were \$90,659. Forfeitures of non-vested Company contributions are used to reduce administrative expenses under the Plan, if any, then to reduce Company contributions if elected. For the year ended December 31, 2024, \$94,957 in forfeitures were utilized to reduce administrative expenses. Unused forfeitures totaled \$76,156 and \$75,161 at December 31, 2024 and 2023, respectively, and are invested in the Vanguard Cash Reserve Federal Money Market Fund. Dividend income received on unused forfeitures invested totaled \$5,293.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies using information provided by investment advisors and the trustee.

The investment in the common/collective trust is valued at the net asset value (NAV) per unit, as determined by Vanguard, the trustee of the Plan, at year-end. The NAV is used as the practical expedient to estimate fair value and is based on the fair value of the underlying investment held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Contributions

Participant and Company matching contributions are recorded biweekly when the Company remits the payroll deductions for investment into the Plan.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

The Company pays certain professional fees and other expenses related to the Plan; therefore, such expenses are not included in the accompanying financial statements. Fees related to the administration of loans and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses charged directly to participants (revenue-sharing) are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in one mutual fund that accounted for approximately 12% and 10% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements with the trustee. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

Money Market Fund: Valued at the daily closing prices as reported by the fund, which is required to publish its NAV and transact at that price.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Fund: The Plan invests in the Vanguard Retirement Savings Trust III at December 31, 2024 and 2023, a stable value fund structured as tax-exempt collective trust. These investment vehicles invest in benefit-responsive investment contracts issued by insurance companies, banks, or other financial institutions, including investment contracts backed by fixed income securities. They are valued at the NAV of units held by the Plan. The NAV, as provided by Vanguard, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan level.

The Plan has adopted the Vanguard Defined Contribution Pre-Approved Basic Plan Document #01 (the Prototype Plan). The Prototype Plan has received from the Internal Revenue Service (IRS) an opinion letter, dated June 30, 2020, indicating that the Prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Summary of Financial Data Certified by the Trustee

6. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are the result of different classifications between line items. Total Plan assets are in agreement.

7. Related Party Transactions and Party-in Interest Transactions

Plan investments are held and managed by Vanguard, the trustee; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue-sharing, rather than a direct payment. The Plan made direct payments to Vanguard for administrative fees totaling \$94,360 for the year ended December 31, 2024. The Plan also made direct payments to its independent advisor of \$62,531 for the year ended December 31, 2024.

Participant notes receivable also qualify as party-in-interest transactions.

8. Subsequent Event

The Plan was amended and restated effective January 1, 2025, to become the Rise Group, Inc. 401(k) Plan and to amend certain minor plan provisions. In conjunction with the amended and restated plan, Ascensus Trust Company became the new trustee of the Plan, effective January 1, 2025.
