INDEPENDENT AUDITOR'S REPORT

To the Benefits Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Aquinas Companies 401k/Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated October 11, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). 1. DESCRIPTION OF THE PLAN

The following description of Aquinas Companies 401k/Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document and trust agreement for a more complete description of the Plan’s provisions.

General

The Plan was established by Aquinas Companies, LLC (“Company”) to enable eligible employees to save for retirement. The Plan is a qualified retirement plan under the Internal Revenue Code (“IRC”) and has been amended as of July 15, 2024, to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participating employers in the Plan include Alexis Insurance Corporation; Alexis Risk Management Service, LLC; AlphaDev, LLC; Aquinas Management Services, LLC; Edgeworth Construction Products, LLC; Essex Health Properties, LLC; Linbeck Group, LLC; Lucia Constructors, LLC; Lucia Group, LLC; Lucia, LLC; Theater Square GP, LLC; Xavier Structures I, LLC; Xavier Structures, LLC; and ZH Performance Products, LLC.

Administration

The Company is responsible for the administration of the Plan. Fidelity Investments is the recordkeeper of the Plan. Fidelity Management Trust Company is the trustee of the Plan and is responsible for trusteeing the Plan’s assets.

Eligibility

The Plan has no age requirement or service requirement. However, an employee is not eligible if they are a resident of Puerto Rico, covered by a collective bargaining agreement, a leased employee, a nonresident alien, or a non salaried employee. An eligible employee will become a participant on the first day of the month following their employment date.

Contributions

Upon becoming a participant, an employee is automatically enrolled in the Plan at 6% of the employee’s eligible compensation as a pre-tax deferral contribution. The employees may stop or change this automatic contribution by notifying the Company. Participants who are projected to be age 50 or older by the end of the calendar year may also make catch-up contributions to the Plan. Participants are responsible for the investment decisions regarding their contributions and will direct the investment of their entire interest in the Plan.

The Company makes non-discretionary matching contributions in amounts equal to 50% of the participant’s first 6% of pre-tax contributions.

The Company has the option to make annual discretionary profit sharing contributions in an amount to be determined by the Company’s Board of Directors at the Plan’s year end. Profit sharing contributions are allocated in the ratio of the participant’s eligible compensation to total compensation for all eligible participants. In 2024, the Company did not make discretionary contributions.

Participants can also roll over part or all of an eligible distribution they receive from an eligible retirement plan into this Plan as rollover contributions.

Vesting

Participants are 100% vested in their contributions, rollover, and Plan earnings thereon. Employer contributions and Plan earnings thereon vest in accordance with the following schedule:

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, rollovers, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Loans have been pre-approved by the Company and will be allowed for any purpose. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve month period. All loans shall bear a reasonable rate of interest. Repayments are made through payroll deductions and are in level payments over no more than a five year period unless the loan was for the purchase of a principal residence.

Benefits Paid to Participants

Participants are eligible to request a distribution of their vested account balance based on any of the following events: death, disability, retirement, required minimum distribution, or termination of employment. A participant can request a single lump distribution as a direct rollover distribution, a non-rollover distribution, or a combination of direct rollover and non-rollover distribution. If the value of the participant's account balance is less than \$1,000, the payment may be made in a single lump sum without the participant's consent. If the participant's account balance is between \$1,000 and \$7,000, and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant. A participant's consent is required for any distribution if their vested account balance is greater than \$7,000.

The following types of in service withdrawals are available under the Plan: hardship withdrawals, withdrawals after age 59½, and withdrawals of after-tax or rollover contributions.

Forfeitures

If a participant terminates employment with the Company and is less than 100% vested in their employer account, the participant will forfeit the non-vested portion of their employer account. Forfeitures are retained in the Plan and can be used to reduce future employer contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$92,556 and \$75,937, respectively. During 2024, \$61,013 of forfeitures were used to pay administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three level of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Money Market Funds* – Valued at the daily closing price as reported by the fund. The money market funds are open-end mutual funds that are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily NAV and to transact at that price. The money market funds are deemed to be actively traded.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also engages in transactions with participants related to notes receivable, which are party-in-interest transactions with respect to the Plan. These transactions are covered by an exemption from the prohibited transaction provisions of ERISA.

6. TAX STATUS

The Company adopted a pre-approved plan with received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable requirements of the Internal Revenue Code ("IRC").

Although the pre-approved plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a 100% vested interest in their account. The Company will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the trustee.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024, Fidelity 500 Index Fund and Fidelity Growth Company Fund represent 12% and 18%, respectively, of the total net assets available for benefits under the Plan. These investment concentrations may subject the Plan to greater risk due to lack of diversification. Participants are encouraged to review the investment objectives, risks, and expenses associated with each option.
