**Note 1. Plan Description**

The following description of Norwalk/Indianola Ready-Mixed 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General:**

The Plan is a defined contribution plan covering all full-time employees of the Company who have six months of services and are age nineteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Trustees determine the appropriateness of the Plan’s investments and monitors investment performance. To be eligible for the employer profit sharing contributions, the employee must have attained the age of 19 and must complete six months of service. The employee must also be employed on the last day of the Plan year in order to receive any employer contribution made to the Plan on the employees behalf.

**Contributions:**

Each year, participants may contribute a percentage of their eligible annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Employer contributions are made on a discretionary basis based upon an allocation formula the employer has selected. If a discretionary contribution is made to the Plan, the employee will receive a pro-rate portion of the contribution equal to the ratio of the employee's compensation to the compensation of all eligible participants.

**Rollover transfers:**

With the consent of the Plan administrator, the Trustee may receive and invest amounts transferred in from other qualified Plans. Total rollover contributions were \$0 for the years ended December 31, 2024 and 2023.

**Participant accounts:**

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s profit sharing contribution and, (b) Plan earnings, and (c) forfeitures of terminated participant’s non-vested accounts and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1. Plan Description (Continued)**

**Vesting:**

Participants are immediately vested in their contributions plus actual earnings, thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on the years of continuous service. A participant is 100% after six years of credited service. Total amount of forfeitures during the years ended December 31, 2024 and 2023 was \$6,262 and \$36,757, respectively. Total amount available in the forfeitures account to be used to offset future employer contributions was \$7,277 and \$743 at December 31, 2024 and 2023, respectively.

**Payment of benefits:**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

**Note 2. Summary of Significant Accounting Policies**

**Date of Management's Review:**

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment valuation and income recognition:**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Sponsor administration and operating expenses:**

All expenses of maintaining the Plan were paid by the Plan.

**Note 3. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds, common stocks, certain corporate bonds, and U.S. government securities are based on the closing price reported in the active market where the individual securities are traded, when available.

*Level 2 Fair Value Measurements*

The fair value of certain corporate bonds for which quoted market price are not available are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less an appropriate discount. The fair value of the certificates of deposit is based on amortized cost or original cost plus accrued interest.

*Level 3 Fair Value Measurements*

Investments in Level 3 consist of assets that are not actively traded and significant other observable inputs are not available. The Plan currently does not have any Level 3 investments.

**Note 6. Income Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Transactions with Parties-in-Interest**

City State Bank is known to be a party-in-interest during the year ended December 31, 2024 and 2023. During the years ended December 31, 2024 and 2023, \$72,578 and \$74,922, respectively was paid to City State Bank.

**Note 8. Concentrations, Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
