NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the Healthtrax International, Inc. 401(k) & Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan was adopted on January 1, 1994 under Section 401(k) of the Internal Revenue Code (the Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan covering substantially all employees of Healthtrax International, Inc. and subsidiaries and New England Fitness and Wellness (collectively, the Company or Plan Sponsor) who have completed one year of service, as defined by the Plan, and are age 21 or older. Employees become eligible to participate on the first day of the month following the date they meet the eligibility requirements. The plan administrator oversees governance of the Plan. Plan management determines the appropriateness of the Plan's investments, monitors investment performance, and reports to the Company's Board of Directors.

Participant Contributions and Investment Options:

Participants may contribute up to the maximum dollar amount allowed under the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). The Plan includes an automatic enrollment provision that provides for a 4% participant contribution unless the participant elects a different contribution percentage or elects not to participate in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan with various objectives and degrees of financial risk. The Plan currently offers various mutual funds and a money market fund as investment options for participants.

Employer Contributions:

The Company may make a discretionary matching contribution equal to a uniform percentage of the participant's salary deferrals. The Company did not make a discretionary matching contribution for the years ended December 31, 2024 and 2023. The Company may also make a discretionary profit-sharing contribution. This contribution, if made, would be allocated to all employees that are eligible, as defined. The Company did not make a discretionary profit-sharing contribution for the years ended December 31, 2024 and 2023.

Participant Accounts:

Each participant's account is credited with the participant's contributions, allocation of administrative expenses, and an allocation of investment earnings or losses. Company discretionary matching and profit-sharing contributions and any qualified non-elective contributions are credited to participant's accounts annually, if applicable. Allocations of Plan earnings are based on each participant's share of directed investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are fully vested immediately in their contributions plus earnings thereon. Vesting in contributions made by the Company plus earnings thereon is based on years of continuous service, as defined.

To earn a year of service, a participant must be credited with at least 1,000 hours of service, as defined in the Plan document. Participants will receive partial vesting of 25% per year between years one through four and will be 100% vested after four years of service. In addition, participants become fully vested upon attaining the age of 65 while employed, or upon death or disability.

Notes Receivable from Participants:

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance. The terms of notes receivable range up to a maximum of five years, unless the note is used to acquire a principal residence, in which case the repayment period may be longer. The notes are secured by the participant's vested account balance and bear interest at a rate commensurate with current prevailing rates. Repayment must be at least monthly through automatic payroll deduction. Participants may not have more than one outstanding loan at any one point. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Code.

Forfeitures:

Forfeitures typically represent unvested employer contributions and are first used to pay Plan expenses, and then to reduce future Company contributions. At December 31, 2024 and 2023, there were no forfeitures available to reduce future plan expenses or Company contributions. For the years ended December 31, 2024 and 2023, there were no forfeitures used to reduce plan expenses or reduce Company contributions.

Payment of Benefits:

Upon termination of service due to death, disability, retirement or other reason (all as defined), a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of participant's vested interest in his or her account, installments over a period not to extend beyond the life expectancy of the participant or beneficiary, or partial withdrawals of at least \$1,000. A partial withdrawal is required for participants or their beneficiaries who must receive required minimum distributions, as defined by the Code. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan additionally allows for in-service withdrawals for participants 55 years of age from their fully vested employer contributions. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or due to hardship, as defined by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates:

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of the income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as deemed distributions in accordance with the provisions of the Plan. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Administrative services and other normal expenses incurred in connection with administering the Plan have been charged to the Plan. The Company provides certain accounting and administrative services to the Plan at no charge, which are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

Management has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

NOTE 3 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, net appreciation in fair value of investments, interest income on notes receivable from participants and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the custodian of the Plan.

NOTE 5 – FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. Authoritative guidance establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The following summarizes the fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient, if any, are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore Level 1.

**Money Market Fund:** Valued based on the closing market value of the shares held by the Plan. The money market fund held by the Plan is deemed to be actively traded and therefore Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are all classified as Level 1 as of December 31, 2024 and 2023 and totaled \$8,649,155 and \$8,085,030, respectively.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3, respectively.

NOTES TO FINANCIAL STATEMENTS

NOTE 6 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

As of December 31, 2024 and 2023, certain investments in Charles Schwab are shares of mutual funds managed by Matrix Trust Company, the Plan's custodian and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

Matrix Trust Company provides services to the Plan as the custodian; therefore, these investments and transactions qualify as exempt party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 8 – TAX STATUS:

The Plan is being operated under a regional prototype non-standardized profit-sharing plan and trust agreement, which received an Internal Revenue Service (IRS) opinion letter, most recently amended June 30, 2020, stating that the form of the prototype is acceptable under Section 401(a) of the Code. Although the Plan has been amended since receiving its opinion letter, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500:

The differences between these financial statements and the Form 5500, if any, are immaterial.
