

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the McGinnis Lochridge LLP Savings Plus Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, which covers eligible employees of McGinnis Lochridge LLP (the Sponsor) who have completed three months of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was originally effective January 1, 1986, and was most recently amended March 1, 2022.

Entry Dates: Plan's entry date is the first day of the month coinciding with or following the date an employee satisfies the eligibility requirements. The Plan's entry date for the safe harbor profit sharing contribution or non-safe harbor profit sharing contribution is January 1<sup>st</sup> or July 1<sup>st</sup> coinciding with or following the date the employee satisfies the eligibility requirements.

Contributions: Each year, participants may contribute up to 80% of their annual compensation, as defined in the Plan. A participant's contribution cannot exceed the annual dollar limitation set forth by Internal Revenue Code (IRC) Section 402(g). The Plan also allows for elective deferral contributions to be made as Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who are age 50 or older may also make additional catch-up salary deferral contributions that are in addition to any limits that are imposed by the Plan and federal law. Such contributions are recorded by the Plan in the period in which the Sponsor makes applicable payroll deductions.

Effective May 1, 2024, if a eligible employee was hired on or after May 1, 2024, or if a participant had not submitted a salary deferral election, or has not specifically declined to make salary deferrals, the Sponsor will automatically withhold 5% from their pay and contribute it to the Plan on the participant's behalf in the form of an automatic elective deferral. The election will remain in effect until the participant modifies or terminates the election. Participants may revoke or make modifications to their salary deferral election at any time.

The Sponsor may make a safe harbor profit sharing contribution to the Plan that is equal to 3% of the compensation of each eligible participant for the allocation period. The Sponsor may also use the safe harbor profit sharing contribution to offset the allocation of any non-safe harbor profit sharing contribution that would otherwise be allocated to the participant's account. Eligible employees of the Sponsor who have completed one year of service and have attained the age of 21 are eligible to receive a safe harbor profit sharing contribution or non-safe harbor profit sharing contribution. For 2024, the Sponsor made a non-safe harbor profit-sharing contribution totaling \$1,930,767.

If the Plan is a top-heavy plan according to the definition set forth in the Plan document and the Sponsor makes discretionary contributions, the Sponsor's contributions shall be allocated such that the contributions made on behalf of any participant shall not be less than the lesser of 3% of such participant's compensation or the largest percentage of Sponsor contributions as a percentage of the key employees' compensation, allocated on behalf of any key employee that year. The Plan was top-heavy for 2024 and 2023.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and, (b) Plan earnings and losses, and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants are responsible for their investment decisions under the Plan and any resulting investment activity. The value of participant accounts is updated each business day to reflect any contributions, exchanges between investment options, investment earnings or losses for each investment option and withdrawals.

Vesting: Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of credited service. Participants are immediately 100% vested in safe harbor profit sharing contributions. A participant is 100% vested after three years of credited service for non-safe harbor profit sharing contributions.

Forfeitures: Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates based on current interest rates charged by persons in the business of lending money for similar loans at the time the loan is made. Principal and interest are paid through payroll deductions.

Payment of Benefits: Upon termination of service for any reason, including death, disability, or retirement, a participant may elect to receive vested benefits in one of the following forms; lump-sum payment; life annuity, as purchased from a commercial insurer with the participant's account; or qualified joint and survivor annuity, as purchased from a commercial insurer with the participant's account.

After a participant's termination of employment from the Sponsor, if the vested amount of their account does not exceed \$1,000, their vested account balance will be distributed directly to them in cash. If the vested amount of a participant's account balance is more than \$1,000 but less than \$5,000, their vested account will be distributed from the Plan. A participant may either elect to receive this distribution in cash or to roll over the distribution to an IRA or the qualified plan of their new employer. If the vested amount of a participant's account exceeds \$5,000, they must consent to any distribution of their account.

Participants who reach age 59½ may receive an in-service distribution from certain accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Administrative Expenses and Investment Management Expenses: The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Sponsor. Expenses relating to specific participant transactions (i.e. loan setup, distribution request, etc.) are charged directly against the appropriate participant's account. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Sponsor has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions and earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivables from Participants: Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed Brokerage Account: Accounts primarily consist of mutual funds, common stocks, and exchange traded funds that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs). The account also contains government and agency obligations, municipal and corporate obligations, and limited partnerships that are valued based upon recent bid prices or the average of recent bid and asked prices when available (Level 2 inputs). The brokerage account also includes various savings and money market deposit accounts, which are estimated to approximate the cost basis of the deposit account balance (Level 2 inputs).

Collective Trust – Stable Value Fund: The fair values of participation units held in the stable value collective trust are based on the net asset values per unit as reported by the fund managers. The stable value collective trust provides for daily redemptions by the Plan at reported net asset values per share. However, redemptions by Plan participants to reinvest in options that compete with the stable value fund may be delayed for up to 90 days.

Collective Trusts – Target Date: This category includes target date common collective trusts whose objective is to allow participants to select the fund that best matches their expected retirement date, risk tolerance, personal circumstances, and complete financial situation, while investment managers handle the day-to-day decision-making. The funds are diversified through exposure to a variety of asset classes that may include, but is not limited to, domestic equity, international equity, emerging markets equity, global real estate, commodities, short term bond, intermediate term bond, inflation-protected bond (U.S. TIPS), world bond, and cash equivalents. Investments in this category can be redeemed daily at the current net asset value per share based on the fair value of the underlying assets.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor. Certain Plan investments are managed by Charles Schwab Trust Bank. These transactions qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Sponsor adopted a non-standardized pre-approved profit sharing plan, sponsored by Schwab Retirement Plan Services. The pre-approved plan obtained its latest opinion letter on September 21, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved profit sharing plan, as then designed, was acceptable under section 401 of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
