NOTES TO THE FINANCIAL STATEMENTS

NOTE 1- DESCRIPTION OF PLAN

The following description of the LCO 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of certain Lac Courte Oreilles Tribal entities (the “Tribe”). Employees are immediately enrolled in the Plan after being hired and participate in the discretionary employer’s contribution (profit-sharing) portion of the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Investment Committee oversees governance of the Plan, and was appointed to fulfill the Tribe’s fiduciary duties in regards to Plan investments. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Tribal Governing Board (the “Board”).

Contributions

Each year, Plan participants may contribute up to the maximum amount allowed by the Internal Revenue Service (“IRS”) statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan was amended on January 1, 2023 to allow for employer discretionary nonelective profit sharing contributions. Mandatory employer match contributions are no longer required. Employees who work at least 1,000 hours during the plan year are eligible for these contributions equal to 3% of annual salary. As of December 31, 2024 the Tribe had committed to the Plan \$1,633,745 and contributed these amounts to the Plan in 2025. Nonelective contributions by the Tribe are invested in the same manner as the participants’ contributions. Additional profit-sharing amounts may be contributed at the option of the Lac Courte Oreilles Tribal Council. During the year ended December 31, 2024, the Tribe did not make additional profit-sharing contributions to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Tribe’s nonelective contributions, as well as any allocations of the Tribe’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 2 -SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Continued

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the Board. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement. Deemed distributions resulting from delinquent participant loans totaled \$4,139 for the year ended December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions

Contributions in excess of amounts allowed by the IRS totaling \$55,620 were refunded to the applicable participants during the Plan year ended December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Tribe. Expenses that are paid by the Tribe, are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Level 2 Fair Value Measurements

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

Note 9 – Prohibited Transactions

For certain pay periods in 2019 and 2020 the Tribe did not remit participant contributions to Transamerica Retirement Solutions within the period prescribed by the Department of Labor's regulations. The Tribe will work with Transamerica to identify each instance of late deposit, calculate lost earnings, and make restorative contributions. The Tribe will submit a Voluntary Fiduciary Corrective Program application to the DOL including a narrative explanation, supporting documentation, and proof of correction. Delays in remitting contributions to the Plan were due to administrative errors and constitute prohibited transactions.
